

MEETING OF OCTOBER 23, 1950

COUNCIL CHAMBERS

759th MEETING

The seven hundred fifty ninth regular meeting of the Council was held on the twenty-third day of October, 1950

The meeting was called to order by Mayor Sperr.

Present: Mayor Sperr, Councilmen Mullan, Norbeck and Frady. Attorney Kirkpatrick, Treasurer Dillery, Water Superintendent Hofmann and Recorder Martin. Absent: Councilman Taylor.

The minutes of the seven hundred fifty-eighth regular meeting of the Council, held on the ninth day of October were approved as written.

The minutes of a special meeting of the Council, held on the sixteenth day of October were approved as read.

It appeared that Mr. Sam Lassiter, owner of Lots 1 and 13 Block 2 Leo's First Addition had set the forms for a sidewalk on the north side of his property and was ready to pour concrete, when he was stopped on account of the walk protruding out into the street too far for the width of the street. It was agreeable to Mr. Lassiter to cut down the width of his walk provided the City did the moving of his forms, dug the new ditch for his curb, re-filled the ditch already dug, and widened the street by sixteen feet on the north side. It was moved by Frady and seconded by Norbeck that the acting Manager work out a plan for this improvement which will relieve the city of any expense except the setting back of Mr. Lassiter's curb forms. Motion carried and so ordered.

The Mayor reported that Mr. Threlkeld, 3925 Harvey Ave. had contacted him (Mayor Sperr) on a matter of claim to a refund of his (Threlkeld's) sewer assessment. It was Mr. Threlkeld's contention that he had been charged an assessment for all his property frontage on Harvey Ave. when a part of it was not available to sewer on Harvey Ave. It was shown that the 40th Street manhole was 1.5 feet deep and that a lateral from this manhole to the middle of Harvey Ave. would serve the east half of Mr. Threlkeld's property.

The matter of recommendation of Class A Package Store license for Winzler's Mart at 32nd and Harrison Streets was again considered. It was reported to the Council that there had been no protest against the license. It was moved by Frady and seconded by Mullan that the Council approve the recommendation for a Class A Package Store License at Winzler's Mart. provided the Chief of Police approves the application. Motion carried and so ordered.

The following bids for the purchase of Lots 14-15-16 Blk. 12 Quincy Addn. were opened and read.

Clinton Russell, for Lots 14 and 15 only \$620.00

John W. Klinker, for Lot 15 only 553.00

It was moved by Mullan and seconded by Norbeck that all bids be rejected. Motion carried and was so ordered.

A letter from the Southern Pacific Co. was read and tabled.

Mayor Sperr reported his findings in the matter of mercury vapor Street lighting. It was moved by Frady and seconded by Mullan that the City install 14 of these lamps along Main Street and take over the cost of maintenance, the cost of lighting to be \$4.05 per month per each lamp. Motion carried and so ordered.

It was moved by Norbeck and seconded by Mullan that permit be granted to Western Door and Plywood to lay a 12 inch water pipe line from 32nd and Harvey, south on 32nd Street to Meek Street, west on Meek Street to 31st Street, along 31st Street to Western Door & Plywood Plant, and to authorize the acting Manager to work out all details in connection with this project. Motion carried and so ordered.

The Mayor brought up the matter of rocking the east end of Harvester Drive in order that Bayly Co. could move building materials on to their property. The Council authorized the acting Manager to proceed with the necessary rocking of this street

It was moved by Mullan and seconded by Norbeck that Milwaukie Refrigeration and Heating Co. bill of \$80.84 be allowed, for repair and cleaning of oil stoves. Motion carried and so ordered.

On motion duly made and carried the meeting adjourned.
