

MEETING OF NOVEMBER 22, 1948

COUNCIL CHAMBERS

713th MEETING

The seven hundred thirteenth regular meeting of the Council was held on the twenty-second day of November 1948.

The meeting was called to order by Mayor Sperr.

Present: Mayor Sperr, Councilmen Hamlin, Mortensen, and Frady, Manager Taber, Attorney Kirkpatrick, Councilman-elect Norbeck, and Recorder Martin. Absent: Councilman Nelson.

The minutes of the seven hundred twelvth regular meeting of the Council, held on the eighth day of November 1948, were approved as written.

A letter from R.E. Blackburn, of War Assets Administration, acknowledging receipt of payment for property in Kellogg Park, purchased by the City, and granting right of entry to the City after 12:01 A.M. November 20, 1948, was read.

Manager Taber announced that, to date, Stevens and Koon had handed out 16 sets of plans for the new water tank, to prospective bidders.

Manager Taber read a letter from the State Board of Health, addressed to Stevens and Koon, stating that the plans for the tank had met with their approval and that they would inspect the tank when it was finished.

Manager Taber read a letter from C.E. Leach, Editor of "Dairy Goat Journal", Columbia, Missouri, in which he, Mr. Leach, made an appeal to the Council to permit Paul Hager to keep milch goats on his place at 27th and Washington Streets. It was moved by Hamlin and seconded by Frady that the letter be tabled. Motion carried and so ordered.

Reports of the League of Oregon Cities Convention at Eugene were made by Taber, Sperr, and Councilman-elect Norbeck. The three delegates turned in a combined expense account for the convention of \$45.05. It was moved by Hamlin and seconded by Frady that the bill be paid. Motion carried and so ordered.

It was moved by Hamlin and seconded by Frady that the Attorney be directed to prepare an ordinance providing for a tax on pin ball games, the amount of the tax to be determined later. Motion carried and so ordered.

It was moved by Frady and seconded by Mortensen that the Attorney be directed to prepare an ordinance providing for a tax on a quarterly basis, for punch boards. Motion carried and so ordered.

It was moved by Frady and seconded by Mortensen that the Attorney prepare an ordinance providing for a tax on juke boxes and other coin operated machines. Motion carried and so ordered.

It was moved by Mortensen and seconded by Hamlin that the Attorney prepare a taxicab franchise ordinance. Motion carried and so ordered.

It was moved by Frady and seconded by Mortensen that the Treasurer's financial report be accepted as presented. Motion carried and so ordered.

On motion duly made and carried the meeting adjourned.
