

TOWN HALL, MILWAUKIE, OREGON, OCTOBER 19th. 1922.

An adjourned meeting of the two hundred forty-seventh regular meeting of the Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen, Shindler, Miller, Hart and Counsell, Recorder Mathews, Treasurer Streib and Marshal Keck. Upon motion duly made and carried, ordinance No. 185 was taken up for the first. The ordinance being read the roll-call showed the following result: Ayes, Shindler, Miller, Hart and Counsell. Nays, none. Ordinance No. 185 passed the first reading. Upon motion duly made and carried, the rules were suspended and Ordinance No. 185 was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes, Shindler, Miller, Hart and Counsell. Nays, none. Ordinance No. 185 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 185 was taken up for the third and final reading and read by title only. The roll-call showed the following result: Ayes, Shindler, Miller, Hart and Counsell. Nays, none. Ordinance No. 185 passed. The Report of the City Engineer on the proposed extension of 27th Street was read and upon motion duly made and carried, the report was laid on the table temporarily. The recorder was instructed to notify The Pacific Telephone and Telegraph Company that unless it immediately removed the pole and anchor arm from in front of Henry Streib's property, that the Council would take the necessary steps to remove the same.

Mr. Walker was present and informed the Council that he would not be willing to give the land for a street through his property unless the Council would pay the cost of improving the same. Mr. Henneman, representing Mr. Schamer, also advised the Council that Mr. Schamer was not willing give the land for a street across his property unless the Council would pay for the improvement of the same. Upon motion duly made and carried, the Recorder was instructed to advertise for bids for the improvement of Myrtle Street in the Daily-Record Abstract for a period of five days, said bids to be opened on the 31st day of October, 1922. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:

An adjourned meeting of the two hundred forty-seventh regular meeting of the Council of the Town of Milwaukie was held on the 31st day of October, 1922. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen, Shindler, Hart and Counsell, Recorder Mathews and Marshal Keck. Upon motion duly made and carried, the proposals for the improvement of Myrtle Street were opened and read. The Bids were as follows:

W. H. Counsell.....	\$1949.36.
A. Wolf & Co.....	\$2000.00.
C. P. Archer.....	\$2196.10.

W. H. Counsell being the lowest bidder, upon motion duly made and carried, he was award the contract for the improvement of Myrtle Street, and the Recorder and Mayor were authorized to enter into a contract with on behalf of the Town of Milwaukie, with Mr. Counsell for the improvement of Myrtle Street. A petition requesting the Council to install an arc light at the intersection of the second street north of Harrison on 32nd Street was read, and upon motion duly made and carried, the Recorder was instructed to notify the P. R. L. & P. Co. to install the light as petitioned for. The Recorder was instructed to notify the P. R. L. & P. Co. that the light on 27th and Washington Streets had been out since the 24th day of October, 1922, and also to advise the P. R. L. & P. Co. that its lighting service was unsatisfactory.

A petition of owners of real property abutting upon 31st. Street for the improvement thereof was read, and the Council deeming it expedient that the said Street be improvement as petition for, upon motion duly made and carried, the City Engineer was instructed to prepare plans and specifications for the improvement of said Street as petitioned for, and estimates of the work to be done and the probable cost thereof. The following persons were appointed Judges and Clerks of the City Election to be held on the 4th day of December, 1922: Ward No. 1. Judges, A. J. Walker, Anna Adams and W. H. Hoesly: Clerks, Mrs. H. A. Furbank and Mrs. I. E. Jones. Ward No. 2. Judges, Thaddeus Stafford, N. R. Harvey and W. A. Davidson: Clerks, Mrs. Ray Cooper and Mrs. James Ridgon. Sam Borland was appointed Marshal for Ward No. 1 and John Simpson was appointed Marshal for Ward No. 2. Upon motion duly made and carried, the Council adjourned.
