

TOWN HALL, MILWAUKIE, OREGON, JULY 13TH. 1926.

The two hundred ninety-second regular meeting of the Council of the Town of Milwaukie was held on the 13th. day of July, 1926. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Kerr, Grasle, Frey and Hazen, Recorder Mathews and Marshal Keck. The minutes of the two hundred ninety-first regular meeting of the Council held on the 8th. day of June, 1926, and the minutes of the adjourned meeting of the two hundred ninety-first regular meeting of the Council held on the 25th. day of June, 1926, were read and approved as read. Councilman Hazen ~~Hazen~~ of the Light Committee recommended that an arc light be installed at 38th Street and Harvey Avenue. Upon motion duly made and carried, the matter was referred back to the Light Committee to get an estimate of the cost of installing the light. Ordinance No. 245 entitled, An ordinance providing for the construction of sewers along and on 28th. and 27th. Streets and on Lake Road in the Town of Milwaukie, Oregon, and declaring an emergency", was read and ordered posted as required by the City Charter. Mr. Redick was present and advised the Council that he would turn over his water main to the Town provided the Town would not allow any more consumers to connect to the main as to do so might interfere with his water supply. The Council advised Mr Redick to have an agreement prepared satisfactory to himself transferring his water mains to Milwaukie and present the same to the Council for their approval. A petition for the construction of sewers on East Harrison Street, 30th. 31st, 32nd. 34th. 37th. and Llewellyn Streets was read, and upon motion duly made and carried, the City Engineer was instructed to prepare plans and specification for the construction of the same and estimates of the work to be done and the probable cost thereof. A petition for the construction of a sewer on Madison Street was read, and upon motion duly made and carried, the City Engineer was instructed to prepare plans and specifications for the construction of the same, together with estimates of the work to be done and the probable cost thereof. A petition for the improvement of Jefferson Street from Front Street to Main Street was read, and the Council deeming it necessary that said street be improved as petition for, upon motion duly made and carried, the City Engineer was instructed to prepare plans and specifications for the improvement of the same, together with estimates of the work to be done and the probable cost thereof. Upon motion duly made and carried, the matter of considering the objections to the proposed assessment to pay the cost of the improvement of 28th. Street was postponed until the 29th. day of July, 1926, at the request of the objectors' attorney. The following resolution was offered by Councilman Hazen, and upon motion duly made and carried, the resolution was unanimously adopted:

BE IT RESOLVED, the City of Milwaukie on and after the 1st day of September, 1926, will not furnish or deliver Rull Run water to B. F. Glover, either pursuant to the provisions of the writing entered into on May 6th. 1919 between said Glover as party of the first part and Town of Milwaukie as party of the second part, or any subsequent arrangement or agreement, or at all. Upon motion duly made and unanimously adopted the Recorder was directed to notify Mr. Glover of the action taken by the foregoing resolution and to deliver to him a copy thereof. TOWN HALL, MILWAUKIE, OREGON, JULY 29TH. 1926.

An adjourned meeting of the two hundred ninety-second regular meeting of the Council of the Town of Milwaukie was held on the 29th. day of July, 1926. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen, Kerr, Grasle, Frey and Hazen, Recorder Mathews and Marshal Keck. Mr. Clark, attorney for the persons objecting to the proposed assessment to pay the cost of the improvement of 28th. Street, was present and requested the Council to postpone the hearing of the objections to the proposed assessment until the 10th. day of August, 1926. The request of Mr. Clark was granted and upon motion duly made and carried, the matter of hearing and considering the objections to the proposed assessment to pay the cost of the improvement of 28th. Street was continued until the 10th. day of August, 1926.

Mr. Howe was present and advised the Council that the water consumers taking water from Mr. Glover would turn over their water mains to the Town of Milwaukie if the Town would connect their water main to the City water main, and would pay the rates established by the City.

Upon motion duly made and carried, the proposition of Mr. Howie was accepted. Councilman Hazen of the Light Committee reported that she had received an estimate of \$336.60 from the P. E. P. Co. for installing a street lamp at 38th. Street and Harvey Avenue. Upon motion duly made and carried, the petition for installing a street lamp at 38th. Street and Harvey Avenue was placed on the table.

Upon motion duly made and carried, Ordinance No. 245 was taken up for the first reading. The Ordinance being read the roll-called showed the following result; Ayes, Kerr, Grasle, Frey and Hazen. Noes, none. Ordinance No. 245 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 245 was taken up for the second reading and read by title only. The roll-called showed the following result: Ayes, Kerr, Grasle, Frey and Hazen. Noes, None. Ordinance No. 245 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 245 was taken up for the third and final reading and read by title only. The roll-call showed the following result; Ayes, Kerr, Grasle, Frey and Hazen. Noes, None. Ordinance No. 245 passed the third and final reading.

Upon motion duly made and carried, the Recorder was instructed to advertise for bids for the construction of sewers on 27th. and 28th Streets and Lake Road in the Daily Journal of Commerce, said bids to be opened on the 10th day of August, 1926, at the hour of 8:00 o'clock P. M. Upon motion duly made and carried, Peterson & Scott were granted a 30 days extension of time within which to complete the Milwaukie Sanitary Sewer. Upon motion duly made and carried, the 19th day of August, 1926, at the hour of 8:00 o'clock P. M. of said day was the time set for hearing and considering objections to the proposed assessment to pay the cost of the improvement of Lake Road. Upon motion duly made and carried, the Council adjourned.
