Upon motion of councilman Mitchell seconded by councilman King and carried, the Recorder and Engineer were were instructed to make formal application, on behalf of the Council, to the Water-Commission of Portland for Full Run Water for the Town of Milwaukie. Upon motion of councilman Mitchell seconded by councilman Albee and carried, the Recorder was instructed to advertise for bids for the improvement of Monroe Street, the said bids to be opened at the nex regular meeting. Upon motion of councilman Mitchell seconded by councilman King and carried, the Council adjourned until the 28th day of May, 1914.

Ar adjourned meeting of the regular one-hundred-forty-sixth meeting of the Town Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Flmer. Present, Mayor Flmer, councilmen Mitchell, Loeding and Counsell, Recorder Mathews and Marshal Reed. Upon motion of councilman Mitchell seconded by councilman Counsell and carried, the bits for water bonds were opened and read, the bid of the Lumbermens Trust Company, being the best bid was accepted by the Council, and upon motion of gouncilman Mitchell seconded by councilman Loeding and carried, the Lumbermens Trust Co., was awarded \$20,000.00 of Water Ponds of the Town of Milwaukie.

A petition from the Milwaukie Commercial Club requesting Lathe Council to veto the proposed Franchise granting L. H. Campbell the right of way to build railway tracks over the street of be

the Town, was read and ordered placed on file.

The matter of the proposed assessment for the improvement of Front Street was taken up. Mr. Latourette, attorney for Hawley, Pulp & Paper Co, and L. P. Menefee, announced that they had no objections to the proposed assessment, and that the same was satisfactory to them. There being no objections to the assessment for the improvement of Front Street, upon motion of Councilman Mitchell seconded by Loeding and carried, ordinance No. 111, entitled, An ordinance declaring the assessment for the improvement of Front Street in the Town of Milwaukie, Oregon, from the north limits of said Town to the south limits thereof, and declaring an emergency, " was taken up for the first reading. The ordinance being read, the roll-call showed the following result: Ayes, Mitchell, Loeding and Counsell. Nays, none. Absent, councilmen Albee and King. Ordinance No. 111, passed the first reading. Upon motion of councilman Counsell seconded by councilman Loeding and carried, the rules were suspended and ordinance No. 111, was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes, councilmen, Mitchell, Loe ling and Counsell. Nays, none. Absent, councilmen, Abbee and King. Ordinance No. 111 passed the second reading. Upon motion of councilman Loeding seconded by councilman Mitchell and carried, the rules were suspended and ordinance No. 111, was taken up for the third and final reading and read by title only. Mr. Latourette interposed an objection to the assessment of \$1694.19 against the land owned by L. B. Menefee as "Weing upon Tonly one parcel of land, which land is on opposite sides of the Street, and in his opinion - 1 consists of three separate tracts and and should be assessed separately in order to permit the owner to pay the assessment on one or two of the parcel of land and let the other or others be sold or taken for the assessment.

The roll-called showed the following result: Ayes, Mitchell, Counsell and Loeding. Nays, none. Absent councilmen, King and Albee. Ordinance No. 111, passed the third and final reading. Upon motion duly made and carried, the Council Adjourned.
