A communication from O. Wissinger, manager of the Bonnett Estate, informing the Council of the appointment of Henry Smith, assone of the viewers to assess benefits and damages on the proposed widening of Harrison Street was read and ordered placed on file.

The following bills were allowed, and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:

Pacific Coast Stamp Works, 30 firemen badges..... \$34.50 Ordinance No. 93 entitled " An ordinance granting to Chackamas County Gas Company, a corporation, its successors and assigns, for a period of forty (40) years, the right, privilege and franchise to lay, maintain and operate gas mains, pipes and appartenances thereto, in the present and furture streets, alleys and public highways of the Town of Milwa ukie and its successors, for the purpose of supplying gas to the Town of Milwaukie and the inhabitants thereof and others, for light, heat, power and other purposes! was read and ordered posted.

Upon motion duly made and carried the Recorder was instructed to notify the City Engineer to set the grade stake at the intersection of Irving Street with Foster Road, at his earliest convenience.

The Recorder was instructed to notify Mr. Kelsey to make the assessment for the improvement of Foster Road at his earliest convenience. The application of Isaac Gratton for a license to sell liquor in the building known as the Milwaukie Club was read and upon motion of councilman Mitchell seconded by councilman Counsell and carried, Mr. Gratton was granted a license to sell liquor in said building for a period of three months.

Upon motion duly made and carried the meeting adjourned.
