## CITY OF OREGON CITY, OREGON PUBLIC UTILITY(S) EASEMENT

KNOW ALL BY THESE PRESENTS, THAT Providence Health Services - Oregon, hereinafter called "**Grantor**", does hereby grant unto the City of Oregon City, hereinafter called the "**City**", and its successors in interest and assigns, a permanent easement, including the permanent right to construct, reconstruct, operate, and maintain utilities within the easement, described as follows:

See attached **Exhibit A** Legal Description, and

**Exhibit B** Drawing for Legal Description

TO HAVE AND TO HOLD, the above described easement unto the CITY, its successors in interest and assigns forever.

Upon completion of the construction, the CITY shall restore the surface of the property to its original condition and shall indemnify and hold the GRANTOR harmless against all loss, cost, or damage arising out of the exercise of the rights granted herein.

GRANTOR reserves the right to use the surface of the land for walkways, plantings, parking, and related uses. Such uses undertaken by the GRANTOR shall not be inconsistent or interfere with the use of the subject easement area by the CITY. No building or utility shall be placed upon, under, or within the property subject to the foregoing easement during the term thereof, however, without the written permission of the CITY.

The true consideration of this conveyance is for other value given, the receipt of which is hereby acknowledged by GRANTOR.

And the GRANTOR above named hereby covenants to and with the CITY, and CITY's successors in interest and assigns that GRANTOR is lawfully seized in fee simple of the above granted premises, free from all encumbrances (no exceptions), and that GRANTOR and their heirs and personal representatives shall warrant and forever defend the said premises and every part thereof to the CITY, its successors in interest and assigns against the lawful claims and demands of all persons claiming by, through or under the GRANTOR.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.

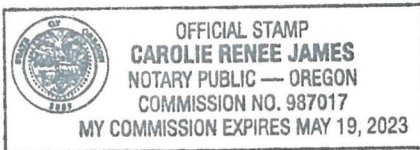

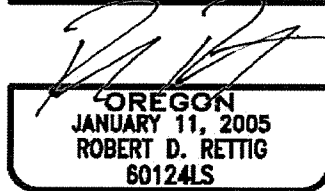
### 15.00 Feet Wide Water Line Easement

Being a tract of land located in the Northeast One-Quarter of Section 32, Township 2 South, Range 2 East, Willamette Meridian, City of Oregon City, Clackamas County, Oregon, and being more particularly described as follows:

COMMENCING at the southwest corner of the Ezra Fisher Donation Land Claim (D.L.C.) No. 44; thence along the west line of said D.L.C. No. 44, North  $01^{\circ}49'03''$  East 1538.75 feet to the southwest corner of that tract conveyed to Doctors Hospital Association, Inc., recorded in Book 534, Page 590 of the Deed records of Clackamas County; thence South  $86^{\circ}08'51''$  East along the southerly line of said Doctors Hospital Tract same being the southerly line of a tract of land conveyed to Providence Health & Services recorded under Document Number 2012-003000 of the Deed Records of Clackamas County, passing at a distance of 620.11 feet to the northwesterly corner of a tract of land conveyed to Providence Health & Services recorded under Document Number 2012-003011 of the Deed Records of Clackamas County, and continuing for a total distance of 735.22 feet to the Point of Beginning of the herein described tract of land; thence leaving said southerly line, North  $42^{\circ}34'42''$  West 47.46 feet to the easterly line of a 15.00 foot wide Utility Easement per Document Number 94-068148, Clackamas County Deed Records; thence along said easterly easement line, North  $53^{\circ}55'38''$  East 15.10 feet; thence leaving said easterly easement line, South  $42^{\circ}34'42''$  East 61.52 feet to the aforementioned Providence Health & Services southerly line; thence along said southerly line, North  $86^{\circ}08'51''$  West 21.76 feet to the Point of Beginning, and containing 817 square feet of land.

The Basis of Bearings is per Survey Number 2004-390 (SN2004-390), Clackamas County Survey Records.

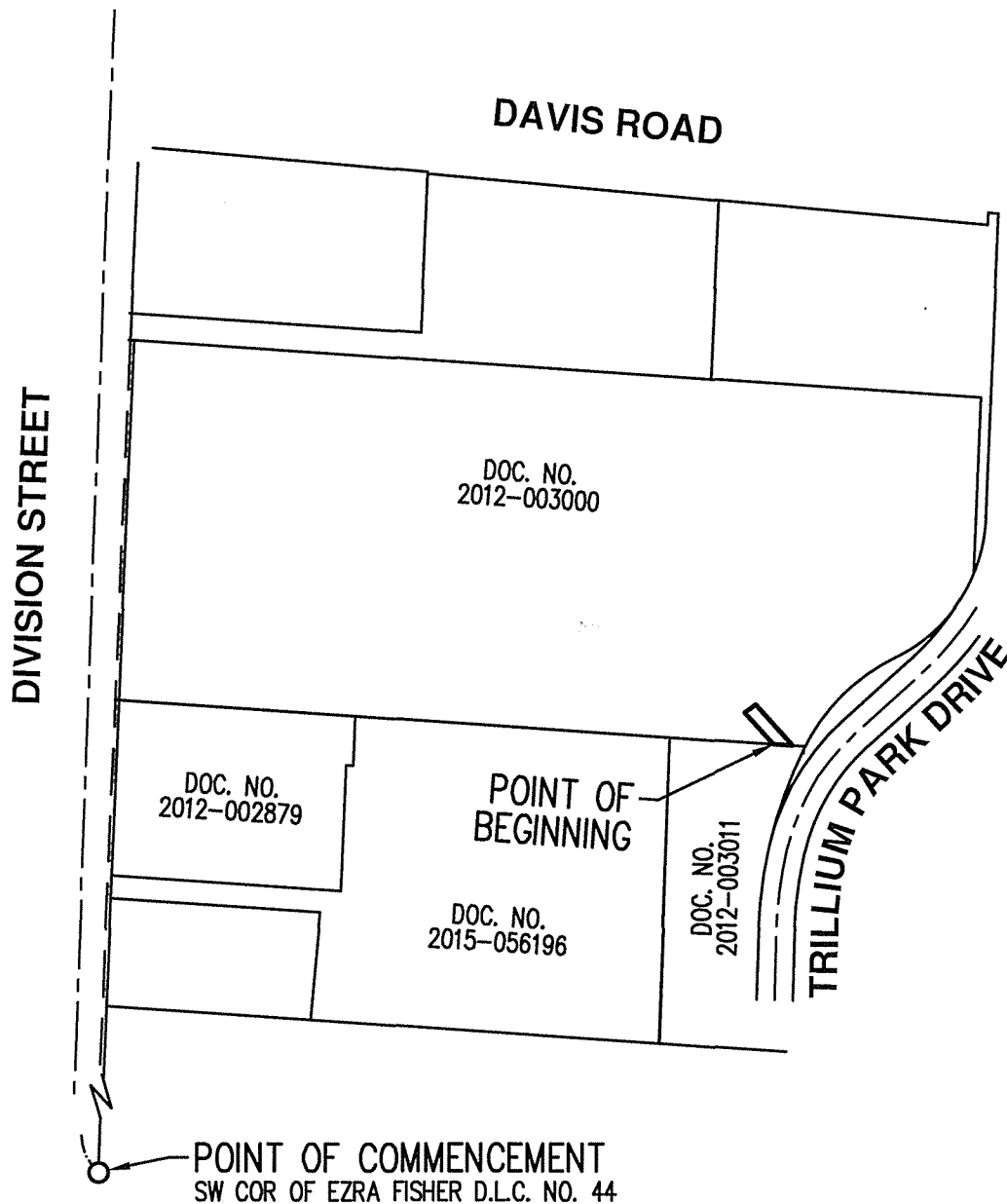
