

TOWN HALL, MILWAUKIE, OREGON, DECEMBER 21st. 1926.

An adjourned meeting of the two hundred ninety-seventh regular meeting of the Council of the Town of Milwaukie was held on the 21st. day of December, 1926. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Ramsey, Kerr, Grasle and Hazen, Recorder Mathews and Marshal Keck. Councilman Hazen stated that she had seen Mr. Phillipssand that he had agreed to audit the city books at the same price that he charged last year. Upon motion duly made and carried, Mr. Phillips was employed to audit the city books for 1926, at the same price he charge last year.

Upon motion duly made and carried, the Council set and fixed the 11th day of January, 1927, at the hour of 7:30 o'clock P. M. of said day, for hearing and considering objections, if any, to the acceptance of the construction of the Milwaukie Sanitary Sewer; Madison Street Sewer; Lake Road extension of the Milwaukie Sanitary Sewer and the 32nd. Street extension of the Milwaukie Sanitary Sewer. Upon motion duly made and carried, the Council adjourned.

TOWN HALL, MILWAUKIE, OREGON, JANUARY 11TH. 1927.

The two hundred ninety-eighth regular meeting of the Council of the Town of Milwaukie was held on the 11th. day of January, 1927.

Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Sanders, Shindler, Earl, Dell and Schrock, Recorder Mathews, Marshal Keck and Treasurer Wiseman. The minutes of the two hundred ninety-seventh regular meeting of the Council held on the 14th. day of December, 1926, and the minutes of the adjourned meeting of the two hundred ninety-seventh regular meeting of the Council held on the 21st day of December, 1926, were read and approved as read.

Mayor Miller in an address to the Council out-lined the policies that he would pursue during his administration, and made a number of recommedations to the Council for the betterment of the Town of Milwaukie.

Mayor Miller appointed the following Committees: Finance, W. J. Dell, Leo Shindler and J. B. Earl. Street and Lighting, Will Sanders, M. S. Schrock and W. J. Dell. Water, J. B. Earl, Will Sanders and M. S. Schrock. Sewers, Leo Shindler, W. J. Dell and Will Sanders. Buildings, Fire and Police, M. S. Schrock, J. B. Earl and Leo Shindler.

The matter of the acceptance of the improvement of Jefferson Street; 23rd Street; 24th. Street and Llewellyn Avenue, was referred to the Street Committee with instructions to report at the next meeting of the Council.

The matter of the acceptance of the Milwaukie Sanitary Sewer; the 32nd. Street extension of the Milwaukie ganitary Sewer; the Lake Road extension of the Milwaukie ganitary Sewer and the Madison Street sewer was referred to the Sewer Committee for investigation with instructions to make its report at the next meeting of the Council. A petition requesting the Council to install an arc lamp at 26th and Washington Streets was read and referred to the light Committee. A petition requesting the Vacation of Second Street between Oak Street and Olive Street in J. R. W Sellwood's Addition to Milwaukie, in the Town of Milwaukie, Oregon, was read, and upon motion duly made and carried it was ordered that Tuesday the 8th. day of March, 1927, at 7:30 o'clock P. M. at the City Hall, be fixed and set as the time and place for hearing and considering said petition. The report of the Treasurer was read and referred to the Finance Committee.

The applications for the position of Water and Street Supt. were read, and upon motion duly made and carried, the applications were referred to Street and Water Committees to select one of the applicants for the position, with instructions to report at the next meeting of the Council. The matter of selecting and preparing an office for the City Treasurer was referred to the Finance Committee with full power to act and purchase such material and supplies as is necessary. Upon motion duly made and carried, Mayor Miller was appointed purchasing agent for the City. Upon motion duly made and carried, Councilman Schrock was elected to preside at the Council meetings in the absence of the Mayor.

The matter of repairing 23rd. Street was referred to the Street Committee with instructions to repair the same at an expense not exceeding \$50.00. The following bills were read and allowed by the Finance Committee, and upon motion duly made and carried, the Recorder was instructed to draw warrants on the several funds in payment of the same:

TOWN HALL, MILWAUKIE, OREGON, JANUARY 18TH. 1927.

An adjourned meeting of the two hundred ninety eighth regular meeting of the Council of the Town of Milwaukie was held on the 18th. day of January, 1927. Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Shindler, Earl, Dell and Schrock, Recorder Mathews and Marshal Keck. Councilman Schrock of the Street Committee reported that the Committee had investigated the improvement of Jefferson Street, 23rd. Street, 24th Street and Llewellyn Avenue, and that the Streets had been improved according to the plans and specifications therefor, and that the Committee would recommend that the improvement of the above Streets be accepted. Upon motion duly made and carried, the improvement of Jefferson Street, 23rd Street, 24th. Street and Llewellyn Avenue was accepted. The proposed assessments to pay the cost of the improvement of the above named streets were read, and upon motion duly made and carried, the 8th. day of February, 1927, at the hour of 7:30 o'clock P. M. was the time and the City Hall the placed fixed and set for hearing objections to the proposed assessments for the improvement of Jefferson Street, 23rd. Street, 24th. Street and Llewellyn Avenue. Councilman Shindler, Chairman of the Sewer Committee, reported that the Committee had inspected the Milwaukie sanitary Sewer, the Lake Road extension of the Milwaukie Sanitary Sewer, the 32nd. Street extension of the Milwaukie Sanitary Sewer and the Madison Street Sewer, and that the Committee would recommend that the Milwaukie ganitary Sewer, The Lake Road extension of the Milwaukie Sanitary Sewer and the Madison Street sewer be accepted, and that the 32nd. Street extension of the Milwaukie Sanitary Sewer be not accepted. Upon motion duly made and carried, the Milwaukie Sanitary Sewer was accepted. Upon motion duly made and carried, the Lake Road extension of the Milwaukie ganitary Sewer was accepted. Upon motion duly made and carried, the Madison Street Sewer was accepted. Upon motion duly made and carried, the acceptance of the 32nd, Street extension of the Milwaukie ganitary Sewer was held up until some future date. Upon motion duly made and carried, the Recorder was instructed to notify Mr. Phillipps to turn over the Treasurer's books to Mr. Streib, as soon as he has completed the audit of the same, and that the Finance Committee see that Mr. Streib turns over the books to the new Treasurer. Councilman Schrock of the Street and Water Committees reported that the Committees had considered all the applications for the position of Water and Street Supt. and that they had selected W. E. Kelso for the position and would recommend that Mr. Kelso be appointed Water and Street Supt. The report of the Water and Street Committees was adopted, and upon motion duly made and carried, W. E. Kelso was appointed to look after the Water Department and the Street Department for the Town of Milwaukie. Mr. Milln was instructed to co-operate with Mr. Felton and inspect the grade of 22nd. Street between Willard Street and Lake Road and ascertain if any changes in the grade could be made that would improve the present grade of the street. The bill of Dr. Ross for medical services performed for Marshal Keck was read and upon motion duly made and carried, the bill was laid on the table until the next regular meeting of the Council. Upon motion duly made and carried, Mayor Miller was instructed to purchase a safe for the City Treasurer at a cost not exceeding \$250.00.

Upon motion duly made and carried, the Council adjourned.
