

TOWN HALL MILWAUKIE, OREGON, September, 4th. 1917.

The one hundred eighty-sixth regular meeting of the Council was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen, Shindler, Grasle, Miller, Seavey and Bates, Recorder Mathews and Marshal Riley. The minutes of the one hundred eighty-fifth regular meeting held on the 7th day of August, 1917, and the minutes of the adjuorned meeting of the one hundred eighty-fifth regular meeting held on the 21st day of August were read and approved as corrected, A communication from the Recorder of Gresham, Oregon, in regard to the water rates which Gresham pays Portland for water was read and ordered placed on file. A communication from the Southern Pacific Company in regard to draining Duersts Addition was read and referred to councilman Bates to take up with the Company. Upon motion of Councilman Miller seconded by councilman Graşle and carried; the Recorder was instructed to prepare an ordinance declaring and levying the assessment for the improvement of 27th. Street, and post a copy of the same as required by the City Charter. Upon motion duly made and carried, the 25th day of September, 1917, at the hour of 8:00 o'clock P. M. was the time, rand the City Hall the place set for hearing objections to the proposed assessment for the improvement of 27th. Street, if any objections there be.

A special meeting of the Town Council washheld on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen Shindler, Grasle, Miller, pates and Seavey.

Mayor Snyder stated that the Meeting was called for the purpose of considering the repair of some of the Streets in the Town. Upon motion of councilman Miller seconded by councilman Grasle and carried, Mr. Counsell was instructed to hard surface approximately 200 feet on the south end of Front Street, said hard surface to 15 feet in width. Upon motion duly made and carried, Street Supt. Mullan was instructed to make the necessary repairs on Harrison Street, Railroad Avenue, Washington Street, Irving Street and Main Street. Upon motion duly made and carried, the Council adjourned.
