David Wilcox, Milwaukie Fire Department, was sworn as a witness, and was questioned by Mr. McDonald and Mr. Walker.


Marvin Lines, Milwaukie Fire Department, was sworn as a witness, and was questioned by Mr. McDonald and Mr. Walker.

Dennis Fleck, Milwaukie Fire Department, was sworn as a witness, and was questioned by Mr. McDonald and Mr. Walker.


(Meeting recessed at 9:20 p. m., reconvened at 9:30 p. m. with all present.)
