The three hundred ninety-seventh regular meeting of the Council was held on 22nd day of April, 1935.

The meeting was called to order by President of the Council Sanders.

Chairman Burdick of the Finance Committee reported that the committee had investigated the cost of setting up the library and found that the same cost \$361.09.

Councilman Burdick also stated that the Finance Committee recommended that the Council adopt the following regulations:

- 1. No bill for purchases to be approved and paid unless purchase made upon requisition.
- 2. No requisition for a purchase greater than \$5.00 to be issued unless the Council authorize the issuance of requisition.
- 3. No purchases to be honored unless they are made by duly authorized agents or employees of the City.

It was moved by Shrock and seconded by Burdick that the regulations be adopted. Motion carried and so ordered.

The matter of reduction of water rates was taken up for consideration. After considerable discussion the matter was put over to the next meeting for further discussion.

No further business coming before the meeting upon motion duly made and carried the meeting was adjourned.

COUNCIL CHAMBERS, MILWAUKIE, OREGON, MAY 13, 1935

The three hundred ninety-eighth regular meeting of the Council of Milwaukie was held on the 13th day of May, 1935.

The meeting was called to order by President of the Council Sanders.  
Present: Councilmen Burdick, Dell, Sanders, Shrock.

- Marshal Riley, Water Superintendent Bevington,
- Fire Chief Lewellyn and Recorder Adams.

The minutes of the three hundred ninety-sixth and three hundred ninety-seventh regular meetings were each read and were each approved as read.

Reports of the Treasurer, Marshal and Fire Chief were read and ordered filed.

A communication from George Bendixen relative to payment of delinquent water bills was read and ordered filed.

The water committee recommended that no water services covering

premises against which there is delinquent water bills be turned on until the bill is paid. It was moved by Burdick and seconded by Shrock that the recommendation be adopted. Motion carried and so ordered.

Councilman Burdick brought up the question of trees overhanging street roadways. It was moved by Burdick and seconded by Shrock that the Marshal notify owners of premises upon which are trees that overhang street roadways, to cut the branches of trees which overhang the street roadways of a distance of 7ft. or less. Motion carried and so ordered.

The question of a septic tank located in the parking in front of the Mahar property on Harrison Street was taken up. It was moved by Burdick and seconded by Shrock that the Marshal notify Mr. Mahar that the use of the septic tank must be discontinued.

Water Superintendent Bevington asked authority to purchase road patching materials and water meter supplies aggregating \$21.50. It was moved by Burdick and seconded by Shrock that authority to make the purchases requested be granted. Motion carried and so ordered.

Fire Chief Lewellyn requested authority to purchase two fire hose coupling parts. It was moved by Burdick and seconded by Shrock that the authority be granted. Motion carried and so ordered.

Water Superintendent Bevington requested authority to sell wheelbarrows. It was moved by Burdick and seconded by Dell that he be authorized to sell all wheelbarrows except 15 at a price to be determined by the hardware merchants of the city acting appraisers. Motion carried and so ordered.

Harvey Hayden of the Stanley Water District asked the Council to set a date when a committee from the proposed Fire Protection District could meet with the Council. The Date was set for May 20, 1935.

The matter of a reduction of water rates for the summer was taken up. It was moved by Dell and seconded by Shrock that the Recorder prepare and post an ordinance reducing for the months of July & August, September & October the water rate on water used over the minimum five cents per hundred cubic feet.

The following bills were read and it was moved by Shrock and seconded by Dell that the same be approved and that the Recorder issue warrants covering the same.
