

TOWN HALL, MILWAUKIE, OREGON, JUNE 6TH. 1922.

The two hundred forty-third regular meeting of the Council of the Town of Milwaukie was held on the 6th. day of June, 1922.

Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen, Miller, Albee, Hart, Shindler and Counsell, Recorder Mathews and Marshal Keck. The minutes of the two hundred forty-second regular meeting of the Council held on the 2nd day of May, 1922, and the minutes of the special meeting of the Council held on the 16th day of May, 1922, were read and approved as read. Councilman Counsell reported that he had purchased the asphalt and repaired Front Street and Lake Road. Upon motion duly made and carried, Ordinance No. 180 was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, Shindler, Albee, Miller, Hart and Counsell. Nays, none. Ordinance No. 180 passed the first reading.

Upon motion duly made and carried, ~~#####~~ the rules were suspended and ordinance No. 180 was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes, Albee, Shindler, Miller, Hart and Counsell. Nays, none. Ordinance No. 180 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 180 was taken up for the third and final reading and read by title only. The roll-call showed the following results: Ayes, Albee, Shindler, Miller, Hart and Counsell. Nays, none. Ordinance No. 180 passed the third and final reading. Upon motion of Councilman Albee duly seconded and carried, the City Marshal was instructed to fix the first Tuesday in each month as the day for dumping garbage and to designate the place where the same may be dumped in Milwaukie, and to post notices to that effect. The following resolution was read and upon motion duly made and carried, was adopted by the Council:

RESOLUTION. 1-1922

Whereas, the Viewers appointed to assess benefits and damages on the proposed extension of Harrison Street have filed their report with the Recorder of Milwaukie, and whereas, the Council of the Town of Milwaukie has adopted said report, Now Therefore BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF MILWAUKIE that the Recorder be and hereby is directed to enter in the Docket of City Liens the respective sums of benefits over damages assessed by said Viewers in said report upon each particular lot or parcel of land, and the names of the owners benefited and assessed, as provided in the City Charter.

Upon motion duly made and carried, the matter of cutting the grass along the parkings and streets was left with the Marshal. Mr. Oatfield of the Oak Lodge Water District was present and advised the Council that upon investigation that he had ascertained that the Milwaukie Water System would be capable of furnishing the Oak Lodge Water District with sufficient water without diminishing the service in Milwaukie. Upon motion duly made and carried, the Water Committee was instructed to get an opinion from J. W. Morris in regard to the matter. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:
