

TOWN HALL, MILWAUKIE, OREGON, SEPT. 6TH. 1921.

The two hundred thirty-fourth regular meeting of the Council of the Town of Milwaukie was held on the 6th. day of Sept. 1921. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Miller, Shindler, Albee, Hart and Counsell, Recorder Mathews and Marshal Keck. The minutes of the two hundred thirty-third regular meeting held on the 4th day of August, 1921, and of the adjourned meeting of the two hundred thirty-third regular meeting of the Council held on the the 17th day of August, 1921, also the minutes of the special meeting of the Council held on the 30th day of August, 1921, were read and approved as read. Mr. Counsell of the Street Committee reported that the bridge on Monroe Street had been repaired and was now safe for traffic. Mayor Snyder stated that he had no report to make on the selection of a Water Supt. Mrs. Eisert was present and asked the Council to install a foot bridge across Kellogg Lake to accomodate the school children from Island Station and Evergreen. The Council took no action in the matter. The objection of Richard Sanblom to the ~~assessment~~ proposed assessment ~~against~~ against his property for the improvement of 32nd. Street was read and the same not being a valid objection was over-ruled by the Council. There being no valid objections to the proposed assessment for the improvement of 32nd. Street, upon motion duly made and carried, Ordinance No. 174 entitled", An ordinance declaring the assessment for the improvement of 32nd. Street, in the Town of Milwaukie, Oregon, from the south line of Elmer Street to the north line of Wister Street, and declaring an emergency", was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, Albee, Shindler, Miller, Hart and Counsell; Nays, none. Ordinance No. 174 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 174 was taken upon for the second reading and read by title only.

Upon motion duly made and carried, the rules were suspended and Ordinance No. 174 was taken up for the third and final reading and read by title only. Upon motion duly made and carried, the Recorder was instructed to draw warrants in favor of W. H. Counsell in the sum of \$2575.62 in payment of the improvement of 32nd. Street. The City Engineer having made a survey, report and plat of the proposed widening and extension of Harrison Street and filed the same with the Recorder, and the said survey, Report and Plat being satisfactory to the Council, upon motion duly made and carried, the Recorder was instructed to prepare an ordinance adopting said survey, report and plat and post the same as required by the City Charter. Upon motion duly made and carried, the Council appointed the following persons as the Budget Committee of the Town of Milwaukie, to-wit: H. N. Hopkins, W. B. perry, Casper Kerr M. J. Walsh and Wm. Shindler. The following bills were read and allowed by the Finance Committee, and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:
