

Town Hall, Milwaukie, Oregon, Jan. 9th. 1918.

The one hundred ninth (190) regular meeting of the Council of the Town of Milwaukie was held on the 9th day of January, 1918. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Shindler, Grasle, Miller, Bates and Seavey, Recorder Mathews, Marshal Riley and Treasurer Streib. The minutes of the one hundred eighty-ninth regular meeting held on the 4th. day of December, 1917, were read and approved as read. The report of the Treasurer was read and ordered placed on file. Upon motion duly made and carried, the Mayor was instructed to accept service on behalf of the Town of Milwaukie of the Notice of application of the P. R. L. & P. Company for increase of rates. Upon motion of Councilman Miller duly seconded and carried, the Recorder was instructed to go to Salem and interview the Public Service

Commission of Oregon in regard to the application of the P. R. L. & P. Company's to raise the car fare between Portland and Milwaukie, and ascertain if the Town of Milwaukie would come under the same ruling as the City of Portland. Upon motion duly made and carried, the lumber in the walk across Kellogg Lake was sold to J. M. Snyder for the sum of \$5.00. A petition asking the Council to prohibit dancing on Sunday was read and ordered placed on file.

Upon motion duly made and carried, the Water Supt. was instructed to take the faucet out of the stand pipe at the Paper and Shingle Mills and install a meter. Upon motion of Councilman Miller duly seconded and carried, the Recorder was instructed to notify the property owners on Front Street whose property is delinquent for the assessment for the improvement of said street that the decision in the case of Hagenburger v. Town of Milwaukie in no way effected the validity of their assessment for the improvement of Front and that the assessment still holds, and unless they pay the assessment in a reasonable time their property will be sold by the Town.

The recorder was instructed to notify C. P. Coldwell General Supt. of the P. R. L. & P. Company that some of the arc lights in Milwaukie have been out of commission for as long as 29 days, and request him to have the same repaired. Moved by councilman Miller that the salary of the Water Superintendent be raised to \$100.00 per month. Motion lost. Upon motion duly made and carried the salary of the Water & Street Commissioner was fixed at \$75.00, per month and the Street Committee was authorized to employ some one at that salary. Upon motion duly made and carried, the salary of C. C. Mullan was raised to \$100.00 per month until some one is secured to take his place.

Town Hall, Milwaukie, Oregon, Jan. 18th. 1918.

A special meeting of the Council was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Shindler, Grasle, Miller, Bates and Seavey, Recorder Mathews and Marshal Riley. Mayor Snyder stated that the meeting was called for the purpose of hearing the report of the Recorder on his interview with the Public Service Commission of Oregon. The Recorder stated that he had gone to Salem and had an interview with the public Service Commission in regard to the application of the P. R. L. & P. Co. to increase its rates, and that the Commission had informed him that the Town of Milwaukie would come under the same ruling as Portland and that Milwaukie would get the same rates as Portland. A communication from Mr. Esterly on behalf of the Montague-O'Rielly Company demanding damages from the Town for the improvement of Front Street was

was read and upon motion duly made and carried, the Mayor and Recorder ~~was~~ instructed to see Mr. Skulason and ascertain what he would charge the Town as fees for defending the Town in case Montague-C'rielly Company would bring action against the Town. Upon motion of councilman Miller seconded by councilman Rates and carried, the office of Water Supt. and Street Commissioner was declared vacant. Moved by councilman Miller that J. W. Hart be employed by the City to look after the Water Department and that he be paid for the actual time he work at the usual rate. Motion lost. Upon motion of Councilman Seavey seconded by Councilman Miller and carried, Samuel Riley was employed as Water Supt. & Street Commissioner, as long as his services were satisfactory, and that his salary be fixed at \$75.00 per month.

Upon motion duly made and carried, the Water Supt. was instructed to repair the hydrant at Island Station and cover the same with a box to prevent freezing. Upon motion duly made and carried, the Water Supt. was instructed to go the water system and install meter where needed and to connect up applicant for water, and to employ such help as is necessary. Upon motion of councilman Rates duly seconded and carried, the salary of the marshal was raised to \$20.00 per month. The following bills were read and allowed by the finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:

Town Hall Milwaukie, Oregon, Feb. 5th. 1918.

The one hundred ninety first regular meeting of the Council was held on the above named date. The Mayor being absent the meeting was called to order by Recorder Mathews. Upon motion duly made and carried, Councilman Miller was elected President of the Council and presided at the meeting. The minutes of the one hundred ninety regular meeting held on the 9th day of January, 1918, and the minutes of the special meeting held on the 18th day of January, 1918, were read and approved as read. A communication from the P. R. L. & P. Co. in regard to repairing arc lights in Milwaukie was read and ordered placed on file. The report of the Finance Committee on the books of the City Recorder and City Treasurer was read and ordered placed on file. The Recorder reported that he had interviewed Mr. Skulason in regard to the amount of fees he would charge the Town in case he ~~was~~ ~~expended~~ ~~for~~ ~~the~~ ~~improvement~~ ~~of~~ ~~Front~~ ~~Street~~ ~~and~~ ~~that~~ ~~he~~ ~~would~~ ~~see~~ ~~the~~ ~~case~~ ~~through~~ ~~for~~ ~~\$500.00.~~ ~~Moved~~ ~~by~~ ~~councilman~~ ~~Shindler~~ ~~and~~ ~~seconded~~ ~~by~~ ~~councilman~~ ~~Rates~~ ~~that~~ ~~the~~ ~~matter~~ ~~go~~ ~~over~~ ~~until~~ ~~the~~ ~~next~~ ~~meeting.~~ Motion carried.

Ordinance No. 159 entitled", An ordinance licensing, taxing and regulating public pool or billiard room or rooms; prohibiting minors from being, or remaining in or about such room or rooms; prohibiting the playing of cards therein at certain times; prohibiting gambling therein; providing the time for closing such pool or billiard room or rooms; repealing ordinances No. 50 and 51; providing a penalty for the violation of the provisions of this ordinance and declaring an ~~emergency~~ emergency", was read and upon motion duly made and ~~carried~~ carried, the recorder was instructed to post a copy of the same as required by the City Charter.
