

TOWN HALL MILWAUKIE, OREGON, APRIL 14TH. 1925.

The two hundred seventy-seventh regular meeting of the Council of the Town of Milwaukie was held on the 14th. day of April, 1925. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen, Kerr, Ramsey, Kelso, Hazen and McIntyre, Recorder Mathews and Marshal Keck. The minutes of the two hundred seventy-sixth regular meeting of the Council held on the 10th. day of March, 1925, and the minutes of the adjourned meetings of the two hundred seventy-sixth regular meeting held on the 16th and 31st days of March, 1925, also the minutes of the special meeting of the Council held on the 28th. day of March, 1925, were read and approved as read. The application of O. F. Witte for a dance hall license was read and upon motion duly made and carried, the application was granted, and the Recorder was instructed to issue a dance hall license to Mr. Witte. The matter of employing an extra officer for Crystal Lake Park was referred to the Police Committee.

Upon motion duly made and carried, the Community Orchestra were granted permission to use a room in the City Hall for practice each monday night, provided they clean the room after using the same. Upon motion duly made and carried, the Street Supt. was instructed to put a sign at each end of the Monroe Street bridge warning all persons driving over said bridge with a load of over two tons that they would do so at their own risk. Moved by Councilman Hazen and duly seconded that the city purchase a Motor-Cycle for the Marshal. Motion lost. Upon motion duly made and carried, the Recorder was instructed to release Lot 5 Karlen's Second Addition to Milwaukie from the lien imposed for the improvement of 29th. Street, upon Mr. Karlen paying its portion of the cost of the improvement, and to release all other lots of Mr. Karlen's in said addition upon the payment of their portion of the cost of the improvement of 29th. Street.

A petition for the improvement of Jackson Street from 40th. Street to 42nd. Street was read, and the Council deeming it expedient and necessary to improve said street as petitioned for, upon motion duly made and carried, the City Engineer was instructed to prepare plans and specifications for said improvement, and estimates of the work to be done and the probable cost thereof.

The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in the several funds in payment of the same:
