The minutes of the two hundred twenty-sixth regular meeting of the Council held on the 12th day of January, 1921, were read and approved as read. The license Committee recommended the pool room license be reduced from \$20.00 per quarter to \$15.00 per quarter for three tables, and that pool rooms be allowed to remain open on Sundays. Upon motion duly made and carried, the recorder was instructed to prepare an ordinance to that effect and post the same as required by the City Charter. The two hundred twenty-eight regular meeting of the Council of the Town of Milwaukie, Oregon, was held on the 9th. day of March, 1921. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Shindler, Albee and Hart, Recorder Mathews and Marshal Reed. The minutes of the two hundred twenty seventh regular meeting of the Council were read and approved as read. Upon motion duly made and carried, Ordinance No. 173, entitled "An ordinance licensing, taxing and regulating public pool or billiard room or rooms; prohibiting minors from being, or remaining in or about such room or rooms; prohibiting the playing of cards therein at certain times; prohibiting gambling therein; providing the time of closing; repealing ordinance No. 159, and providing a penalty for the violation of the provisions of this ordinance", was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, Shindler, Albee and Hart. Nays, None. Ordinance No. 173 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 173 was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes, Shindler, Albee and Hart. Nays, none. Ordinance No. 173 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 173 was taken up for the third and final reading and read by title only. The roll-call showed the following result: Ayes, Shindler, Albee and Hart. Nays, None. Ordinance No. 173 passed the third and final reading. The request of the Wichita Water Company for permission to connect on the Milwaukie Water main North of the pressure reducer was referred to the Water Committee. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:
