3a. Downtown Oregon City Association's Biannual Update

Liz Hannum, Executive Director of the Downtown Oregon City Association, discussed the Memorandum of Understanding requirements that had been completed by June 30, 2020 and the challenges and opportunities for the coming year.

There was discussion regarding private lots for the parking program and amending the agreement based on the fact they could not meet the deliverables due to Covid.

There was consensus that the Commission would not hold DOCA responsible for those deliverables at this time due to Covid.

4. Citizen Comments

Heidi Blackwell, resident of Oregon City, discussed a County Commission meeting where racism was discussed. Oregon City was not portrayed as a place where people of color felt comfortable. She thought the resolution that was passed by the Commission was a good first step and she listed ideas of what the next steps could be.

Heidi Chang, resident of Oregon City, was a decorated combat vet and a mother. She was questioning setting down roots in Oregon City after learning about actions taken by the Mayor. She gave examples of how she thought he had degraded women. It was the duty of the Mayor to set the example of how to treat fellow humankind.

Dara Kramer, resident of Oregon City, spoke about the recall effort and the many people who were volunteering due to the Mayor's treatment of women, citizens, and fellow Commissioners, his stance on racial injustice, and actions that had led to lawsuits and investigations. Other elected officials and former mayors had already signed the petition. She listed ways citizens could sign.

Sarah Head, resident of Oregon City, said Oregon City was recently identified as a place that was especially uninviting to people of color. She gave examples of racism she had seen in the City and stated silence was not an option. She asked the City to reach out to experts and resources that could help with this issue.
