

TOWN HALL, MILWAUKIE, OREGON, SEPT. 22nd. 1925.

A special meeting of the Council of the Town of Milwaukie was held on the 22nd. day of September, 1925. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Ramsey, Grasle, Kerr, McIntyre and Hazen, and Recorder Mathews. The Mayor stated that the meeting was called for the purpose of hearing the report on the Monroe Street bridge and for the transaction of any other business that might come before the Council. Councilman Ramsey stated that a concrete culvert 8 feet by 8 feet and 70 feet in length constructed across Monroe Street would be satisfactory to Mr. Fisch.

The City Engineer stated that a concret culvert 8 feet by 6 feet in the clear and 94 feet in length would cost approximately \$4175.00.

Upon motion duly made and carried, the City Engineer was instructed to prepare plans and specifications for a bridge across Monroe Street.

The proposed assessment to pay the cost of the improvement of 32nd Street having been filed with the Recorder, upon motion duly made and carried, the 13th day of October, 1925, at the hour of 8:00 o'clock P. M. of said day, was appointed as the time and the City Hall as the place for hearing and considering objections to said assessment.

Upon motion duly made and carried, the City Engineer was instructed to establish the grades on 22th Street and Madison Street between 21st and 22nd Streets. It was ordered that the Council meet with the property owners on 22nd Street to discuss the grade of said street as established by the Union High School, and the Recorder was instructed to notify all property owners interested to be present at 5:00 o'clock P. M. next Thursday, that being the time fixed by the Council for the meeting. Councilman Ramsey reported that he had seen the Sheriff of Multnomah County in regard to the jail which Multnomah County had for sale, and was informed that there were 50 applications in for the jail and that it would cost \$1000.00 to place the jail on the sidewalk in front of Court House.

Upon motion duly made and carried, it was ordered that all ordinances proposed by the Council be published in the Milwaukie Review, and the Recorder was instructed to prepare an extra copy of each ordinance hereafter proposed for the Milwaukie Review. Upon motion duly made and carried, the Milwaukie Band was granted the use of the City Hall the first Saturday in October free of any charge for the purpose of conducting a dance.

Upon motion duly made and carried, the Council adjourned.

TOWN HALL, MILWAUKIE, OREGON, OCTOBER 13TH. 1925.

The two hundred eighty-third regular meeting of the Council of the Town of Milwaukie, was held on the 13th. day of October, 1925. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, councilmen Hazen, Grasle, Kerr and Ramsey, Recorder Mathews and Marshal Keck.

The minutes of the two hundred eighty-second regular meeting of the Council held on the 8th. day of September, 1925, and the minutes of the adjourned meeting of the two hundred eighty-second regular meeting of the Council held on the 15th day of September, 1925, also the minutes of the special meeting of the Council held on the 22nd day of September, 1925, were read and approved as read. The proposals for the improvement of Monroe Street were opened and read, which proposals were as follows:

Upon motion duly made and carried, the proposals for the improvement of 28th. Street were opened and read, which proposals were as follows:

United Contracting Co....	4591.60.
J. Rebman.....	5361.41.

Curtis Gardner having submitted the lowest bid for making the fill and constructing a concrete culvert across Monroe Street, upon motion duly made and carried, Curtis Gardner was awarded the contract for the work for \$3532.50. Curtis Gardner having submitted the lowest bid for the improvement of 28th. Street, upon motion duly made and carried, Mr. Gardner was awarded the contract for the improvement of 28th. Street for the sum of \$4036.02. Upon motion duly made and carried, the Recorder was instructed to return to the unsuccessful bidders the certified checks accompanying their respective bids. Upon motion duly made and carried, the Mayor and Recorder were instructed to execute contracts in behalf of the Town of Milwaukie with Curtie Gardner for the improvement of 28th. Street and constructing a concrete culvert and making the fill across Monroe Street. Upon motion duly made and carried, the Recorder was instructed to prepare a formal complaint and file the same with the Public Service Commission of Oregon requesting the Commission to compel the Southern Pacific Company to install wig wag signals at the Southern Pacific Railroad crossings on Harrison Street and on Monroe Street.

Upon motion duly made and carried, the Street Supt. was instructed to remove the old plank sidewalk on the east side of Front Street between Washington Street and the City Limits at Island Station and replace the same with a gravel sidewalk.
