The nine hundred seventy-third regular meeting of the Council of the City of Milwaukie, was held on the thirteenth day of August, 1962.

The meeting was called to order by Mayor Clay.

Present: Mayor Earl Clay; Councilmen James Howard, Charles Renard and Paul Baer; City Manager Leonard Jullan, City Attorney John O. Sheldahl and Clerk Ellen Martin.. Absent: Councilman Theron Sedgwick.

Mr. Ron Forrest came before the Council on behalf of the Junior Chamber of Commerce and stated that the Junior Chamber of Commerce wished to donate to the City, and plant along the Main Street, parking, in front of the City Hall, four dogwood trees. There was discussion about the planting of the trees in the parking as this would interfere with the setting back of the curbs to widen Main Street. It was moved by Renard and seconded by Howard that the trees be accepted and that the City Manager and the Junior Chamber of Commerce decide on the location of the planting. Motion carried and so ordered.

Mr. Forrest then stated that the Junior Chamber of Commerce would like to plant dogwood trees along both sides of Main Street, four trees to each block, to be of the variety of Dogwood that does not grow large and to be alternated red and white trees, and wanted the approval of the Council to remove blocks of pavement from the sidewlaks for these plantings. It was moved by Renard and seconded by Howard that a committee of three, one of which is to be a member of the Junior Chamber of Commerce, one a member of the Council and one business man, be appointed to make investigation of the feasibility of this plan and report their findings to the Council. Motion carried and so ordered.

Mr. Frank St. Pierre, contractor, and Mr. Jossy, architect, laid plans for the remodeling and rehabilitation of the Ledding Estate buildings along the west side of Main Street between Momroe Street and Jackson Street, cameebefore the Council and requested approval of their plans for this work. There was considerable discussion on the question of the present condition of the buildings. It was moved by Renard and seconded by Howard that the City employ a qualified disinterested person to make inspection of these buildings and report his findings to the Council. Motion carried and so ordered.

The Mayor opened the hearing on the matter of the withdrawal of the George Ivers property from the Clackamas Water District and called for any objection to the same, There was no person present who objected and no written objection had been received. The Mayor declared the hearing closed. Ordinance No. 928 was taken up and read for its first reading. It was moved by Howard and seconded by Renard that Ordinance Number 928 be passed to its second reading. Motion carried and so ordered.

The Mayor opened the hearing on the question of the annexation of properties as described in Ordinance No. 924 and called for objection to the same. There was no person present who made objection and no written objection had been received. The Mayor declared the hearing closed. Ordinance Number 929 was taken up and read for its first reading. It was moved by Howard and seconded by Renard that Ordinance No. 929 be passed to its second reading. Motion carried and so ordered.

The Mayor opened the hearing on the question of the annexation of properties as described in Ordinance No. 925 and called by objection to the same. There was no person present who objected and no written objection had been received. The Mayor declared the hearing closed. Ordinance No. 930 was taken up and read for its first reading. It was moved by Renard and seconded by Baer that Ordinance No. 930 be passed to its second reading. Motion carried and so ordered.

The Mayor opened the hearing on the question of the withdrawal from the Milwaukie Rural Fire Protection District of territories recently annexed to the City and described in Ordinances 904, 908, 909 and 910 and called for objection to the same. There was no person present who made objection and no written objection had been received. The Mayor declared the hearing closed. Ordinance Number 931 was taken up and read for its first reading. It was moved by Baer and seconded by Renard that Ordinance No. 931 be passed to its second reading. Motion carried and so ordered.

The Mayor opened the hearing on the question of the withdrawal from the Wichita Zone of properties as described in Ordinances 904, 908, 909, 910 and called by objection the the same. There was no citizen present who made objection and no written objection had been received. The Mayor declared the hearing closed. Ordinance No. 932 was taken up and read for its first reading. It was moved by Renard and seconded by Baer that Ordinance No. 932 be passed to its second reading. Motion carried and so ordered.

The Mayor opened the hearing on the withdrawal from the Milwaukie Rural Fire Protection District of those properties recently annexed to Milwaukie as described in Ordinance No. 919 and called for objection to the same. There was no person present who objected and no wr written objection had been received. The Mayor declared the hearing closed. Ordinance No. 933 was taken up and read for its first reading. It was moved by Howard and seconded by Baer that Ordinance No. 933 be passed to its second reading. Motion carried and so ordered.

The Mayor opened the hearing on the question of the withdrawal from the Wichita Zoning District of those properties recently annexed to Milwaukie and described in Ordinance No. 919 and called for objection to the same. There was no person present who objected and no written objection had been received. The Mayor declared the hearing closed. Ordinance No. 934 was taken up and read for its first reading. It was moved by Baer and seconded by Renard that Ordinance No. 934 be passed to its second reading. Motion carried and so ordered.

Ordinance No. 935 was taken up and read for its first reading. It was moved by Howard and seconded by Renard that Ordinance No. 935 be passed to its second reading. Motion carried and so ordered.

Ordinance Number 936 was taken up and read for its first reading. It was moved by Baer and seconded by Howard that Ordinance No. 936 be passed to its second reading. Motion carried and so ordered.

Ordinance No. 937 was taken up and read for its first reading. It was moved by Howard and seconded by Renard that Ordinance No. 937 be passed to its second reading. Motion carried and so ordered.

Ordinance Number 938 was taken up and read for its first reading. It was moved by Baer and seconded by Howard that Ordinance No. 938 be passed to its second reading. Motion carried and so ordered.

Manager Mullan reported that the State Highway Department had informed him that McIntyre Electric Do. had been the successful bidder for the installation of electric traffic signals at McLoughlin Blvd. and River Road. The amount of the bid was \$5913.00. The City has paid \$2,000.00 toward their share of the cost of this installation. The Manager was requested to contact the Highway Department to ascertain if or not this electrical installation covered the whole cost.

The Police report was read and ordered filed. The Health Department report was read and ordered filed.

It was moved by Howard and seconded by Renard that the following bills be approved and that warrants be drawn for payment of same.
