Town Hall, Milwaukie, Oregon, May 17th. 1932.

An adjourned meeting of the three hundred sixty-second regular meeting of the Council was held on the 17th. day of May, 1932. Meeting Called to order by Mayor Miller. Present, Mayor Miller, Councilmen Sanders, Dean, Bevington and Dell, Recorder Mathews and Marshal Keck. Upon motion duly made and carried, it was ordered that the city accept the sum of \$97.60 in full settlement for city lien against Lot 1, Block 1, Karlens Addition, for 28th. Street improvement. After a hearing on the two applications for a franchise to operate motor busses on and along the streets of Milwaukie for the purpose of transporting passengers for hire and after due consideration, upon motion duly made and carried, a permit was granted to W. M. Rankin and L. M. Peden to operate motor busses on and along the streets of Milwaukie, Oregon, for a period of six months from the 17th. day of May, 1932, subject to the reasonable regulation and control of the Council of Milwaukie.

Upon motion duly made and carried, C. C. Mullan was allowed \$40.00 as expenses to attend the Firemens School at Corvallis, Oregon.

Upon motion duly made and carried, the offer of Ray Bishell to pay the city all its charges against Lot 15, Block 011, Quincy Addition to Milwaukie, for its interest in said lot, payable \$100.00 cash and balance in monthly installments of \$5.00 each with interest at rate of 6% per annum was accepted and the Mayor and Recorder were authorized on behalf of the City to entered into necessary agreement with Mr. Bishell. Upon motion duly made and carried, the Council adjourned.
