SPECIAL MEETING OF OCTOBER 7, 1964

Acting Chairman Strauss read the notice of the hearing as published and called for any objection to a change of zone from 3-R-2 Special to Commercial Zone on Tax Lots 38 and 39, Whitcomb D.L.C. There was no citized present who made objection and no written objection had been received. The Chairman declared the hearing closed.

Mr. James Praggastis, owner of the property, presented a preliminary plot plan showing that the proposed use of the property was for a small Steak House and for parking lot to be used by both the bowling alley on the next property to the east and for the Steak House. It was moved by Burdick and seconded by Bernard that the Planning Commission recommend to the Council that the zone on this property be changed from 3-R-2 Special to Commercial. Motion carried and so ordered.
