

Res 4-1925

A resolution vacating the following Streets and alleys in Young's Addition, Milwaukie, Oregon, to-wit: All of Madison Street lying between the east line of 22nd Street and the west line of 25th. Street: All of Madison Street lying between the East line of 25th. Street and the east line of said Young's Addition: All of 23rd. Street lying between the north line of Madison Street and the north line of said Young's Addition. All of 25th. Street lying between the north line of Willard Street and the North line of said Young's Addition, and all that certain alley running east and west through the center of Block 4 in said Young's Addition, was read and adopted as read. Upon motion duly made and carried, the Street Supt. was given the ties on 29th. Street, provided that he remove them on his own time. The Recorder was requested to notify Mr. Wagner, Mrs. Loeding, Mrs. Carr and the S. P. Co. to replace the old wooden sidewalks in front of their property on Monroe Street with cement sidewalks. Upon motion duly made and carried, the Recorder was instructed prepare an ordinance amending Sec. 4 of Ordinance No. 139, by making the installation charge of \$25.00 for water connections accompany the application for water connections. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants on the Treasury in payment of the same:

TOWN HALL, MILWAUKIE, OREGON, JULY, 17TH. 1925.

An adjourned meeting of the two hundred eightieth regular meeting of the Council of the Town of Milwaukie was held on the 17th. day of July, 1925. Meeting called to order by Councilman Kerr, President of the Council. Present, Councilmen Kerr, Kelso, McIntyre and Hazen, Recorder Mathews and Marshal Keck.

A petition of owners of real property abutting on East Monroe Street for the improvement of said street from Oak Street easterly to 42nd. Street was read, and the Council deeming it necessary to improve said street as petitioned for, upon motion duly made and carried, the City Engineer was instructed to prepare plans and specifications for the improvement of said street as petitioned for, and estimates of the work to be done and the probable cost thereof.

Upon motion duly made and carried, the Recorder and Mayor were instructed to purchase a new typewriter for the City. Councilman Ramsey, Chairman of the Street Committee, reported that he had seen Mr. W. R. Counsell in regard to having the County do the paving for the Town, and that Mr. Counsell had informed him that the County would do the paving for cost plus 10% and would prepare the base for receiving the pavement for actual cost. Upon motion duly made and carried, the bids of Peterson & Scott and The United Contracting Company ~~were rejected~~ for paving 32nd. Street were rejected. Upon motion duly made and carried, Clackamas County was authorized to do the paving for the Town at cost plus 10% and to prepare the base for receiving the pavement at actual cost. The Street Supt. was instructed to repair the crossing at 21st. Street and Lake Road by having the same brought to grade and paved when the other paving was being done. Upon motion duly made and carried, the Recorder was instructed to advertise for bids for the improvement of Jackson Street in the Milwaukie Review, said bids to be opened on the 27th. day of July, 1925.

The matter of having the ordinances of the City printed was put over until the next regular meeting. Upon motion duly made and carried, the Council adjourned until Monday the 27th. day of July, 1925.

TOWN HALL, MILWAUKIE, OREGON, JULY 27TH. 1925.

An adjourned meeting of the two hundred eightieth regular meeting of the Council of the Town of Milwaukie was held on the 27th. day of July, 1925. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Ramsey, Kerr, Kelso, McIntyre and Hazen, Recorder Mathews and Marshal Keck. The bid of W. R. Strange for the improvement of Jackson Street was opened and read. The bid of W. R. Strange of \$526.50 for the improvement of Jackson Street, being the lowest and only bid submitted for the improvement of Jackson Street, was accepted by the Council, and upon motion duly made and carried, the contract for the improvement of Jackson Street was awarded to W. R. Strange for the sum of \$526.50. Upon motion duly made and carried, the Mayor was instructed to appoint a Committee to interview Mr. R. M. Fisch and see what his wishes are in regard to bridge across Monroe Street. The Mayor Appointed Councilmen Ramsey and McIntyre as such committee. A petition of owners of real property abutting on 28th. Street, for the improvement of 28th. Street from the south property line of Harrison Street to the North property line of Washington Street was read, and the Council deeming it expedient and necessary that said improvement be made as petitioned, upon motion duly made and carried, the City Engineer was instructed to prepare plans and specifications for said improvement and estimates of the work to be done and the probable cost thereof. Upon motion duly made and carried, the purchasing agent was instructed to purchase 3 stop signs; 3 school signs and 3 traffic guides. The Street Supt. was instructed to install a 9" corrugated iron pipe across the west end of East Monroe Street and a 12" corrugated iron pipe across Railroad Avenue on the the grade and at the places designated by the City Engineer. The following resolution was read and unanimously adopted as read:

RESOLUTION AND NOTICE OF THE IMPROVEMENT OF EAST MONROE STREET FROM OAK STREET TO 42ND. STREET.

Whereas, pursuant to an order of the Council of the Town of Milwaukie, Oregon, heretofore made, the City Engineer has filed his report and filed in the office of the Recorder of said Town plans and specifications for an appropriate improvement of East Monroe Street from Oak Street to 42nd. Street, according to the petition heretofore filed, together with an estimate of the work to be done and the probable cost thereof, and whereas, said plans and specifications and estimates are satisfactory to the Council of the Town of Milwaukie: Therefore be it resolved by the Council of the Town of Milwaukie, Oregon, that said plans, specifications and estimates be and the same are hereby approved and adopted. And be it further resolved that it is the purpose and intention of the Town of Milwaukie by its Council to make said improvement, described as follows, to-wit:

(1). That said East Monroe Street be improved from Oak Street to 42nd. Street by widening the present gravel roadway to a width of sixteen and one-half feet by placing the necessary crushed rock to make a base five inches in thickness.

(2). By scarifying and rolling the present gravel roadway to make a uniform surface suitable to receive an asphaltic pavement of 2 inches in thickness. All work to be done in accordance with the plans and specifications heretofore filed with the Recorder of the Town of Milwaukie and approved by this Resolution.

Remonstrances against said improvement may be filed in writing with the Recorder of the Town of Milwaukie on or before the 11th day of August, 1925.

The Recorder of the Town of Milwaukie is hereby directed to cause this notice and resolution to be posted as required by the Charter of the Town of Milwaukie, Oregon. Upon motion duly made and carried, the Recorder was instructed to draw warrants in the amount of \$2000.00 in favor of Peterson & Scott on the 32nd. Street Fund, as part payment of the cost of the improvement of said street. Upon motion duly made and carried, the Council adjourned.
