

## SPECIAL MEETING OF JULY 17, 1950

## COUNCIL CHAMBERS

A special meeting of the Council was called July 17, 1950, for the purpose of discussing the sale of 1.55 acre, in the Kellogg Park Industrial Area, to the Independent Distributors Incorporated, and such other matters as was necessary to come before the Council at this time.

Present: Mayor Sperr; Councilmen, E. Norbeck, G. Taylor, Attorney Kirkpatrick, Treasurer Dillery, (Acting Recorder.)

This property was discussed but no decision was made on the matter.

It was moved by Taylor, seconded by Norbeck that the money for the sewage treatment plant be kept in a separate account in the bank without interest, which, is now being paid to the City of Milwaukie, on various balances of funds, and that the City accept a loan from the bank without interest up to an amount of \$30,000.00 to cover anticipated warrants in various funds. Motion carried and so ordered.

It was moved by Taylor, seconded by Norbeck that P.S. Lord be authorized to lay water mains on the following streets at a cost not to exceed \$12,000.00.

On Elmer from the intersection of 32nd Street to 35th Street  
On 35th from Elmer to Wister  
On 34th from Elmer to Wister  
On Sellwood from 32nd to 35 Street.

Motion carried and so ordered.

It was moved by Taylor and seconded by Norbeck that the Manager pro-tem be authorized to give permission to Joe Councili to move his residence from 746 Main Street south on Main to Harrison, East on Harrison to Railroad Avenue S.E. on Railroad Avenue to 3235 Railroad Avenue provided they conform to the building code requirements. Motion carried and so ordered.

## MEETING OF JULY 24, 1950

## 753rd MEETING

The seven hundred fifty-third regular meeting of the Council was held on the twenty-fourth day of July, 1950.

The meeting was called to order by Mayor Sperr.

Present: Mayor Sperr; Councilmen Taylor, Norbeck, Mullan, and Frady; Officer Delp, and Recorder Martin. Absent: Attorney Kirkpatrick.

Ordinance Number 541 was taken up and read in full for its first reading. It was moved by Frady and seconded by Mullan that the rules be suspended and that Ordinance Number 541 be read by title only for its second reading at this time. Motion carried and so ordered. Ordinance Number 541, AN ORDINANCE, establishing a local organization for civil defense in accordance with the State Civil Defense plan and program, for the City of Milwaukie: Authorizing the Mayor to appoint a Director of Civil Defense for the City of Milwaukie and giving such Director all powers and duties provided for in Chapter 434, Oregon Laws of 1949; and declaring an emergency, was taken up and read by title only for its second reading and put on its passage with the following results being had. Ayes: Sperr, Taylor, Norbeck, Mullan, and Frady. Nays: None. Ordinance Number 541 passed by unanimous vote of the Council and was so declared by the Mayor.
