It was moved by Burdick and seconded by Shrock that the old Remington typewriter of the City be sold for \$8.00. Motion carried and so ordered.

COUNCIL CHAMBERS, APRIL 13, 1936

The four hundred seventeenth regular meeting of the Council of Milwaukie was held on the 13th day of April, 1936.

Present: Mayor Sanders; Councilmen Burdick, Dell, Walsh and Wills; Marshal Riley; Water Superintendent Bevington; Fire Chief Lewellyn, and Recorder Adams.

The minutes of the four hundred fifteenth and four hundred sixteenth regular meetings of the Council held respectively on the 9th and 23rd days of March, 1936 were each read and were each approved as read.

The Recorder opened and read the following sealed bids for \$5,000

Milwaukie Sewer Refunding Bonds:

1. Bid for all of said bonds, drawing interest at the rate of $2\frac{1}{2}$ per cent per annum, at 100.27, plus accrued interest, by Mess, Tripp & Butchart, accompanied by a certified check for \$100.00.
2. Bid for all of said bonds, drawing interest at the rate of 4 per cent per annum, at 101.25, plus accrued interest, by First State Bank of Milwaukie, Milwaukie, Oregon, accompanied by a certified check for \$100.00.
3. Bid for all of said bonds, drawing interest at the rate of 3% per annum, at 100.86, plus accrued interest, by Federal Securities Company, accompanied by a certified check for \$100.00.
4. Bid for all of said bonds, drawing interest at the rate of $2\text{-}3/4\%$ per annum, at 100.17, plus accrued interest, by Marshal Wright & Company, accompanied by a certified check for \$100.00.
5. Bid for all of said bonds, drawing interest at the rate of $3\frac{1}{2}\%$ per annum, at 100.08, plus accrued interest, by Universal Bond & Mortgage Corporation, accompanied by a certified check for \$100.00.
6. Bid for all of said bonds, drawing interest at the rate of 3% per annum, at 100.078, plus accrued interest, by Baker, Fordyce Co., accompanied by a certified check for \$100.00.
7. Bid for \$500.00 of said bonds, drawing interest at the rate of 5% per annum, at \$100.00, by Mary E. Gapiard, accompanied by a certified check for \$100.00.

It was moved by Burdick, seconded by Walsh that the above bid of Mess, Tripp & Butchart be accepted, and that the Recorder deliver the bonds and receive payment therefor on behalf of Milwaukie as soon as the bonds become available. The roll call being taken on the motion, the following result was had:-

The Treasurer's monthly report was read and ordered filed.

The Fire Chief's monthly report was read and ordered filed.

Mr. Keep, operator of the Richfield Oil and Gasoline Distributing Plant in the City, raised the question of complying with the City Ordinance in reference to gasoline storage. It was moved by Burdick and seconded by Willis that the Recorder prepare and post an ordinance amending Ordinance Number 183 by increasing the quantity of gasoline that may be stored underground to 30,000 gallons and conforming requirements concerning storage of gasoline and volatile oils above ground to regulations of the State Fire Marshal's Office for the storage of such commodities in cities. Motion carried and so ordered.

It was moved by Burdick and seconded by Dell that Ordinance Number 362 entitled "An Ordinance providing for a special election to be held on the 15th day of May, 1936, for the purpose of submitting to the voters of Milwaukie for their acceptance or rejection a proposal to Amend the Charter of Milwaukie filed in the office of the Secretary of State February 11, 1905, and to amend all acts amending said act by adding thereto Section 22-B authorizing the issuance and sale of Seven thousand, five hundred dollars (\$7,500.00) general obligation bonds of said Milwaukie, to provide funds with which to purchase a fire truck and other fire fighting equipment, and providing for the levy of a special tax to pay principal of and interest on said bonds." be taken up for consideration. Motion carried and so ordered. Ordinance Number 362 was read for the first time. Ordinance number 362 passed the first reading. It was moved by Dell and seconded by Burdick that Ordinance Number 362 be taken up for the second time and be read by title only. The roll call on the motion being taken the following result was had: Ayes: Burdick, Dell, Sanders and Willis. Noes: None. Motion carried and so ordered. It was moved by Dell and seconded by Burdick that Ordinance Number 362 be taken up for the third reading and be read by title only. The roll call on the motion was taken with the following result being had. Ayes: Burdick, Dell, Sanders and Willis. Noes: None. Motion carried and so ordered. Ordinance Number 362 was read for the third time by title only. Ordinance Number 362 was put on its passage with the following result being had: Ayes: Burdick, Dell, Sanders and Walsh. Noes: None. Ordinance Number 362 passed the Council.

It was moved by Dell and seconded by Walsh that the Recorder advertise for bids on the construction of pumphouse for the six inch well pump, in accordance with plans to be prepared by the City Engineer, W. W. Jones. Motion carried and so ordered.

The Recorder brought up the question of the sale of lots 17 and 18 block 71, Minthorn Addition. He stated that the City had approximately \$28.00 against each lot and that the City had acquired an assessment sale title to the lots. It was moved by Dell and seconded by Walsh that the Recorder be authorized to sell the lots on behalf of the City for \$35.00 each. Motion carried and so ordered.

Mr. Harris and Mr. Johnson appeared before the Council in behalf of residents in Quincy Addition and requested that the Council give attention to the putting through of a footpath or roadway connecting thirtieth Street and the Grammar School Grounds and also that the Council give attention to the repair of Thirtieth, Thirty-first and Thirty-second Streets in Quincy Addition. Mr. Clarence Rudder and Mr. Jones asked the Council's cooperation in having Clackamas County residents employed on P.W.A. projects. County Supervisor Stroll requesting that Clackamas County residents be given all preference on P.W.A. work undertaken in the County. Motion carried and so ordered.
