TOWN HALL, MILWAUKIE, OREGON, MARCH 11TH. 1929.

The three hundred twenty-fourth regular meeting of the Council of Milwaukie was held on the 11th. day of March, 1929. Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Shindler, Sanders, Dell and Dean, and Marshal Keck. Councilman Dell reported that the petitions for the improvement of Jefferson Street and 35th. Street had been mailed to Mr. Milln. The matter of repairing the streets was turned over to the Street Committee. The report of the City Treasurer was read and ordered placed on file.

The matter of repairing Milwaukie Highway was left with the Street Committee. Moved by Councilman Dell and seconded by Councilman Sanders that a price of \$5.00 per night be made to Religious Sects for the use of the City Hall. The matter of repairing the Milwaukie Service Station on corner of Monroe Street and Milwaukie Highway was left to Councilmen Shindler and Dell.

TOWN HALL, MILWAUKIE, OREGON, APRIL 8TH. 1929.

The three hundred twenty-fifth regular meeting of the Council of Milwaukie was held on the 8th. day of April, 1929. Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Sanders, Shindler, Dean and Dell, Acting Recorder Kelso and Marshal Keck. The minutes of the three hundred twenty-third regular meeting of the Council held on the 11th. day of February, 1929, were read and approved as read. Councilman Dean reported that he had taken up the matter of repairing Milwaukie Highway with the County officials and that they would take care of this street from this time as it had been classed as a Market Road, and also that the bill sent Milwaukie for repairs last year would be assumed by the County.

Councilman Dell reported that the gravelling and grading of the City Streets had been done and that they were in good shape except a few places where holes had developed. The application of O. F. Witte for a dance hall license to conduct dances in Crystal Lake Park from April 15th. 1929 to April 15th. 1930, was read, and upon motion duly made and carried, Mr. Witte was granted a dance hall license as requested. Regularly moved and seconded that the matter of the delinquent tax liens on the various tracts of City property be taken up at the next regular meeting. The plans and specifications for the improvement of 35th. Street and estimates of the work to be done and the probable cost thereof prepared by the City Engineer and heretofore filed in the office of the Recorder, being satisfactory to the Council, the following resolution and notice was read and upon motion duly made and carried, was unanimously adopted as read:

M. Webber and wife on abid of \$250.00, and that the Mayor and Recorder be instructed and directed to make the proper conveyance on behalf of the City up the payment of the purchase price. Motion carried.

The City Engineer was instructed to establish grades ~~for~~ for sidewalk for Sam Millich at 32nd. and Madison Streets.

A communication from the Salvation Army of Oregon City asking for a donation was read and ordered laid on the table.

Moved and seconded that W. E. Kelso be appointed Acting Recorder until Mr. Mathews was able to resume his duties. Motion carried.

Moved and seconded that the City Council accept deeds for property on Willard Street as soon as the Union High School Board pays to the Young Estate the amount of \$375.00 for a parcel of land on Willard Street improvement. Moved and seconded that the Recorder be instructed to draft and post ordinances for the improvement of 35th. and Jefferson Streets. Motion carried.

Mr. Dahlman reported that the City Band was coming along in a fine shape and that they had a chance to get 30 uniforms and several instruments for \$250.00 and would like the support of the City in obtaining same, also that the band would give a free concert at the Grammer School April 16th. Mr. Dahlman was informed that the City could not do anything but the members individually would assist in raising the amount asked for.

C. H. Counsell was instructed to remove excess dirt on Lake Road.

TOWN HALL, MILWAUKIE, OREGON, MAY 13TH.1929.

The three hundred twenty-sixth regular meeting of the Council of Milwaukie was held on the 13th. day of May, 1929. Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Sanders, Shindler, Dell and Dean, Recorder Mathews and Marshal Keck. The minutes of the three hundred twenty-fourth regular meeting of the Council held on the 11th. day of March, 1929, and the minutes of the three hundred twenty-fifth regular meeting of the Council held on the 8th. day of April, 1929, were read and approved as read.

Upon motion duly made and carried, the Recorder was instructed to draw a warrant on the Street Fund in favor of the Milwaukie Sanitary Sewer Fund for \$100.00 to apply to-ward the payment of the sewer assessment against the Woodard property in payment of property deeded to city by the Woodards for extending Willard Street. Councilman Dell reported that Chas. Counsell had gone over the street with the grader and had removed all excess dirt, and that all the streets were in good shape, except Railroad Avenue. Upon motion duly made and carried, the Recorder was instructed to notify the L. D. McFarland Company to keep all poles and logs off of the street in front of its property and to keep the street in repair. The matter of oiling King Street was referred to Councilman Dell to report at the next meeting of the Council.

A petition for the extension of the water main from the intersection of Adams and 40th. Streetseasterly along the south side of Adams Street to the easterly city limits was read and referred to the Water Supt. Mrs. Grannis was present and requested the Council to allow her to redeem her property on Jackson Street from the sale for delinquent assessments for the improvement of the street by paying the actual amount of the assessment without interest, penalty or cost of sale, for the reason that the assessment was made in the name of another person and that she did not receive notice of the assessment. Upon motion duly made and carried, the request of Mrs. Grannis was granted.

Upon motion duly made and carried, ordinance No. 290 entitled, "An ordinance providing for the improvement of 35th. Street in Milwaukie, Oregon, northeasterly from Lake Road to the northerly side of Blocks 20 and 21, Quincy Addition to Milwaukie, and declaring an emergency", was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, councilmen Shindler, Sanders, Dell and Dean. Noes, none. Ordinance No. 290 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 290 was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes; Councilmen Shindler, Sanders, Dean and Dell. Noes, none. Ordinance No. 290 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 290 was taken up for the third and final reading and read by title only.
