

TOWN HALL, MILWAUKIE, OREGON, MAY 28TH. 1925.

An adjourned meeting of the regular two hundred seventy-eight regular meeting of the Council of the Town of Milwaukie was held on the 28th. day of May, 1925. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Ramsey, Kelso, Kerr, McIntyre and Hazen, Recorder Mathews and Marshal Keck. Upon motion duly made and carried, ordinance No. 225 was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, Hazen, McIntyre, Kelso, Kerr and Ramsey. Nays, none. Ordinance No. 225 passed the first reading.

Upon motion duly made and carried, the rules were suspended and Ordinance No. 225 was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes, Hazen, McIntyre, Kelso, Kerr and Ramsey. Nays, none. Ordinance No. 225 passed the second reading. Upon motion duly made and carried, the rules were suspended and Ordinance No. 225 was taken up for the third and final reading and read by title only. The roll-call showed the following result: Ayes, Hazen, McIntyre, Kelso, Kerr and Ramsey. Nays, none. Ordinance No. 225 passed the third and final reading. Ordinance Number 227 entitled, "An ordinance providing for the improvement of Jackson Street in the Town of Milwaukie, Oregon, from the east property line of 40th. Street east to 42nd. Street, and declaring an emergency", was read and ordered posted as required by the City Charter. The following bids for mixing and pouring the concrete for the construction of base for foundation for stand pipe were submitted: J. C. Jensen for continuous pouring form measure... \$2.50 per cu. yd. Dry measure per yd. \$2.10. For regular 8 hour run- form measure . \$2.15 per yd. Dry measure. \$1.75 per yd.

Fickemeyer & Geston- Pouring concrete at the rate of \$1.50 per yd.

Upon motion duly made and carried, the action of the council in awarding the contract for furnishing 240 bbl. of cement to Milwaukie

Fuel & Feed Company, at a Council meeting held on the 20th. day of May, 1925, was rescinded. Upon motion duly made and carried, G. C. Pelton was awarded the contract for furnishing approximately 240 bbl. Oregon Cement at \$2.90 per barrel; approximately 75 cu. yd. of washed sand at \$2.65 per yd; also approximately 133 cu. yd of washed gravel at \$2.65 per yd. all to be delivered at 40th. & Harvey Streets; also the mixing and pouring of the concrete for stand pipe base at \$1.45 per cu. yd. Mr. Pelton to furnish the lumber for protecting material without cost to City, and to put in the necessary concrete forms at actual cost.

TOWN HALL, MILWAUKIE, OREGON, JUNE 9TH. 1925.

The two hundred seventy-ninth regular meeting of the Council was held on the 9th. day of June, 1925. Present, Mayor Cowell, councilmen Kerr, Kelso, Ramsey, McIntyre and Hazen, Recorder Mathews and Marshal Keck. The minutes of the two hundred seventy-eight regular meeting of the council held on the 12th. day of May, 1925, and the minutes of the special meeting of the Council held on the 20th day of May, 1925, and the minutes of the adjourned meeting of the two hundred seventy-eight regular meeting of the Council held on the 28th. day of May, 1925, were read and approved as read. A petition requesting the Council to pass an ordinance prohibiting the loading and unloading of obnoxious fertilizer in the Town of Milwaukie was read and upon motion duly made and carried, the petition was referred to the Health Committee with a request to make a report on the same at the next meeting of the Council.

A petition of property owners along Monroe Street requesting the Council to pave Monroe Street from Main Street to 29th. Street was read, and upon motion duly made and carried, the petition was laid on the table until after the other streets were paved. A petition to vacate certain streets and alleys in Young Addition was read and upon motion duly made and carried, the petition was granted. The Engineer was instructed to make a preliminary survey of a sewer district and ascertain the most feasible route to run the main sewer line. Upon motion duly made and carried the Recorder was instructed to advertise in The Daily-Record Abstract for bids for the improvement of 32nd. Street, the bids to be opened on the 16th. day of June, 1925. Upon motion duly made and carried, the Chairman of the Street Committee was instructed to interview the County Court of Clackamas County and see if the County would pay for that portion of the improvement of 32nd. Street outside of the City limits. Upon motion duly made and carried, the City Engineer and Mayor were instructed to purchase a altitude valve for the stand pipe and all other necessary fixtures.

TOWN HALL, MILWAUKIE, OREGON, JUNE 16TH, 1925.

An adjourned meeting of the two hundred seventy-ninth regular meeting of the Council of the Town of Milwaukie was held on the 16th day of June, 1925. Meeting called to order by Mayor Cowell.

Present, mayor Cowell, councilmen, Ramsey, Kerr, Kelso, McIntyre and Hazen, Recorder Mathews and Marshal Keck. Upon motion duly made and carried, the proposals for the improvement of 32nd Street were opened and read, which proposals were as follows:

Peterson & Scott having submitted the lowest bid for the improvement of 32nd. Street, upon motion duly made and carried, the contract for the improvement of 32nd. Street was awarded to Peterson & Scott for the sum of \$3370.90.

Upon motion duly made and carried, the rules were suspended and ordinance No. 227 was taken up for the third and final reading and read by title only. A letter from L. S. Kaiser, Supt. of Water Bureau of Portland, in regard a storage reservoir for water was read and ordered placed on file. The Water Supt. was instructed to make a test for three days to ascertain the amount of water used by Milwaukie daily. Council Ramsey of the Health Committee reported that he had seen the County Health Officer and had been informed by the Health Officer that the obnoxious odors from the fertilizer used by the celery gardeners was not detrimental to health, but was a nuisance. Upon motion duly made and carried, the Recorder was instructed to prepare an ordinance prohibiting the loading or unloading of fertilizer with an obnoxious odor within the Town of Milwaukie, Oregon. Upon motion duly made and carried, the City Engineer was instructed to construct a cement cap over pressure reducer pit.

Upon motion duly made and carried, the Council adjourned.
