COUNCIL CHAMBERS, CITY HALL, SEPTEMBER 23, 1935

The four hundred seventh regular meeting of the Council was held on the 23rd day of September, 1935.

The meeting was called to order by Mayor Sanders.

Present: Mayor Sanders, Councilmen Burdick, Dell and Shrock; Water Superintendent Bevington; Recorder Adams, Fire Chief Lewellyn and Marshal Riley.

L. H. Alexander of the Bank of Sellwood appeared and suggested that the City purchase the spring on the old Sellwood place for the purpose of using it as the source of the City's water supply. No action was taken on the suggestion.

Ordinance No. 353 entitled "An Ordinance to regulate and license certain mechanical amusement devices commonly known and referred to as pin ball machines under Chapter 369, Laws 1935, State of Oregon." was taken up for consideration and read for the first time. There being no objection it was read for the second time by title only. There being no objection it was read for the third and final time by title only. Ordinance No. 353 being put on its passage the following result was had. Ayes: Burdick, Dell and Shrock. Noes, None. Ordinance No. 353 passed the Council.

Ordinance No. 354 " An Ordinance to prohibit the operation of slot machines and providing a penalty for the violation of the same." was taken up for consideration and read for the first time. There being no objection it was read for the second time by title only. No objection being made Ordinance number 354 was read for the third reading by title only. Ordinance No. 354 being put on its passage the following result was had. Ayes: Burdick, Dell and Shrock. Noes, None. Ordinance No. 354 passed the Council.

COUNCIL CHAMBERS, OCTOBER 14, 1935

The four hundred eighth regular meeting of the Council was held on the 14th day of October, 1935.

The meeting was called to order by Mayor Sanders.

Present: Mayor Sanders, Councilmen Burdick, Dell, Shrock and Walsh, Water Superintendent Bevington, Marshal Riley, Fire Chief Lewellyn and Recorder Adams.

The minutes of the 406th and 407th regular meetings of the

Council held respectively on the 9th and 23rd days of September and of the special meeting held on October 11, 1935, were each read and were each read approved as read.

The Treasurers monthly report was read and ordered filed.

The Fire Chief's monthly report was read and ordered filed.

It was moved by Burdick and seconded by Walsh that attest well be drilled preparatory to submitting to the people of Milwaukie the question of having well water as the source of the Municipal Water Supply. Motion carried and so ordered.

Ordinance Number 356 entitled "An Ordinance relating to the hawking and peddling of popcorn, icecream, sodapop, peanuts, and similar wares, and providing a penalty for the violation thereof." was taken up for consideration and read by title only. There being no objection it was passed to second reading and read by title only. There being no objection Ordinance Number 356 was passed to the third and final reading and read by title only. Ordinance Number 356 being put on its passage it was put on its passage with the following result being had:

Noes, None. Ordinance Number 356 passed the Council.

It was moved by Shrock and seconded by Walsh that arrangements be made with Clackamas County to have the City Streets graded. Motion carried and so ordered.

It was moved by Shrock and seconded by Walsh that parking lanes be painted on Main Street. Motion carried and so ordered.

It was moved by Shrock and seconded by Walsh that the sale of five small wheelbarrows be authorized. Motion carried and so ordered.

It was moved by Shrock and seconded by Walsh that the purchase of stamps for the mailing of water bills on November 1st and the purchase of two barrels of road oil be authorized. Motion carried and so ordered.

It was moved by Burdick and seconded by Dell that the City Engineer investigate the existing street lines of twenty-ninth street and make a survey thereof if necessary.

It was moved by Shrock and seconded by Walsh that the following bills be approved and that the Recorder issue warrants covering the same. Motion carried and so ordered.

COUNCIL CHAMBERS, OCTOBER 28, 1935

The four hundred ninth regular meeting of the Council was held on the 28th day of October, 1935.

The meeting was called to order by Mayor Sanders.

Present: Mayor Sanders, Councilmen Burdick, Dell, Shrock and Walsh, Water Superintendent Bevington, Recorder Adams, Marshal Riley and Fire Chief Lewellyn.

Considerable discussion was had relative to the question of
