TOWN HALL, MILWAUKIE, OREGON, MARCH 16TH. 1931.

A special meeting of the Council of Milwaukie was held on the 16th. day of March, 1931. Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Shindler, Sanders, Dean and Dell, Recorder Mathews and Marshal Keck. Mayor Miller stated that the meeting was called for the purpose of discussing the proposed franchise requested by The Pacific Telephone & Telegraph Company. Mr. Bacon and Mr. Davenport of The Pacific Telephone & Telegraph Company was present. After a discussion of the terms and conditions of the franchise it was agreed that the Council would grant the Telephone Company a franchise for a period of 20 years and in consideration thereof the Pacific Telephone and Telegraph to pay the City of Milwaukie annually, during the life of said franchise, 2% per annum of its gross exchange service receipts derived from the operation of telephones located within Milwaukie, and also to furnish Milwaukie the use of three telephones for local exchange service free of charge. Mr. Bacon agreed to prepare the ordinance granting the franchise according to the terms and conditions agreed upon and present the same to the Council at a special meeting to be held on the 23rd. day of March, 1931.
