Upon motion duly made and carried, it was ordered that ordinance No. 231 be amended so as to provide that before a license could be issued, that the application must secure the written consent of three fourths of the resident property owners residing within a radius of 200 feet of where the dogs were proposed to be kept. Upon motion duly made and carried, the Street Supt. was instructed to cut all grass, thistles and obnoxious weeds in the streets of the Town of Milwaukie, and render a bill to the property owners for the cost of the same. Upon motion duly made and carried, the City Engineer was instructed to establish sidewalk grades on Jackson Street between 40th and 42nd. Streets. Upon motion duly made and carried, it was ordered that the Council petition the County Court of Clackamas County requesting the County to put in a foot bridge across Johnson Creek.

TOWN HALL, MILWAUKIE, OREGON, SEPT. 15TH. 1925.

An adjourned meeting of the two hundred eighty-second regular meeting of the Council of the Town of Milwaukie was held on the 15th. day of September, 1925. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Ramsey, Kerr, McIntyre and Hazen, and Recorder Mathews. The resignation of W. E. Kelso as councilman from Ward No. 2, was read and upon motion duly made and carried, the resignation of W. E. Kelso as Councilman from Ward No. 2 was accepted.

W. H. Grasle and M. J. Walsh were nominated as Councilman in Ward No. 2 to fill the unexpired term of W. E. Kelso, resigned: M. J. Walsh withdrew his name as a nominee for councilman in Ward No. 2. Upon motion duly made and carried, W. H. Grasle was elected Councilman in and for Ward No. 2, to fill the unexpired term of W. E. Kelso, and was duly sworn in as such councilman. The City Engineer having filed with the Recorder plans and specifications for the improvement of Lake Road, together with an estimate of the work to be done and the probable cost thereof, and said plans, specifications and estimates being satisfactory to the Council, the following resolution and notice was read and upon motion duly made and carried, was adopted as read:

RESOLUTION AND NOTICE OF THE IMPROVEMENT OF LAKE ROAD FROM THE EAST LINE OF MAIN STREET SOUTHEASTERLY TO THE CITY LIMITS.

Whereas, pursuant to an order of the Council of the Town of Milwaukie, Oregon, heretofore made, the City Engineer has filed his

report and filed in the office of the Recorder of said Town of Milwaukie, Oregon, plans and specifications for an appropriate improvement of Lake Road from the east line of Main Street southeasterly to the City limits, according to the petition heretofore filed, together with an estimate of the work to be done and the probable cost thereof, and whereas, said plans, specifications and estimates are satisfactory to the Council of the Town of Milwaukie:

THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF MILWAUKIE, OREGON, that said plans, specifications and estimates be and the same are hereby approved and adopted. AND BE IT FURTHER RESOLVED that it is the purpose and intention of the Town of Milwaukie by its Council to make said improvement, described as follows, to-wit:

By constructing cement curbs on said street from the east line of Main Street southeasterly to the City Limits. Said cement curbs to be 18 inches in height with an 8 inch base and a 6 inch top. All of said work to be done in strict accordance with the plans and specifications heretofore filed with the Recorder of the Town of Milwaukie and approved by this Resolution.

Remonstrances against said improvement may be filed in writing with the Recorder of the Town of Milwaukie on or before ten days from the 21st day of September, 1925.

The Recorder of the Town of Milwaukie is hereby directed to cause this Notice and Resolution to be posted as required by the Charter of the Town of Milwaukie, Oregon. A petition requesting the Council to pave Scott Street between Milwaukie Highway and Main Street was read, and upon motion duly made and carried, the request was granted. Upon motion duly made and carried, it was ordered that Main Street be paved to a width of 16 feet between Harrison Street and Scott Street. The preliminary estimate of the City Engineer on the cost of the proposed bridge on Monroe Street, which estimate of the cost being \$11000.00 was read, and upon motion duly made and carried, it was ordered that the Council meet with Mr. Fisch and the City Engineer to discuss the proposed bridge. Upon motion duly made and carried, Ordinance No. 232 entitled, "An ordinance providing for the improvement of 28th. Street in the Town of Milwaukie, Oregon, from the south property line of Harrison Street to the north property line of Washington Street, and declaring an emergency," was taken up for the first reading. The Ordinance being read the roll-call showed the following result: Ayes, Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none. Ordinance No. 232 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 232 was taken up for the second reading and read by title only. The rollcall showed the following result: Ayes, Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none. Ordinance No. 232 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 232 was taken up for the third and final reading and read by title only. The roll-call showed the following result: Ayes, Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none. Ordinance No. 232 passed the third and final reading. Upon motion duly made and carried, the Recorder was instructed to advertise for bids for the improvement of 28th. Street, the bids to be opened on the 13th. day of October, 1925. A petition of property owners living in the vicinity of No. 3816 Harrison Street waiving objections to the Council granting Mrs. Hansen a Kennell license was read and ordered placed on file. Upon motion duly made and carried, the petition requesting the Council to purchase the Marshal a motor vehicle was denied, and the Marshal was authorized to hire an auto when his official duties makes it necessary that he have some kind of a conveyance. Upon motion duly made and carried, J. J. Miller, M. J. Walsh, G. C. Pelton, Wm. Kleebe and C. H. Counsell were appointed as a budget Committee. The following bills were read and allowed by the Finance Committee and the upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:
