

Town Hall, Milwaukie, Oregon, October 31st. 1917.

A special meeting of the Town Council was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen, Shindler, Bates, Seavey, Grasle and Miller. The Mayor stated that the meeting was called for the purpose of letting the contract for digging the drain under Washington Street. Upon motion duly made and carried, the contract was let to W. H. Counsell for \$100.00. Upon motion duly made and carried, Mr. Bates was authorized to purchase the necessary drain pipe to go under Washington Street. Upon motion duly made and carried, the council adjourned.

Town Hall Milwaukie, Oregon, November 6th. 1917.

The one hundred eighty-eight regular meeting of the Council was held on the 6th day of November, 1917. Meeting called to order by Mayor Snyder. Present, Councilmen Shindler, Grasle, Miller, Bates and Seavey, Recorder Mathews and Marshal Riley. The minutes of the one hundred eighty seventh regular meeting of the Council was read and approved as read. Councilman Miller of the Finance Committee reported that it would be necessary to raise \$5408.15 to run the Town for the current year, and that the Committee would recommend that a tax of \$5408.15 be levied against the taxable property in Milwaukie. Upon motion duly made and carried, a tax of \$5408.15 was levied against the taxable property within the Town of Milwaukie, Oregon, and the Recorder was instructed to notify the proper County official of said tax levy. Mr. Bates of the Street Committee reported that the Rockolite Contracting Co. had repaired Foster Road and that the Street was ready for final acceptance. Upon motion of councilman Miller duly made and seconded and carried, the improvement of Foster Road was accepted and the Recorder was instructed to draw a warrant for \$318.64 in payment in full for balance due the Rockolite Contracting Company for maintenance of Foster Road. Upon motion duly made and carried, the Recorder was instructed to write the Public Service Commission of Oregon and inform them of the trouble the Town of Milwaukie is having in ##### in trying to get the Minthorn Springs Water Company to repair its water mains in the Milwaukie. The Recorder was also instructed to notify the Hawley Pulp and paper Co. and the Wenefee Lumber Company to provide suitable toilets for their employes and keep the same in proper repair. Mr. Albee stated that upper Monroe Street was in a bad condition and requested the Council to gravel the same. Councilman Miller requested the Recorder and Treasurer to report the amount of the Road Fund on hand. Upon motion duly made and carried, the Street Committee was authorized to make the necessary repairs to the bridge on Front Street. Upon motion duly made and carried, the Mayor and Finance Committee were instructed to interview the County Court of Clackamas County in regard to getting some of the tax money paid the County by the S. P. Co. Upon motion duly made and carried, the Recorder was instructed to preparing an ##### ordinance authorizing the issuance of improvement bonds to pay a portion of the cost of the improvement of 27th. Street and post a copy of the same as required by the City Charter.
