

MEETING OF JULY 13, 1953

COUNCIL CHAMBER

824th MEETING

The eight hundred twenty-fourth regular meeting of the Council was held on the thirteenth day of July, 1953.

The meeting was called to order by Mayor Mullan.

Present: Mayor Mullan, Councilmen Shook, Clay, Klein and Wright. Manager Sperr, Attorney Kirkpatrick, Fire Chief Lillis and Recorder Martin.

The minutes of the eight hundred twenty-third regular meeting of the Council, held on the twenty-second day of June, 1953, were read and approved as read.

Bids for the improvement of 37th Street from Harrison to King Streets, and 28th Street south of Lake Road, by curbs and sidewalks and driveways were opened and read as follows:

It was moved by Klein and seconded by Clay that the Manager and City Attorney examine the bids and that after their investigation the contract be awarded to the low bidder. Motion carried and so ordered.

Mr. Wm. Harrison, representing the Foster & Kleiser Sign Co. came before the Council and requested permission to place a two panel sign board on the south end of Lots 5 & 6 Block 29 Milwaukie Addition. Mr. Harrison stated that the location of the sign would be about fifteen feet north of a building presently occupied by Dan Harmon, and that the proposed location of the sign was on Mr. Harmon's property. There was considerable discussion on the matter. The Council preferred that the sign board be set closer to the building as the fifteen foot space would be apt to become a sanitary or fire hazard. It was decided that the matter be turned over to the Manager and that he make an effort to have the sign board located close to the present buildings.

Mr. Edwin Graham, attorney for the Southern Pacific Co. came before the Council with regard to the streets which were owned by them at one time, a portion of Railroad Ave, (formerly Eddy Street), Oak Street and Monroe Street from 37th Street to Railroad Avenue, and a portion of Harrison Street. Mr. Graham stated that the Southern Pacific Co. were offering the City of Milwaukie perpetual use of the property for street purposes and requested that the City agree that in the event of any of these streets were ever to be vacated, that the property would revert back to the Southern Pacific Co. The matter was tabled until the next regular meeting of the Council in order that investigation could be made.

It was moved by Shook and seconded by Klein that Mr. S E Johnson be paid for work completed to date less 10% in the amount of \$4,895.78. Motion carried and so ordered.

It was moved by Wright and seconded by Shook that the following bills be approved and that warrant-checks be drawn for the payment of same.

It was moved by Wright and seconded by Shook that the following salaries be approved as of July 1, 1953. Recorder \$255.00; Attorney, \$135.00; Police Chief, \$360.00; Police Sargent, \$305.00; Police Patrolman, \$290.00; Librarian, \$155.00; Librarian Assistants, 85¢ and 60¢ per hour; Fire Chief, \$360.00; Fire Captains, \$305.00; Fire Hosemen, \$290.00; Sewage Disposal Superintendent \$ 325.00; Laborers, \$1.60 per hour; Surveyor, \$2.00 per hour; Water Superintendent, \$ 360.00; Treasurer, \$300.00; City Manager, \$265.00; Custodian by contract, \$140.00 per month; Hildenbrand, \$290.00 regular, extra street work \$15.00; Peterson, \$300.00 regular, extra street work, \$15.00; Kobs \$25.00 extra street work. Motion carried and so ordered.

A report for the fiscal year, from the Municipal Judge, was read and ordered filed.

The Police Chief's monthly report was read and ordered filed.

Attorney Kirkpatrick reported that a street right-of-way from Lake Road <sup>- 36 ft.</sup> to a dead end near Kellogg Lake, 50 feet in width with a 60 foot turn around at the south end except 19 feet at the north 123 feet leaving a 31 foot right-of-way, at the north, had been deeded to the city by Frank Sanvitali, and that the same would be recorded in the Surveyor's and County Clerks office on the morrow.

Ordinance Number 587, AN ORDINANCE regulating the use of streets by itinerant merchants, providing a license therefor and fixing a penalty, was taken up and read in full for its second reading and put on its passage with the following results being had. Ayes: Mullan, Shook, Clay, Klein and Wright. Nays: None. Ordinance Number 587 passed the Council and was so declared by the Mayor.

Manager Sperr reported that Mr. Baker, chairman of the Milwaukie Rural <sup>Rural Fire District</sup> Fire Protection District, had called a meeting to be held in the City Hall on July 15, the object being to select a Citizen's Advisory Committee, to be made up of citizens from different areas of the Rural Fire Protection District and the City., the duties of the Committee would be to work out the problems facing the Rural Fire Protection District and to make recommendation to the R.F.D. Board and to the City Council, in an effort to work out a plan for the benefit of all concerned.

Manager Sperr reported that he had received the following bids for fire hose:

It was moved by Wright and seconded by Klein that the City purchase 1000 feet of hose to be selected by the Manager and Fire Chief. Motion carried and so ordered.
