

City Charter. A resolution of Union High School No. 5 requesting the Council to have the corners of the Blocks at the intersection of 23rd. and Washington Streets rounded sufficiently to permit vehicles of all types to travel said intersection at a moderate rate of speed. The specifications for the construction of a steel stand pipe of 160,000 gallon capacity prepared by the City Engineer was read, and after changing the time of paying for the same as follows; 25% upon the delivery of the material on the ground; 25% upon the completion of the stand pipe and 50% within 30 days after the completion of the stand pipe, the specifications were approved by the Council and the Recorder was instructed to advertise for bids for the construction of the stand pipe in Daily-Record Abstract, said bids to be opened on the 12th. day of May, 1925, at the hour of 8:00 o'clock P. M. of said day. Upon motion duly made and carried, the City Engineer was instructed to make all necessary preliminary tests and get the site ready to ~~#####~~ put in the foundation for the stand pipe.

Upon motion duly made and carried, the Council adjourned.

TOWN HALL MILWAUKIE, OREGON, MAY 12TH. 1925.

The two hundred seventy-eight regular meeting of the Council of the Town of Milwaukie was held on the 12th. day of May, 1925.

Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Kelso, Kerr, Ramsey and Hazen, Recorder Mathews and Marshal Keck. The minutes of the two hundred seventy-seventh regular meeting of the Council held on the 14th. day of April, 1925, and the minutes of the adjourned meeting of the two hundred seventy-seventh regular meeting of the Council held on the 16th day of April, 1925, were read and approved as read. Upon motion duly made and carried, the proposals for the erection of a steel stand pipe of 160,000 capacity were opened. The proposals were as follows: The Steel Tank & Pipe Company----- \$7000.00. Western Pipe & Steel Company----\$5950.00. King Bros. Boiler Works--\$5845.00 Alt. \$5743.00. Chicago Bridge & Iron Works--\$5595.00. Albina Marine Iron Works--\$5549.00. Poole & McGonigle--\$5200.00. Pittsburgh-Des Moines Steel Co. -- \$5184.00. Upon motion duly made and carried, the contract for erecting a 160,000-gallon capacity steel stand pipe was awarded to Poole & McGonigle for \$5200.00, the stand pipe to be completed within 70 days. Upon motion duly made and carried, the Recorder was instructed to advertise for proposals for furnishing sand, gravel and cement for the construction of the foundation for the stand pipe, and to award the contract to the lowest bidder. The City Engineer having heretofore filed in the office of the Recorder, plans and specifications for the improvement of Jackson Street from the east property line of 40th. Street easterly to the City limits, and estimates of the work to be done and the probable cost thereof, and said plans, specifications and estimates being satisfactory to the Council of the Town of Milwaukie, the following resolution was read and upon motion duly made and carried, the resolution was adopted as read:

Res 3-1925

Resolution and Notice of the improvement of Jackson Street from the east property line of 40th. Street to 42nd. Street.

Whereas, pursuant to an order of the Council of the Town of Milwaukie, Oregon, heretofore made, the City Engineer has filed his report and filed in the office of the Recorder of said Town of Milwaukie, plans and specifications for an appropriate improvement of Jackson Street from the east property line of 40th. Street to 42nd. Street, according to the petition heretofore filed, together with an estimate of the work to be done and the probable cost thereof, and, whereas, said plans, specifications and estimates are satisfactory to the Council of the Town of Milwaukie:

Therefore Be It Resolved by the Council of the Town of Milwaukie, Oregon, that said plans, specifications and estimates be and the same are hereby approved and adopted. And be it further resolved that it is the purpose and intention of the Town of Milwaukie by its Council to make said improvement, described as follows, to-wit:

(1). By grading said street to the established grade and constructing thereon a 16 foot gravel roadway six (6) inches thick. All of said work to be done in accordance with the plans and specifications heretofore filed with the Recorder of the Town of Milwaukie and approved by this resolution.

Remonstrances against said improvement may be filed in writing with the Recorder of the Town of Milwaukie on or before ten days from the 16th day of May, 1925. The Recorder of the Town of Milwaukie is hereby directed to cause this notice and resolution to be posted as required by the Charter of the Town of Milwaukie, Oregon.

Ordinance number 226 entitled, "An ordinance establishing the grades of Jackson Street from the east line of 40th. Street easterly to the City limits," was read and ordered posted as required by the City Charter. There having been no objections filed against the

improvement of 32nd. Street, ordinance Number 225 entitled, " An ordinance providing for the improvement of 32nd. Street in the Town of Milwaukie, Oregon, from the north side line of Harrison Street northerly to the City limits, and declaring an emergency," was read and ordered posted as required by the City Charter.

Upon motion duly made and carried, ordinance number 224 was taken up for the first reading. The ordinance being read, the roll-call showed the following result: Ayes, Ramsey, Kerr, Kelso and Hazen. Nays, none. Ordinance No. 224 passed the first reading. Upon motion duly-made and carried, the rules were suspended and ordinance No. 224 was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes, Ramsey, Kerr, Kelso and Hazen. Nays, none. Ordinance No. 224 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 224 was taken up for the third and final reading and read by title only. The Roll-call showed the following result: Ayes, Ramsey, Kerr, Kelso and Hazen. Nays, none. Ordinance No. 224 passed the third and final reading. Upon motion duly made and carried, the Recorder was instructed to notify Mr. Carver to be present at the next regular meeting of the Council and show cause why the franchise of the Portland Southern Railway company's franchise should not be revoked. Moved by councilman Ramsey and seconded by Councilman Kelso that the Town of Milwaukie reject the benefits of the Workmen's Compensation Law as amended by the last session of the Legislature. Motion carried. The Recorder was instructed to notify the State Industrial Accident Commission of the rejection of the benefits of the Compensation Law by the Town of Milwaukie. Upon motion of Councilman Ramsey seconded by Councilman Kelso and carried, it was ordered that the Town of Milwaukie make the same charges as the City of Portland for extending water mains and making connections to water consumers. Upon motion duly made and carried, it was ordered that stop signs be painted in front of the ~~grammar~~ ^{High} school similar to those used in the city of Portland.
