TOWN HALL, MILWAUKIE, OREGON, OCTOBER 14TH. 1924.

The two hundred seventy-first regular meeting of the Council of the Town of Milwaukie was held on the 14th. day of October, 1924.

Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Kerr, Miller, McIntyre and Kleeb, Recorder Mathews and Marshal Keck. The minutes of the two hundred seventieth regular meeting of the Council held on the 9th. day of September, 1924, were read and approved as read. A delegation of the Parent-Teachers' Association was present and called the attention of the Council to the bad condition of the sidewalk between Island Station and Milwaukie. Upon motion duly made and carried, the Mayor and Street Supt. were instructed to have the sidewalk repaired. Upon motion duly made and carried, Ordinance No. 214 was taken up for the second reading. The ordinance being read the roll-call showed the following result: Ayes, Kerr, Miller, McIntyre and Kleeb. Nays, none. Ordinance No. 214 passed the second reading.

Upon motion duly made and carried, further action on the passage of ordinance No. 214 was indefinitely postponed. A petition requesting the Council to install an arc lamp at the upper end of 23rd. Street in Streib's Addition was read and upon motion duly made and carried, an arc lamp was ordered installed where requested. The application of J. A. Keck for an increase in salary was read and taken under advisement.

Upon motion duly made and carried, the following persons were appointed as the budget committee: M. J. Walsh, Thaddeus Stafford, Thomas Walker, G. C. Pelton and W. H. Grasle. Mr. Snyder was present and requested the Council to have the grades established on Lewellyn Street between 40th & 42nd Streets and on 40th. Street from King Street to Harrison Street. J. M. Snyder was granted permission to use blasting powder to blow out some stumps in Lewellyn Street upon the condition that he save the Town harmless from any damage that may result. The Marshal was instructed to charge the lodges the sum of \$4.00 per night for the use of the City Hall. TOWN HALL, MILWAUKIE, OREGON, NOVEMBER 11TH, 1924.

The two hundred seventy-second regular meeting of the Council of the Town of Milwaukie was held on the 11th day of November, 1924.

Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Johnson, Kerr, Miller, Kleeb and McIntyre, Recorder Mathews and Marshal Keck. The minutes of the regular meeting of the Council held on the 14th day of October, 1924, and the minutes of the special meeting of the Council held on the 27th day of October, 1924, were read and approved as read. Upon motion duly made and carried, Denzil Mullan was allowed the sum of \$50.00 per month each month until he is able to work. Upon motion duly made and carried, the Marshal was instructed to have the roof of the City Hall repaired.

The Treasurer's report was read and ordered placed on file. The Recorder was instructed to notify the City Engineer and Mr. Oliver to be present at the Council meeting to be held on the 21st day of November, 1924, to take up the matter of the completion of Harvey Street. Upon motion duly made and carried, Mr. Appleby was appointed Register to register the voters of Milwaukie. Upon motion duly made and carried, the following persons were appointed Judges and Clerks of the election to be held on the 1st day of December, 1924:

Ward No. 1: Judges- A. J. Walker, H. W. Hoesly and Anna Ray; Clerks- Arthur Webster, Jr. and Sadie Lewellyn.

Ward No. 2: Judges-Thaddeus Stafford, W. H. Grasse and William Sanders; Clerks: Myrtle Stanley and Deette Kelso. Upon motion duly made and carried the Recorder was instructed to purchase the necessary election material for the election to be held on the 1st day of December, 1924.

Ordinance No. 217 was read and upon motion duly made and carried, the Marshal was instructed to post the same as required by the City Charter, which ordinance is entitled, "An ordinance establishing the grades of Lewellyn Street from the west line of 42nd Street to the east line of 40th Street." Ordinance No. 218 entitled, "An ordinance establishing the grades of 40th Street from the north line of Harrison Street to the south line of King Street," was read and order posted as required by the City Charter.
