TOWN HALL, MILWAUKIE, OREGON, NOV. 11TH, 1913.

The one hundred fortieth (140) regular meeting of the town Council of the Town of Milwaukie was held on the above named date. Meeting called to Order by Mayor Elmer. Present, Mayor Elmer, councilmen, Mitchell, King, Loeding, Counsell and Albee, Recorder Mathews, Tres. Rolstad and Marshal Reed. The minutes of the one hundred thirty-ninth (139) regular meeting of the town Council held on the 14th day of October, 1913, was read and approved as read. The monthly estimate of the City Engineer of the work done by the Montague-O'Reilly Company on Front Street amounting to \$12,400.75, was read, and upon motion of councilman Mitchell seconded by councilman King and carried, the Recorder was instructed to draw a warrant of Front Street Fund in payment of the same.

The bill of J. W. Morris for engineering services on Front Street, amounting to \$638.09, was read and upon motion duly made and carried the Recorder was instructed to draw a warrant on the Front Street Fund in payment of the same.

The following bills were read and allowed by the Finance Committee, and upon motion of councilman Mitchell seconded by councilman King and carried, the recorder was instructed to draw warrants in payment of the same:

A communication from the Montague-O'Reilly Company requesting an extension of time for the completion of Front Street was read and referred to the Street Committee. Mayor Elmer rearranged the Committees as Follows: Finance Committee: Mitchell, Loeding and King. Street, Public Property, and Public Utilities Committee: Loeding, Mitchell and Counsell. Police, License and Election Committee: Counsell, Mitchell and Albee. Lights, Water and Health Committee: King, Counsell and Mitchell. Fire Dept. and Public Safety Committee: Albee, Counsell and Loeding.

A resolution of the Commercial Club recommending another stop by the P. R. L. & P. Co. of their cars at Front and Washington Streets was read and referred to the Fire and Public Safety Committee. A petition of the property owners on Foster Road for the installation of another arc light was read and referred to the Light Committee. A communication of Mr. Wissinger in regard to the appropriation of the Bonnett heirs land for the widening of Harrison Street was read and referred to the Street Committee.

Upon motion duly made and carried, the 24th day of November, 1913, was the day set for hearing objections, if any there be, to the assessment made for the improvement of Foster Road, and the Recorder was instructed to so notify the property owners along Foster Road to that effect. The matter of purchase Street signs for the Town was taken up and referred to the Street Committee.

Upon Motion of councilman Mitchell seconded by councilman Albee and carried the Mayor and Recorder was instructed to enter into a contract with the P. R. L. & P. Co., in behalf of the town, for lighting for the coming year. Upon motion duly made and carried, the Recorder was instructed to notify the Southern Pacific Co., of the dangerous condition of their railroad crossing in Milwaukie, and also notify them to remove the piling from Front Street.

Upon motion of councilman King seconded by councilman Albee and carried, ordinance No. 96 was taken up for the first reading. The ordinance being read, the roll-call showed the following results: Ayes, Mitchell, King, Loeding, Counsell and Albee. Nays. None. Ordinance No. 96 passed the first reading. Upon motion of councilman Albee seconded by councilman Mitchell and carried, the rules were suspended and ordinance No. 96 was taken up for the second reading and read by title only. The roll-call showed the following results: Ayes, Mitchell, King, Loeding, Counsell and Albee. Nays, none. Ordinance No. 96 passed the second reading.

Upon motion of councilman Mitchell seconded by councilman King and carried, the rules were suspended and ordinance No. 96 was taken up for the third and final reading.

The ordinance being read, the roll-call showed the following results:

Ayes, Mitchell, King, Loeding, Counsell and Albee. Nays, none. Ordinance No. 96 passed the final reading. Upon motion of councilman Mitchell seconded by councilman Albee and carried, the Gas Franchise was taken up for passage. The ordinance being read, upon motion of councilman Loeding seconded by councilman Counsell and carried, the ordinance was referred to the Public Utilities Committee for further consideration, said Committee to make a report on the ordinance at the meeting to be held on the 24th day of Nov. 1913.

Upon motion duly made and carried, Ordinance No. 95 was taken up for the first reading. The ordinance being read the roll-call showed the following results: Ayes, Mitchell, King, Loeding, Counsell and Albee. Nays, none. Ordinance No. 95 passed the first reading. Upon motion of councilman Mitchell seconded by councilman Counsell and carried, the rules were suspended and ordinance No. 95 was taken up for the second reading and read by title only. The roll-call showed the following results: Ayes, Mitchell, King, Loeding, Counsell and Albee. Nays, none. Ordinance No. 95 passed the second reading. Upon motion of councilman Albee seconded by councilman Counsell and carried, the rules were suspended and ordinance No. 95 was taken up for the third and final reading and read by title only. The roll-call showed the following results: Ayes, Mitchell, King, Loeding, Counsell and Albee. Nays, none. Ordinance No. 95 passed the third and final reading.

Upon motion of Councilman King seconded by councilman Albee and carried, \$1000.00 was taken from the Main Street Fund and loaned to the general Fund to pay the outstanding warrants.

Upon motion duly made and carried, the meeting adjourned until the 24th day of November, 1913.

An adjourned meeting of the one hundred fortieth (140) regular meeting of the Town Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Elmer. Present, Mayor Elmer, Councilmen, Mitchell, King, Loeding, Counsell and Albee, Recorder Mathews, and Marshal Reed.

The remonstrance of John R. Kelso and John Miller against the assessment for the improvement of Foster Road was read and referred to the Street Committee.

The bill of the Seba Norton Heirs for damages for the widening of Foster Road was read and referred to the Finance Committee.

The matter of the assessment of Lot 1 block 1 Duerst Add. owned by John R. Kelso was referred to the City Engineer to report upon at the next meeting.

Ordinance No. 97 entitled "An ordinance declaring the assessment for the improvement of Foster Road in the Town of Milwaukie, Clackamas County, Oregon, from the east line of Main Street to the Eastern boundary of said Town, and declaring an emergency, was ordered posted.

The following report of the Public Safety Committee was read and ordered filed:

Milwaukie, Oregon, Nov. 24, 1913.

Mr. Mayor:

With reference to the petition requesting the Portland Railway, Light and Power Co., to stop their trains at front and Washington having been referred to us, The Public Safety Committee, we beg to advise that this Committee would report favorably upon this matter were Washington Street in an improved condition from Main to Front Street but inasmuch as this section of Washington Street is hardly passable we suggest that action be deferred until such time as the street and sidewalks be so improved.

The petition of the property owners on First Street in Minthorn Addition for an Arc Light was read and referred to the Light Committee.

The Light Committee recommended that arc lights be installed on the following streets: One on Foster Road: One on Front Street near the pulp Mill, and one on the south side of Monroe Street and the proposed intersection of Shindler Street. Upon motion of councilman Mitchell seconded by councilman Albee and carried the Recorder was instructed to notify the P. R. L. & P. Co. to install the said lights.

The following resolution was read and upon motion of Councilman Albee seconded by councilman Mitchell and carried, the resolution was adopted as read: RESOLUTION: No. 12 - 1913
