Town Hall, Milwaukie, Oregon, January 7, 1919.

The Two hundred second (202) regular meeting of the Council of the Town of Milwaukie was held on the 7th Day of January, 1919.

The meeting was called to order by Mayor Snyder: Present, Mayor Snyder, councilmen, Grasle, Miller, Frutchey and pates; Recorder Mathews, Treasurer Streib and Marshal Riley. The minutes of the two hundred first regular meeting held on the 3rd day of December, 1918, were read and approved as read. Mr Streib reported that he and the Recorder had demanded the road money due Milwaukie from the County Court; but that the Court refused to turn the money over the Town: The Recorder was instructed to notify the P. R. L. & P. Co. to repair the arc lights in the Town as they are in a bad condition: Upon motion duly made and carried, the Recorder was instructed to request the Pacific Telephone and Telegraph Company to immediately install a telephone in the residence of Mr. Huff.

Upon motion duly made and carried, the Water supt. was instructed to strictly enforce the water rules. Upon motion duly made and carried the Mr. Frutchey was appointed a delegate to represent the Council at the metting to be held in Portland to discuss ways and means for providing work for the returning soldiers. Mr. Grasle reported that he had attended the meeting at Oak Grove relative to action of the Public Service Commission in regard to increasing the Car fare, and that the meeting had decided to raise money by subscription and try to get a rehearing in the matter. The Marshal was instructed to purchase a globe valve and put the same in the hydrant at the mill. Some of the boys from the High School were present and requested to use of the City Hall in which to play Exketxbekk basket ball. Upon motion duly made and carried, the request was denied. The report of the Treasurer was read and ordered placed on file. The application of the Ringler Dancing Academy to conduct dances in the Riverside Park for the year 1919, was read and upon motion duly made and carried, the application was denied. The application of A, H, Dowling for a dance hall license for Riverside Park was read. Moved by councilman Grasle and seconded by councilman Rates that the application be denied. Motion lost. Upon motion duly made and carried, the matter of the application of A. H. Dowling for dance hall license was laid on the table until the Council saw fit to investigate the same.

Upon motion duly made and carried, the recorder was instructed to notify the S. P. Co. to install a drain under its trach on Harrison Street. The following bills were read and allowed by the Finance Committee, and upon motion duly made and carried, the Recorder was instructed to draw warrants on the Treasurer in payment of the same:

Dowling be granted a dance hall's license to conduct dances in the pavilion in Riverside Fark, provided that he boards up the rooms and conducts an orderly place. Motion carried. Ayes, Frutchey, Miller, Hart and Counsell. Nayss, Grasle. Upon motion duly made and carried, the Marshal was instructed to purchase enough lumber to repair the sidewalk on Washington Street and for Street crossing and meter boxes. Upon motion duly made and carried, the council adjourned.
