The roll call being taken the following result was had: Ayes; Dean, Dell, Sanders, Shrock and Walsh. Noes: None. Ordinance Number 337 passed the first reading. It was moved by Shrock and seconded by Dell. that the rules be suspended and that Ordinance Number 337 be taken up for the second time and be read by title only. The roll call on the motion being taken the following result was had: Ayes: Dean, Dell, Sanders, Shrock and Walsh. Noes: None. The roll call on the passage of Ordinance Number 337 on its second reading being taken, the following result was had; Ayes: Dean, Dell, Sanders, Shrock and Walsh. Noes: None. Ordinance Number 337 passed the second reading. It was moved by Shrock and seconded by Dell that the rules be suspended and that Ordinance Number 337 be taken up for the third time and be read by title only. The roll call on the motion showed the following result: Ayes: Dean, ell, Sanders, Shrock and Walsh. Noes: None. The roll call on the passage of Ordinance Number 337 on its third reading being taken the following result was had: Ayes: Dean, Dell, Sanders, Shrock and Walsh. Noes: None. Ordinance Number 337 passed the third and final reading and was declared duly passed.

No further business coming before the meeting upon motion duly made and carried it was adjourned.

Council Chambers Milwaukie, Oregon January 4; 1934.

A special meeting was held on the 4th day of January, 1934, at the call of Wayor Miller and pursuant to the provisions of Section 10 of the Charter of the Town of Milwaukie, for the purpose of canvassing the returns of the special election held on the 2nd day of January, 1934, at which what is known as the "Civic Works Bond Amendment", being an amendment to the Charter of Milwaukie, designated as "Section 22-A", and proposed by initiative petition, was submitted to the voters of Milwaukie for their acceptance or rejection and for taking up such other matters in connection with the Bond Issue as might demand attention.

Councilman Dean moved that the Council go on record that it was opposed to Portland-Oregon City Highway goingthrough Milwaukie on any other route than along Front Street and that Recorder notify the Highway Commission to that effect. It was moved by Dell and seconded by Sanders that the Mayor and Recorder execute the new contract for a water supply tendered by the City of Portland which contract provides for reduced rates and covers a period commencing December 1, 1933 and ending November 30, 1935. Ayes: Dean, Dell, Sanders and Shrock. Noes: None. Motion carried and so ordered.

It was moved by Dean and seconded by Sanders that the Recorder write James Roberts and T. Hirofugi letters thanking them for their kindnesses to CWA workers. Ayes: Dean, Dell, Sanders and Shrock. Noes: None. Motion carried and so ordered.

It was moved by Sanders and seconded by Dell that pending receipt of approval by C.W.A. authorities of the project relative to the construction of a side-walk abutting the Anna Miller property on Harrison Street that the present wooden sidewalk be removed and be replaced by gravel. Ayes: Dean, Dell, Sanders and Shrock. Noes: None. Motion carried and so ordered.

It was moved by Sanders and seconded by Dean that commencing with the date of the commencement of CWA work in Milwaukie and continuing until CWA work in Milwaukie should be terminated that J.F. Elliott receive an additional salary payment of \$30.00 per month and that the Recorder pay such additional salary out of the Water Bund.
