

TOWN HALL MILWAUKIE, OREGON, MARCH 9TH. 1915.

The one hundred fifty-sixth regular meeting of the Town Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, Councilmen, Grasle, Rond, Peery, Counsell and Skulason, Recorder Mathews and Marshal Riley. The minutes of the 155 regular meeting of the Council held on the 9th day of February, 1915, and of the adjourned meetings of the Council held on the 26th day of February and on the 1st day of March, 1915, were read and approved as read.

The light committee reported that they had taken no action in the matter of the installation of new arc lights, whereupon the matter was referred to the light Committee with instructions to make a report before the adjournment of this meeting.

A communication from the Social Service Club of Oakgrove requesting the Council to name a day for a general clean up was read and referred to the Street Committee with instructions to report on the matter at this meeting.

The protest of Mr. Ameele to the assessment against his property was read and upon motion duly made and carried, it was laid on the table. The matter of the complaint of Mrs. Cogswell in regard to the overflowing of her land by Kellogg Lake was referred to the Street Committee. Ordinance No. 124 was read and a copy ordered posted as required by the City Charter.

Upon motion duly made and carried, ordinance No. 127 was laid on the table indefinitely.

The following bills were allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrant in payment of the same:

X Upon motion of councilman Skulason seconded by councilman Counsell and carried, all the arbitration negotiations in regard to the Water Companies prepared by Mr. U'Ren was laid on the table. Upon motion of councilman Rond seconded by councilman Grasle and carried, the Marshal's salary was fixed at \$75.00 per month, the Marshal also to act as Street Commissioner without any additional salary. Upon motion duly made and carried, the Oregon Social Hygienic League was given the use of the City Hall free of charge for the night of March 16th . 1915.

Upon motion duly made and carried, the Council adjourned subject to the call of the mayor.

TOWN HALL MILWAUKIE, OREGON, MARCH 17TH. 1915.

An adjourned meeting of the Town Council was held on the above named date. Present, Mayor Pelton, Councilmen, Grasle, Peery, Skulason, Rond, Recorder Mathews and Marshal Riley.

Upon motion of councilman Skulason seconded by councilman Peery and carried, the Mayor and Recorder was instructed to enter into a contract with the P. R. L. & P Co. on behalf of the Town, for lighting during the year 1915, the Recorder to deliver the contract to the Company if the rates for lighting specified therein are the same as charged Portland.

Upon motion of Councilman Rond seconded by councilman Peery and carried, the Law firm of Clark, Skulason & Clark were retained to defend the Town in the injunctions suit pending against the Town. Upon motion duly made and carried, the Recorder was instructed to notify the P. R. L. & P. Co, to install new arc lights at the following places; One at Scharner's corner on Washington Street: One at the intersection of 32nd and King Streets and one at the intersection of Ruckeye and Harrison's Streets. Upon motion duly made and carried, the matter of the change of arc lights was referred to the Street Committee with full authority to act. Upon motion duly made and carried, Saturday the 3rd of April, 1915 was set as clean up day for Milwaukie, and the Marshal was instructed to cause to be printed and distributed suitable notices to that effect.

Upon motion of councilman Rond seconded by councilman Skulason and carried, the Marshal was instructed to repair th

the Streets in Front of Mr. Reed's and Mr. Warrens.

Upon motion duly made and carried, the Marshal was instructed to notify the Southern Pacific Company to remove the dirt and clean up the Streets over which its trains run.

Upon motion duly made and carried, the meeting adjourned,

TOWN HALL MILWAUKIE, OREGON, MARCH 31st. 1915.

A special meeting of the Town Council was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, Councilmen, Bond, Peery, Counsell, Grasse and Skulason, Recorder Mathews, Treasurer Streib and Marshal Riley. The Mayor stated that the meeting was called for the purpose of considering the initiative petition requesting the Council to call a special election. Upon motion duly made and carried, the Recorder was instructed to notify the P. R. L. & P. Co. to remove the arc light in front of Mrs. Walker's place to the intersection of Henneman and Washington Streets. The Street Committee recommended that the Town put in a dam at the mouth of Kellogg Lake on Front Street on the east side of said Street. Upon motion duly made and carried the recommendation of the Street Committee was adopted and the Marshal was instructed to put the dam in.

Upon motion of Councilman Skulason seconded by councilman Counsell and carried, the Mayor was requested to confer with the County Court personally in regard to improving the Harvey Road.

Upon motion duly made and carried, the Treasurer was instructed to transfer \$1750 from the Front Street Fund to the General fund.

Upon motion of councilman Counsell seconded by councilman Bond and carried, the initiative petitions were referred to the license and election Committee for inspection, the Committee to report upon the same at the next regular meeting of the Council.

Upon motion duly made and carried, the meeting adjourned.
