The three hundred seventy-ninth regular meeting of the Council of the Town of Milwaukie was held on the 9th day of October, 1933. The meeting was called to order by Mayor Miller. Present: Mayor Miller; Councilmen, Dean, Dell, Sanders, Shrock and Walsh; City Marshal Keck and Recorder Adams.

The minutes of the three hundred seventy-eighth regular meeting of the Council of the Town of Milwaukie and minutes of the special meetings of said Council held on the 18th and 27th days of September, 1933 were each read and were each approved as read.

The Council by unanimous vote passed the following resolution:

WHEREAS, Almighty God in His infinite Wisdom has seen fit to take from this earthly life Charles C. Mullan, and

WHEREAS, Charles C. Mullan was an esteemed official and highly respected citizen of the Town of Milwaukie, Oregon, and

WHEREAS, Charles C. Mullan had faithfully and efficiently performed the duties of Fire Chief of the Fire Department of the Town of Milwaukie with great credit to the Town of Milwaukie and to himself, for a period of more than twenty years, and

WHEREAS, the Council of the Town of Milwaukie is greatly appreciative of the excellent and faithful service of Charles C. Mullan to the Town of Milwaukie and of the high type of citizenship which he exemplified, and

WHEREAS, the Council of the Town of Milwaukie regrets that the Supreme Being has seen fit to remove Charles C. Mullan from our midst, now therefore

Be it, and it is hereby, resolved by the Council of the Town of Milwaukie, Oregon, that the appreciation of the Town of Milwaukie, of the efficient and faithful service of Charles C.
