STAFF RECOMMENDATION:

Provide Feedback on the OC 2040 Vision Statement

EXECUTIVE SUMMARY:

Oregon City has spent the past year seeking input from the community about the future of Oregon City. The Comprehensive Plan Update (OC 2040) project has used the robust community input to craft a draft Vision Statement which describes Oregon City in 2040. The Vision Statement will inform the Comprehensive Plan Update through the end of the year.

The City Commission and Planning Commission reviewed the draft Vision Statement prior to public review. Since that time, additional feedback has been gathered and the draft Vision Statement has been altered with assistance from the Project Advisory Team. This is anticipated to be the final opportunity for the City Commission and Planning Commission to review the draft Vision Statement prior to a request for adoption via Resolution.

BACKGROUND:

Since March 2020, the OC2040 Project Advisory Team (PAT) has been working to develop a draft Vision Statement that will guide the City's update of the Comprehensive Plan. The Vision Statement is based on the many outreach efforts conducted over the last year, and is based on two questions:

- What do we love about Oregon City today?
- What do we want to see in the future?

The draft Vision Statement has the following four topic areas:

- Healthy and Welcoming Community
- Diverse Economy
- Connected Infrastructure
- Protected Environment

Staff will provide an overview of the outreach efforts and facilitate a discussion about the Vision Statement so that it is ready for adoption.

Since the City Commission and Planning Commission reviewed the draft Vision Statement at the June 8th joint work session, the city launched the OC2040 Vision Forum, which is live from June 1 through June 21 in which we had 92 participants. The draft statement had a high level of support with 80%-90% of respondents indicating they “loved” or “liked most of” each of the four statements. Request for community participation on the Vision Statement was sent to a variety of groups and advertised on social media. Staff further presented the Vision Statement to the Citizen Involvement Committee (CIC) on June 7.

The purpose of this meeting is to seek final direction on the Vision Statement from the City Commission and Planning Commission prior to a request for adoption by Resolution.

The OC2040 Project Advisory Team will use the Vision Statement as the basis for updating the Comprehensive Plan which is expected through the end of the year. The Legislative adoption process is anticipated in early 2022.

Revising the Vision Statement: What did we hear?

- Change *Healthy Communities* to *Healthy and Welcoming Communities*
- Change *Resilient Economy* to *Diverse Economy*
- Connect positive health outcomes to historically disadvantaged communities
- Emphasize the preservation of Oregon City's small-town feel
- Highlight Oregon City's ability to adapt and innovate over time
- Strengthen the importance of accessibility in transportation



Revising the Vision Statement: PAT Direction

- Ensure statements are aspirational rather than pessimistic, or used to describe current conditions
- Improve readability by moving the last statement of each paragraph to the beginning
- Make “Communities” singular so as to not imply separateness
- Remove specific Tribal names so as to not exclude any
- Elevate the concept of health
- Include the concept of public safety
- Connect tourism to historic and cultural attractions
- Include the concept of maintaining existing infrastructure
- Remove specific references to parks
- Highlight OC’s landscape and topography, emphasizing the rivers
