**Commissioner Gamba** called the meeting to order at 5:15 p.m.

### 1. CALL TO ORDER

### 2. APPROVE OF MINUTES

It was moved by Commissioner Hyzy and seconded by Commissioner Batey to approve the Minutes of the September 1, 2020, Milwaukie Redevelopment Commission (MRC) Meeting. Motion passed with the following vote: Commissioners Falconer, Batey, Nicodemus, Hyzy, and Gamba voting "aye." [5:0]

### 3. REGULAR BUSINESS

### A. MRC Bylaws Change – Resolution

**Aman** explained that the Commission was asked to approve two resolutions: one amending the MRC bylaws by renaming the Citizen Advisory Committee to the Community Advisory Committee (CAC); the second making appointments to the CAC.

**Commissioners Gamba and Falconer** expressed support for the CAC name change.

**Aman** and **Commissioner Hyzy** provided an overview of the CAC recruitment and interview process and noted the membership requirements outlined in the MRC bylaws. It was noted that Commissioner Hyzy would be the CAC's initial chair and that Clackamas Fire District #1 (CFD1) and the North Clackamas Parks and Recreation District (NCPRD) would have ex-officio seats on the committee.

**Commissioner Batey** expressed appreciation for all applicants and the list of nominees.

It was moved by Commissioner Hyzy and seconded by Commissioner Nicodemus to approve the resolution making amendments to the bylaws. Motion passed with the following vote: Commissioners Falconer, Batey, Nicodemus, Hyzy, and Gamba voting "aye." [5:0

**Commissioner Batey** remarked on the importance of burying electricity and utility wires underground in downtown Milwaukie. Commissioners Falconer and Batey and Aman discussed whether the MRC could use urban renewal funds to pay for undergrounding utility wires. It was noted that the CAC would need to weigh-in on any urban renewal funded projects. The group noted the potential benefit for future development projects if the cost of undergrounding utility wires had already been covered.

Commissioner Mark Gamba called the meeting to order at 7:27 p.m.

### 1. CALL TO ORDER

### 2. APPROVE MINUTES

It was moved by Commissioner Batey and seconded by Commissioner Falconer to approve the minutes of the October 1, 2019, and June 16, 2020, MRC meetings. Motion passed with the following vote: Commissioners Falconer, Batey, Parks, Hyzy and Gamba voting "aye." [5:0]

### 3. REGULAR BUSINESS

### A. Citizens Advisory Committee (CAC) Formation – Discussion

**Ms. Aman** provided an overview of the MRC's work since 2016, noting the adoption of an urban renewal plan, commission bylaws, action plan, and budgets. She reported that the actual revenue received to-date from the urban renewal district was less than projected. She explained that the MRC had anticipated this and had adopted budgets that used a lower revenue projection.

**Councilor Batey** noted she had been concerned about the actual revenue received but thought Ms. Aman had explained the financial situation well.

**Councilor Hyzy** and **Ms. Aman** noted that the Coho Point at Kellogg Creek project would receive vertical housing tax credits which would mean the urban renewal district would receive delayed tax revenue in ten years. **Councilor Batey** noted the pending development of the McFarland opportunity site would eventually provide revenue as well.

**Ms. Wicks** discussed the purpose and membership of the CAC and reviewed the recruitment process. She asked if the Commission had any guidance on the recruitment process and which Commissioners would serve as CAC chair and alternate.

**Councilor Batey** asked about the interview process. **Ms. Wicks** explained that interviews would be held via video conference for positions where multiple applicants had applied. The group noted potential groups of people who may be interested in applying for the CAC, including applicants from recent ad hoc committee recruitments, the city manager's Black, Indigenous, and People of Color (BIPOC) interest list, and Northwest Housing Alternatives (NHA) staff and residents.

The group discussed whether CAC members needed to live in city limits. **Ms. Wicks** reported that the MRC bylaws did not include a CAC residency requirement and the group agreed that non-residents could serve on the CAC.

The group noted that staff hoped to begin the recruitment process in October and make appointments by the end of the year.

The Commission discussed who should serve as the Commission liaison and alternate liaison to the CAC. It was noted Commissioners Hyzy and Falconer expressed interest in serving.

It was moved by Commissioner Parks and seconded by Commissioner Batey that Commissioner Hyzy would serve as the Commission's representative to the CAC and Commissioner Falconer were served as the Commission's alternate representative to the CAC. Motion passed with the following vote: Commissioners Falconer, Batey, Parks, Hyzy, and Gamba voting "aye." [5:0]

### 4. INFORMATION

It was noted that there were no additional Commission reports.

### 5. ADJOURNMENT

It was moved by Commissioner Parks and seconded by Commissioner Hyzy to adjourn the MRC. Motion passed with the following vote: Commissioners Falconer, Batey, Parks, Hyzy, and Gamba voting "aye." [5:0]

### Subject: Urban Renewal Community Advisory Committee

### ACTION REQUESTED

The Milwaukie Redevelopment Commission (MRC) is asked to consider a resolution to amend the MRC Bylaws by replacing references to a Citizen's Advisory Committee to a Community Advisory Committee (CAC). The MRC is also asked to consider approving a resolution making appointments to the CAC.

### HISTORY OF PRIOR ACTIONS AND DISCUSSIONS

On <u>October 1, 2019</u>, the MRC received an update on urban renewal and held their first strategic discussion about urban renewal programming.

On <u>September 1, 2020</u>, the MRC received an update on financial resources available in the Urban Renewal Area fund and discussed the recruitment process for the CAC.

### ANALYSIS, BUDGET IMPACTS

The Milwaukie Urban Renewal Plan was adopted by Council in August 2016 and bylaws for the MRC were adopted in February 2017. Since that time, the MRC has convened to adopt the annual budget for the urban renewal agency (URA) and discuss programming.

The CAC is identified in the Urban Renewal Plan as an advisory group that will assist the MRC in decision making regarding plan implementation. In October 2019, the MRC directed staff to work with the CAC to develop a five-year action plan to prioritize and implement projects outlined in the Urban Renewal Plan with the assistance of the CAC).

The bylaws of the MRC outline the following details for the CAC:

- It is appointed by the MRC.
- Its purpose is to advise the MRC in decisions regarding plan implementation.
- It shall adopt its own bylaws which shall be approved by the MRC.
- It will have no more than nine voting members and two non-voting ex-officio members.
- Its members will serve for up to three-year terms.
- Its members will be limited to two terms, except for the initial members.
- The MRC will strive to appoint voting members who represent the following categories:
  - Property owners or business owners from within the URA
  - Residents from within the URA;
  - Persons with extensive knowledge of finance, accounting, or economics;
  - Persons with extensive knowledge of real estate, development, or land planning;
  - Persons with extensive knowledge of affordable housing development or programs;
  - Persons with extensive knowledge of public services, utilties, or infrastructure

### MRC5

- A member of the MRC (a city councilor) this person will serve as the chair; and
- 2 ex-officio members representing special service districts Clackamas Fire District #1 (CFD1) and the North Clackamas Parks and Recreation District (NCPRD).

The city began accepting applications for the CAC in December 2020, and review of applications began on January 22, 2021. Staff promoted the opportunity to serve on this committee via the Pilot, the city website, social media posts, contact with the Downtown Milwaukie Business Association and the North Clackamas Chamber of Commerce, and direct outreach to community members. Staff and MRC members Hyzy and Nicodemus conducted interviews with all applicants. The application process and interviews were scheduled with support from the office of the city recorder

### STAFF RECOMMENDATION

Staff recommends that the MRC approve the resolution amending the MRC bylaws to reflect the renaming of the committee from the Citizen's Advisory Committee to the Community Advisory Committee; and
