1. Convene Regular Meeting and Roll Call

The meeting was called to order at 7:03 PM.

2. Public Comment - None

3. Other Business: Election of Chair

Kelly Reid, Planner, read from the code regarding the election of the Chair.

4. Opportunity for HRB Input on the City Commission Goals and/or Budget

Ms. Reid explained how the City Commission set goals for each biennium that would directly influence the budget. The Commission had asked for input from City Committees on these goals. She explained the recommendations made by the Planning Commission.
