2. Newspaper articles and pictures during this week concerning the activities of the Planning Commission and explaining the THOROUGHFARES report.
3. Displays of City Planning materials in downtown store windows during the week.
4. Public Forum on June 4 in the Library at which time Mr. Baughman will preside and Mr. Lynch, Mr. Bell and Mr. Nims will present the "THOROUGHFARES" report, followed by open discussion.

Mr. Bell recommended that the Planning Commission attempt to interest the State Highway Commission in a project to beautify the rights of way along the river. The group agreed on the importance of this work and asked Mr. Nims to prepare a map showing the areas needing beautification.
