1. Minutes of the June 30, 2020 Regular Meeting

Troy Bolinger moved to approve the minutes; Shawn Dachtler seconded All in Favor: Troy Bolinger; Derick Cougle; Alicia Hammock; Shawn Dachtler; Andy Crump; Brent Haverkamp; Doug Neeley; Karin Morey

Motion passed unanimously.

2. Minutes of the July 30, 2020 Regular Meeting

Doug Neeley moved to approve the minutes; Shawn Dachtler seconded All in Favor: Troy Bolinger; Derick Cougle; Alicia Hammock; Shawn Dachtler; Andy Crump; Brent Haverkamp; Doug Neeley; Karin Morey

All opposed: none

Motion passed unanimously.

PUBLIC COMMENT

There were no citizen comments.

Ms. Morey confirmed with Cameron McCredie and Jesse Buss that they wished to speak under item #5, Upper Yard Charter Park Designation, rather than in Public Comments.

PRESENTATIONS

GENERAL BUSINESS 3. Oregon City Oregon Film Trail Site

Matthew Weintraub, Tourism Program Specialist with the Economic Development Department thanked the PRAC members for their service, then went through the Oregon City Film Trail Signage presentation. To help promote tourism in Oregon City, Mr. Weintraub was asking for PRAC's support in placing two sign panels on the McLoughlin Promenade highlighting key movies and TV shows that were filmed in Oregon City. No funding from the Parks Department would be needed. The location of the signage is yet to be determined, but a light pole or the flagpole are being considered, rather than digging down into the basalt cliffside. Mr. Dachtler pointed out that it is against national flag etiquette to place a sign on or near a flagpole and he recommended against doing that. Mr. Bolinger noted that Mr. Dachtler was correct and liked the idea of the sign having its own post. More questions were asked and answered pertaining to the ability to add more information and a plan to repair vandalized signs. Ms. Morey gave a Statement of Contact that she had taken part in the Tourism Group and had created a website listing everything that has been filmed in Oregon City. She asked if members felt that she should recuse herself from the vote. Mr. Bolinger noted that he thought if this were a more serious matter that they would ask Ms. Morey to recuse herself, although he felt that it wouldn't matter in this situation. Ms. Morey asked for a vote to approve the concept of the signage and to have Mr. Weintraub return when the location had been determined. Doug Neeley so moved, Andy Crump seconded.

Motion passed unanimously.

Mr. Weintraub thanked the committee for the vote of confidence and stated that he would work with Kendall Reid and Staff to determine a location and would come back.

4. Additional Permitting and Notification Draft Policy for City Tree Removal Laura Terway, Community Development Director, presented the Additional Permitting and Notification Draft Policy for City Tree Removal. Ms. Terway discussed the new draft policy that includes an internal review process, considers alternatives to tree removal and defines the public notification process that would apply when the City wants to remove a significant tree that is either on City or Urban Renewal property or within the right-of-way. The policy would require, in some circumstances, a report from a certified arborist with analysis and alternatives, including the cost. Ms. Terway noted that an additional requirement in this policy is to establish an annual budget with dedicated funding to make alternatives to tree removal feasible. Jonathan Waverly, Parks Manager, stated that he thinks they need funding, particularly for the cost of the arborist reports. If the funding is in place, Mr. Waverly is ok with the policy. Mr. Reid noted that he had discussed with Staff to ensure they have the resources. Knowing that they will sometimes need to make unpopular decisions to remove trees (ADA issues, trip hazards, diseased trees), Mr. Reid thought it was good that the City Manager could make the decision to move forward. Kathy Wiseman commented that it is important to look at what the site is being used for as part of the assessment process. Mr. Neeley agreed with Mr. Waverly about funding, not wanting P&R budget reduced to support this policy, and he hoped the City Commission would identify additional money and consider possibly putting an arborist on staff if the need arose. Mr. Haverkamp and Mr. Bolinger also noted their concerns about funding. When asked where the money would come from, Ms. Terway responded that she felt it was reasonable to allocate \$30,000 per department in new revenue for arborist reports and alternative implementation. Doug Neeley moved to support of the draft policy as proposed; Alicia Hammock seconded. Mr. Bolinger asked if the motion included the funding. Doug Neeley modified the motion to include \$30,000 per department in funding; Alicia Hammock seconded. All in favor: Derick Cougle; Alicia Hammock; Andy Crump; Doug Neeley; Karin Morey

All opposed: Troy Bolinger; Shawn Dachtler; Brent Haverkamp;

The motion passed with 5 Yes votes and 3 No votes.

During the voting process, Mr. Haverkamp asked Ms. Terway to confirm the total amount of funding. Ms. Terway replied that it would be \$30,000 for Parks and \$30,000 for Public Works.

After the vote, Ms. Terway stated that she would communicate the concerns about funding and about too much process and response. Mr. Neeley pointed out that Ms. Wiseman's concerns should be noted too. Ms. Terway agreed and summarized that this policy provides a process; it is not meant to stop tree removal, just explain why.

5. Upper Yard Charter Park Designation Update

Cameron McCredie, as a representative from the McLoughlin Neighborhood Association, requested 5 minutes to show a video; Lower Water Board Park Video Testimony. Ms. Morey agreed. The video, showcasing the history of the land and citizen comments of support, was played for the members. Jesse Buss, Oregon City resident, stated his support of giving Charter Park protection to the Upper Yard. Mr. Buss commented that this issue, which has extensive community support, has been discussed many times in various committees, including a vote of support by PRAC in 2018. Mr. Buss noted that although it has taken awhile, the discussion has moved onto the City Commission and he felt that the time has passed for PRAC to weigh in. Jim Nicita, resident of Oregon City and amateur historian, stated his view that the Camp Adair buildings should be viewed as treasures deserving of a fair and involved disposition process with the City offering support to whomever acquires them. Mr. Reid noted that Staff's main concerns are wanting to do what is best for the community and to make sure the land is not turned over to Parks in disarray to be remediated with resources they don't have. Ms. Morey gave a Statement of Chair, then recused herself from the vote; noting that there is no verifiable proof that the Upper Yard was ever part of the park. Ms. Morey doesn't understand the hurry and has serious concerns with the Parks Department taking on the expense of making the property park ready. Mr. Haverkamp asked for clarification on what is a Charter Park. Mr. Reid noted that making any major changes to a Charter Park will require a community vote. Ms. Terway added that the modifications don't have to be related to park use. Discussion followed with Mr. Cougle and Mr. Neeley expressing their support for the designation. Other members, including Mr. Dachtler, Ms. Hammock and Mr. Bolinger, shared their concerns with getting locked into the limitations of the Charter Park designation, the budgetary concerns and many questioned the need for urgency. Troy Bolinger made a motion that PRAC does not support making the Upper Yard a Charter Park at this time: Shawn Dachtler seconded.

The motion passed with 5 Yes votes, 2 No votes and 1 Abstain.

Ms. Morey stated that this would be brought to the City Commission and they will see what the future brings.

MEMBER REPORTS

Ms. Morey:

Reported that she has an abundance of the blue can/bottle recycling bags that support the Oregon City Parks Foundation. If anyone would like some, they may contact her. Mr. Neeley and Mr. Haverkamp expressed interest. She noted that the Oregon City cemetery received a grant for a new computer system that will provide better information on the cemetery. She also thanked Staff for providing Parks information and continuing to engage the community during this time. No other members provided reports.

STAFF REPORTS

Rochelle Anderholm-Parsch, Aquatics and Recreation Manager, provided information on the upcoming Drive-In Movies events on September 11, 12 and 19; pre-registration is required and all OHA guidelines will be followed. The Ermatinger House will be reopening for tours on September 5; pre-registration is required. A survey was put out to gather information community childcare needs.

Kathy Wiseman, Senior Center Supervisor, thanked the PRAC members for volunteering to serve on this very important board. All volunteer efforts at this time are much appreciated and keeps the community going.

Mr. Reid thanked Denise Conrad for being a rock star and gave kudos for her hard work on the two current construction projects at Tyrone S. Woods and D.C. Latourette Parks.

SUBJECT:

Expansion of 6th Street Library Book Return

STAFF RECOMMENDATION:

Support the expansion of the 6th Street library book return.

EXECUTIVE SUMMARY:

In order to address capacity issues exacerbated by the COVID-19 pandemic, the Library has purchased an additional book return unit. The Library Director will review the desired permanent placement of the new book return with PRAC and answer any questions committee members may have.

BACKGROUND:

The COVID-19 pandemic has impacted every aspect of City service, including the Library. While the Library building remains closed to the public, staff are working to provide as many services as possible, either virtually or thorough alternative "no-contact" methods.

In June, the library restored circulation services, allowing patrons to make appointments for no-contact holds pickups outside the building, and to return borrowed materials in our outside book returns (of which, the 6th street book drop is the most heavily-used).

Even in normal times, the 6th street book drop was undersized for the amount of materials the library circulates, and staff were required to empty the return at frequent intervals (usually hourly) throughout the day. In addition, staff were generally required to come in over holiday weekends simply to empty the return to prevent overflow.

The COVID-19 pandemic has only exacerbated these capacity issues. With the need to quarantine materials for 6 days, and the need to significantly adjust circulation staffing to ensure adequate physical distancing and continuity of operations, the expanded book return provides much-needed additional capacity and secured storage space. The

expanded book return has also allowed the library and has allowed us to keep the book drops open 24 hours/day, 7 days/week.



Figure 1 - Expanded 6th Street book return

Prior to ordering the additional book return, library staff measured to ensure that sufficient clearance remained between the expanded book return and planter box to permit unimpeded access. Library staff also confirmed with City staff that no building permits, land use applications, or historic review process was required. In addition, based on feedback from our City Attorney, as an addition or alteration to an already-existing structure, this project is exempt from the City Charter prohibition against new, non-recreational structures on park property without a public vote.

We were not able to formally update the Parks and Recreation Advisory Committee prior to the book return's delivery, however, we have endeavored to make sure the Parks and Recreation Director has been kept up to date on our plans and latest developments. The Library Board expressed support for the expanded book return at their August meeting.

Parks and Recreation Advisory Committee: Heritage Stand Nomination for Park Place Park

STAFF RECOMMENDATION:

Staff recommends that the PRAC consider revising the Heritage Stand designation to only include trees that are in good condition, safely accessible and visible to park visitors.

EXECUTIVE SUMMARY:

Planning and Parks staff are recommending a revised proposal to move forward with nomination of some of the trees in Park Place Park and propose that the others would not be nominated due to various issues. In addition, we wanted to recognize that the trees which staff were not proposing to move forward on (such as those surrounded by poison oak) would be protected under the draft policy which includes elevated levels of investigation of alternatives to removal and approval for public trees which qualify.

BACKGROUND:

PRAC reviewed the original recommendation on February 27, 2020. The Park Place nomination includes 27 trees, consisting of 19 Oregon White Oaks, 2 Douglas Firs, and 6 Atlas Cedars. PRAC recommended that the nomination be approved for all trees that are not in a state of decline. Additional information about tree conditions, and the development of the new tree removal and notification policy for trees on city-owned land necessitate a revised recommendation.

Any tree removal on or abutting city-owned land is subject to a Type I Site Plan and Design Review process for tree removal. This permit requires a detailed examination of the tree condition prior to removal and require mitigation pursuant to OCMC 17.41.

In addition, the City Commission is considering the Additional Permitting and Notification Process for City Tree Removal. This policy applies to City removal of trees:

- On City or Urban Renewal owned property; or
- Within the right-of-way.

The purpose of this policy is to reduce unnecessary tree removal by the City and provide public notification of such removal.

The codes, permitting requirements and policy provide sufficient protections and public notification for trees on park property. Heritage tree designation does not provide any further protection for trees that is not already embodied in the current code and draft policy.

Furthermore, several of the trees in the Park Place Park nomination are in areas that:

- Are in areas of poison oak
- Within the Geologic Hazard Overlay District, which further regulates tree removal
- Are not publicly accessible or visible.

Parks staff are responsible for managing trees to assure public safety with an extremely limited budget, and it is imperative that they be able to do their jobs without subjecting tree removal to politicized and discretionary processes. The existing code and proposed policy assure an objective and reasonable standard that assures professional and expert consideration of alternatives to tree removal and notification by the public.

For these reasons, staff is recommending that PRAC consider revising the proposed nomination.

"Heritage stand" means a group of two or more trees that have been designated by the city as having unique importance, subject to the heritage tree regulations of OCMC 12.32.

"Heritage tree" means a tree that has been designated by the city as having unique importance, and subject to the heritage tree regulations of OCMC 12.32. Where a grouping of two or more heritage trees has been so designated, the term "heritage stand" may be used.

OCMC 12.32.040.A. Nominations for trees or tree stands on city-owned property, other than right-of-way, may be submitted by any citizen of Oregon City and the City Commission shall make the final decision following the general procedure identified in subsection 12.32.030 above. If the nomination is for a city park, the Parks and Recreation Advisory Committee shall also review the nomination and provide an advisory opinion prior to the Natural Resources Committee recommendation to the City Commission.
To be nominated as a heritage tree or stand, trees must meet the requirements in OCMC 12.32 (Attached). The criteria are:

- A. Heritage criteria (at least one heritage criterion must be met):
 - 1. The tree or stand of trees is associated with events that have made a significant contribution to the broad pattern of Oregon City's history; or
 - 2. The tree or stand of trees is associated with the life of a person or group of historic significance to Oregon City; or
 - 3. The tree or stand of trees represents a significant and distinguishable presence within Oregon City; or
 - The tree or stand of trees has age, size, or species significance (horticultural or ecological), which contributes to Oregon City's heritage status;
- B. Site and Condition Criteria (all criteria must be satisfied):

Purpose

♦ 12.32.010 - Purpose.

A. The purpose of this chapter is to recognize, foster appreciation and provide for voluntary protection of certain trees, because their age, species, natural resource value, ecological or horticultural value, or historical association, are of special importance to the city. These trees may grow on private or public property.

Definitions

- Iteritage stand" means a group of two or more trees that have been designated by the city as having unique importance, subject to the heritage tree regulations of OCMC 12.32.
- * "Heritage grove" (or stand) means is at least two heritage trees separated by no more than twenty feet on a property or properties.
- * "Heritage tree" means a tree that has been designated by the city as having unique importance, and subject to the heritage tree regulations of OCMC 12.32. Where a grouping of two or more heritage trees has been so designated, the term "heritage stand" may be used.

Criteria for designation (OCMC 12.32.070)

The City Commission may designate a tree or stand of trees as a heritage tree or heritage stand if the commission determines that the tree or stand of trees is consistent with a positive balance of the factors set forth below.

A. Heritage criteria (at least one heritage criterion must be met):

- 1. The tree or stand of trees is associated with events that have made a significant contribution to the broad pattern of Oregon City's history; or
- 2. The tree or stand of trees is associated with the life of a person or group of historic significance to Oregon City; or
- 3. The tree or stand of trees represents a significant and distinguishable presence within Oregon City; or
- 4. The tree or stand of trees has age, size, or species significance (horticultural or ecological), which contributes to Oregon City's heritage status.

Site and Condition Criteria

B. Site and Condition Criteria (all criteria must be satisfied):

- 1. The tree species is not listed as invasive on any regionally accepted plant list;
- 2. If the proposed heritage tree or stand is located on private property or on public property owned by a public agency other than the city of Oregon City, the property owner or, if the tree or stand of trees is located on a public right-of-way, the abutting private property owner consents to the designation and agrees to sign a protective covenant.

Designation

For designation of heritage trees and stands on city parks and other city owned property, the designation shall be complete upon the City Commission's approval of the nomination and any documents determined by the commission to be legally necessary to ensure the preservation of the heritage tree or stand of trees, whether this be in the form of a restrictive covenant, or other instrument or agreement applicable to the specific site.

Protection

- City Manager has authority to allow removal of trees if "the burden imposed on the city by the continued presence of the tree, outweighs the public benefit provided by the tree." (OCMC 12.32.080)
- The following activities are considered "reasonable burdens":
- 1. View obstruction;
- 2. Routine pruning, leaf raking and other maintenance activities; and
- 3. Infrastructure impacts or tree hazards that can be controlled or avoided by appropriate pruning or maintenance.

DISCUSSION LEADER TIPS

General Principles

As the presenter and discussion leader, your role is to help create an open and shared environment so that all participants have the opportunity for discussion. Please follow the agenda closely as you have only limited time. "Prompts" are shown in the italicized print below. It is OK if people disagree! There is no need for consensus or agreement.

General Guidelines

- Stick to the agenda and move the conversation forward.
- If a point is made that is off-topic, write it down, then guide the discussion back to the question at hand.
- Encourage everyone to participate but do not allow anyone to dominate.
- Keep the discussion moving by summarizing and synthesizing.
- Resist the temptation to voice your own opinions or to be the "expert" on the subject.
- Start and end each meeting on time.
- Have fun!

Specific Guidelines

- Emphasize that there are no "right" or "wrong" answers. Everyone's opinion is valid.
- Give credence to differences, but do not dwell on them. It's important that we have an open discussion. There are no right or wrong answers.
- Do not hesitate to say you do not know the answers to a specific question. Make note of the question and ask the individual to see you later.
- Follow the meeting flow. That's a good question/idea/issue, I'll write it down to make sure we don't forget that point.
- Move the group along politely but firmly. I see we have only a few minutes left and we have more discussion questions to cover or Thank you for your suggestion.
- Make sure each participant has a chance to speak. Who else has something to add?
- Summarize the discussion as you go along, validating it with participants. Have I captured all key points?
- Five minutes before the discussion ends, summarize the discussion. Ask participants for any final thoughts. *Is there anything we have missed?*
