

# **ACTION REQUESTED**

The Milwaukie Redevelopment Commission (MRC) is asked to adopt a resolution appointing a new member to the MRC Community Advisory Committee (MRCCAC).

## HISTORY OF PRIOR ACTIONS AND DISCUSSIONS

November 8, 2022: City Council elections were held which resulted in the previous Council liaison to the MRCCAC not being re-elected. At the same election Rebecca Stavenjord was elected to Council.

February 21, 2023: Council finalized its committee assignments for 2023.

## ANALYSIS

As outlined in the Milwaukie Urban Renewal Plan and the MRC Bylaws, the Commission has the authority to appoint eligible and qualified individuals to the MRCCAC. As a vacancy exists due to a committee member's elected term ending and as City Council has selected a new Council liaison to the MRCCAC, a resolution has been prepared for the MRC to confirm the appointment of a Council liaison to the MRCCAC.

If appointed, the nominated individual would serve until the City Council nominated a different Council member to serve as liaison or until the nominated individual resigns. The individual would be eligible for reappointment to the committee for additional terms.

Councilor Rebecca Stavenjord has been nominated to serve as Council liaison to the MRCCAC.
