# Carnegie Center Strategic Plan

# Vision

The Carnegie Center will provide a high quality, open, available and fiscally responsible art gallery, café, and learning space that offers an enriching experience to the community while respecting its cultural heritage.

# **History and Background**

The Oregon City Carnegie Center was built in 1912 as a public library, funded in part by a grant from the Carnegie Foundation. This building was in continuous use as a library until 1995, and is now operated by Oregon City Parks and Recreation primarily as an art gallery, complete with a coffee shop and children's museum. It is also the site for the summer concerts in the park series and many recreational and cultural classes, events and programs.

The Carnegie Center is located in the Historic McLoughlin neighborhood, within walking distance of many of Oregon City's historic landmarks. The Carnegie Center is surrounded by Library Park on land donated to the City of Oregon City by Dr. John McLoughlin, one of the state's founders.

In 2001, the Carnegie underwent a major renovation. The yearlong project restored the building's original façade as well as updated the building to current safety, ADA and construction standards.

The Carnegie Center Art Gallery displays and sells the work of local artists. Artwork is displayed in the main floor gallery space. Exhibits change monthly and feature a variety of original paintings, ceramics, fiber art, wood and glass, as well as group and theme shows.

The Carnegie Center Focus Group began meeting in February 2003 to develop recommendations for the Center's use and operations. This plan represents those recommendations.

# **Building Use Recommendations**

The Carnegie Center should remain in City ownership and continue to be used as a cultural arts center. The building and most of its current use are enriching to the community and represent a very important piece of Oregon City's cultural heritage which must remain available to the entire

community. The Carnegie Center should hold extensive "open" hours and be available for rentals, community events and meetings. In addition, the Center should continue to offer the following functions and programs:

#### Art Gallery

The gallery is the "Heart and Soul" of the Center and should display and sell a wide variety of art, crafts and exhibits. The community should consider the Center a destination for quality art, entertainment and refreshment. The Center's atmosphere should be friendly and instructive. Gallery shows should continue to be varied and represent the work of local artists. The Center should create a strong retail sales base. Because of its position as the hub of fine arts in Oregon City, the Carnegie Center can also function as a clearinghouse of information related to local art and artists.

#### **Coffee Shop**

The coffee shop is an attractive compliment to the environment of the Center. The coffee shop encourages guests to increase the length and frequency of their visits. The shop provides a quiet area that can be utilized for reading, meeting with small groups or just relaxing. Different mechanisms of operating the coffee shop should be explored. The ability of Center staff to manage the operations of the gallery and coffee shop simultaneously is limited.

#### Summer Concerts in the Park

The summer "Concerts in the Park" series is a popular program that has been offered at the Center for ten years. The concerts draw an average 900 people each Thursday evening to the grounds of the Center. Many of these attendees visit the Center for the first time, and of these, many become regular users. Sales of artwork are very high during the concerts, as well.

#### Saturday Night Java

Saturday Night Java brings small local musical performances into the Carnegie Center once or twice per month. It offers visitors a relaxing atmosphere, good music and coffee drinks all for a modest admission charge.

#### Art and Other Cultural Classes

The Carnegie Center should continue to offer art and cultural classes such as polymer clay, watercolor, colored pencil art, beading and music. These classes, key to the operation of the Center, have become more popular recently and should expand as demand and classroom availability grows. Classes should be expanded to also take place in existing facilities that have available space.

### **Action Items**

#### 1. Children's Museum

The Children's Museum should be relocated to another facility as soon as an appropriate replacement site is located. The operation of the Children's museum is not consistent with the fine arts environment that the Center represents. In addition,

the 2001 remodel of the Carnegie Center reduced the amount of space available for the Children's Museum, causing its attendance to decrease. There is no possibility for growth or expansion in the Carnegie Center's basement. This space would be better utilized to conduct art classes. The Children's Museum might be more appropriately sited along with a children's library.

Classes to be offered in this space could include, among other things, painting, weaving, photography, polymer clay and sculpturing. As scheduling permits, it could also be rented in time blocks for artist studio space and to other groups. It is believed that art classes are in demand by the community and would probably yield much greater revenue than the Children's Museum currently does. Another possibility would be to offer "craft parties" where people could schedule the space and an instructor. To accommodate these classes and activities, minor remodeling to the downstairs area would be necessary. If feasible, a moveable wall should be installed to divide the area into two separate classroom spaces. Once regular classes are established, the Center's hours of operation should be expanded to include many evenings each week. Regular evening hours will make the Center available to new potential users

#### 2. Friends Group/ Marketing

A "Friends" group should be created and incorporated as a 501(c)3 to advocate for the Center and its programs. The friends group would be responsible for

- Fundraising
- Assisting with special events such as teas and festivals
- Advocating for the Center
- Coordinate events, functions and programs with the Oregon City Arts Commission and other community arts/ cultural groups
- Providing publicity and marketing for the Center and its programs

A marketing strategy must be developed by the friends group and City staff to assist with the planning and continued success of the Carnegie program. This plan should explore which activities are the most in demand and identify strategies for enabling these programs to flourish. Partnerships with organizations, such as the Clackamas Community College, the Oregon City School District and Marylhurst University should be developed for the mutual benefit of each.

The friends group would have a membership program and an associated dues structure. Members of the friends group would be entitled to benefits of membership, including discounts on art purchases. A portion of the membership dues could be negotiated to be paid to the Center to compensate for the discount on art purchases.

A member of the friends group should serve on the Parks and Recreation Advisory Committee just as a representative of the Pioneer Center sits on the Committee.

# POLICY TITLE: Use of property purchased with Park Systems Development Fees

#### EXPLAINATION:

Park Systems Development Fees (Park SDCs) are fees assessed to new development to cover their fair share of the cost of improvements and additions to Parks and Recreation facilities that are required to accommodate the needs of such growth. SDCs can only be used for capital improvements based on a jurisdiction's Capital Improvement Plan.

These fees are collected in Oregon City by the Planning Department at the time they issue a building permit for new construction or development.

Oregon City Park SDCs are currently collected on Single-Family, Multi-Family and Manufactured Housing as well as on non-residential development based on a per estimated employee calculation based on the type of non-residential facility at the time of construction. Park SDCs are not deposited into one dedicated account within the City's construction fund and are not designated for use in any one sub division or area of the City.

Under ORS 223,208-223.314 SDC can only be spent only on capacity increasing capital improvements in accordance with a City adopted Capitol Improvement Plan (CIP). The Park and Recreation Master Plan (1999) along with the City's CIP has designated areas of the City which are park deficient and specific projects which add capacity to the existing system as required by new construction.

Example: If the City were to construct a Community Center and Pool, only a portion of this project could be funded with SDCs because over half of the project would be serving the needs of the existing residents.

Park property is often purchased with Park SDCs and "land banked" for future development. This may occur when the SDC fund does not have the resources necessary to make the purchase and then plan and construct with available funds or it may occur when property is identified within the Urban Growth Boundary and purchased before housing development creates the demand for development.

POLICY: Property purchased with Park SDCs must be purchased for park, recreation or open-space use. Property, purchased with SDCs, but not designated as a Park under the Chapter X of the City Charter may only be sold under the following circumstances:

• Another piece of property, which is a great value to the system, is purchased in the same area of the City as a replacement.

• The property, or a portion thereof, becomes surplus due to development of roads or other public right-of-way improvements. Example: corner of the park property becomes separated from the main park property to allow for a road connection.

• Through surrounding development or natural causes, the property becomes unusable for the park classification for which it was intended. Example: earthquake causes a rockslide reducing the usable property for development as a sports center.

Revenues from the sale of property purchased with SDC funds shall be deposited in the same Park SDC account as if they were coming from new development.
