OREGON CITY PARKS & RECREATION Activity Report

Monthly Parks & Recreation Report October 2004

O.C. Pool/Aquatics

- Our annual *Swamp Swim* special event was very successful with 193 participants. 84 of the attendees participated in the costume contest.
- The competitive swim season will begin in November with teams from Oregon City and Gladstone high schools, St. John's Middle School and the year-round club
- The O.C. Pool is also playing host to a new Oregon City/ West Linn water polo team
- We have implemented a recycling program through a cooperative program with Clackamas County Waste Reduction

Carnegie Center

- New items are on display for holiday shoppers
- Ermatinger Tours and Teas are picking up for the holidays
- "Spirits of Oregon City" event brought in over 300 attendees this year
- The gallery has seen strong attendance on Saturday and Sunday afternoons

Pioneer Center

- A new 12-passenger van has been ordered to replace our 1992 van
- Our annual transportation audit was conducted by Ride Connection
- We offered 2 trips this month Spirit Mountain, Rasmussen Farm; both were attended at full capacity
- Monday dine-outs averaged 15 18 people
- Rose Linn seniors went on a trip to the pumpkin patch
- Julie attended the weekly Chamber of Commerce meetings in support of the Center
- Glen Tadina's Band continues to play old time swing dance songs every Wednesday with about 80-90 people in attendance
- Glen Tadina's Band has agreed to donate a dance to the center in February

- An average of 15 West Linn seniors went on two dine outs and one potluck this month
- Donations: \$115 for the pioneer donation fund, and \$10 for meals on wheels
- Staff attended the West Linn Seniors potluck
- We received \$716 in donations toward the new van this month
- A grant application for the van was submitted to the Collins foundation
- A meeting with the local business community lead to the planning a bingo fundraiser for the van
- Our wreath sale continues in support of the van replacement fund; our goal is 100 sold
- The Center's lobby area was reorganized to make a better presentation to groups interested in renting the Center
- We are busy improving our efforts to market the Center for wedding receptions
- Staff participated in the "Spirits of Oregon City " by providing transportation utilizing all three of our vans
- Minor building maintenance is now completed two days per month
- The Center was closed a few days this month for cleaning and maintenance

- Teen Scene attendance is averaging over 200 again now that school has begun
- Our brand new Scottish Single Stick classes are already very popular, with about 30 people between the Monday and Wednesday evening sessions

- 200 spring bulbs planted

PRAC members -

An update on this situation. Since originally sending my earlier message regarding the 11/29 PRAC meeting, I have found out that the Commission Study session that evening has become very full. While there is no way to know for sure how long it will last (they begin at 5:30PM and typically last a couple of hours), it sounds like this meeting has the potential to go longer than usual. I will need to stay through the entire meeting. We could push the start time of the PRAC meeting to 8:00PM, but potentially I may not be able to join you until even later than this dependent upon the Commission meeting ending. The other issue as discussed last meeting, is that PRAC desired to have the City Manager attend this meeting to address the Blue Ribbon Task Force recommendations and city funding strategy status. Obviously, this may be difficult to accomplish as well since he (Larry Patterson) will also be involved in the Commission study session.

The other option is to pick a different night the week of 11/29 to hold the meeting - my only option open that week is Thursday; or postpone your meeting for one week further and meet on Monday, December 6. I am willing to do either of these or work out another solution. Please reply to all with your thoughts in the next couple of days, so we get a sense of what works best. I'll confirm the meeting date/time once we work this out.

Sorry this has become a challenge to pin down - I don't normally have this conflict on your regular meeting nights, and only do this time since we decided to hold your November leeting a week later. Thanks for your patience.
