#### Regular Meeting

- 1. Call to order: Vice-chair Shawn Dachtler called the meeting to order at 7:05 PM. Ted Schumaker arrived a few minutes later and assumed the Chair duties for the remainder of the meeting.
- 2. Approval of minutes April 28, 2008 regular meeting: Approved with one minor change to section 4.a.
- 3. Citizen comments on issues and items not on the agenda: None
- 4. General business:

a. <u>Parks & Recreation Master Plan Update – final report adoption</u>: The City Commission adopted the final plan on June 4<sup>th</sup>. Final copies are being prepared and will be distributed to PRAC members at the next meeting.

#### b. PRAC 2008 goal setting:

The final 2008-09 PRAC goals were distributed and discussed. PRAC members requested this be an ongoing agenda item to review and update progress.

#### c. Parks property search:

Scott Archer provided an update on the High School area park property search. As reported at the last meeting, a willing seller has offered another property around 9.5 acres, in the Glen Oak Road area. Staff is continuing to pursue this for potential acquisition.

#### d. PRAC by-laws amendment:

At their June 18 meeting, the City Commission approved the PRAC recommended by-laws change. Revised by-laws copies were distributed to members.

h. Other general business:

1. Scott Archer provided an update regarding the previously discussed Singer Creek Park proposed sewer line issue. The Engineering Division is continuing

to work with the property owners who made the proposal. The next required step would be the formation of a Local Improvement District. PRAC members questioned why this would need to go to a vote of the citizens to be approved. Staff explained that this was confirmed by our City Attorney's office. It has to do with the city charter, requiring that a "non-park" use must be presented to the voters for approval.

2. Scott Archer provided follow-up to Shawn Dachtler's e-mail asking for an update on the dog-waste mitt dispensers in the parks. These have been installed in a few of our parks, and to date they have been working well. Staff intends to continue adding these to several more of our parks, a few at a time over the next few years as time and budget permits. The most expensive part of these is the cost of keeping the bags (mitts) stocked.

3. Ted Schumaker asked what happened to Phil Yate's proposal from a while back regarding door hangers to fundraise for parks. Scott Archer indicated that the way it was left was that Mr. Yates was to continue to refine his idea and follow-up with the department. Staff has not heard anything further from Mr. Yates about his proposal at this time.

- 6. Director's report:

- a. Project updates were provided on the following:
  - Jon Storm Park/Willamette Trail the groundbreaking ceremony was held earlier today. It was a well-attended, successful event. The project is well under way at this point.
  - Debris Boom project has been advertised for bids; bid opening will occur soon.
  - 3. Sportcraft boat ramp improvements staff are working through an extensive permitting process to move the project forward.
  - 4. Wesley Lynn improvements (OCHS const. class) the first phase of this project is now complete. Restoration of the grounds adjacent to the pathway are under way.
  - 5. Parker Knoll Development (Wesley Lynn Park) this is still moving forward.
- b. Recreation Services reports were provided about the following:
  - 1. Pool diving blocks removal issue. More about this will be covered at a planned tour of the pool facility.
  - 2. Carnegie Spray Park needs to be upgraded. Staff is looking at some ways to upgrade/modify the existing system to add better features and improve the concrete pad area, while still being sensitive to the historic issues in the park. McLoughlin Neighborhood Association input will be sought. A sub-committee may be formed to help make decisions about the design.
  - Pioneer Center improvements have been made. Meals on wheels program – fuel costs are becoming an issue for volunteers; staff is working on a program to offset some of these costs for volunteers.
- c. Parks maintenance update

d. Belle of the Falls status – the tour boat has been sold to an out of state operator and will no longer run in Oregon City.

e. Oregon City Youth Sports was formally recognized for the Chapin Snack Shack at the June 18 City Commission meeting.

f. A letter dated May 21 from Jim Desmond, Metro Parks & Greenspaces Director, to Canemah neighbors and interested parties was distributed to PRAC.

The letter addressed issues that arose recently regarding the Canemah Metro property (near our Canemah Neighborhood Park).

## Description

## **History**

The Oregon City Recreation Advisory Committee was created by the City Commission on November 3, 1983 with nine members; by-laws were adopted on October 11, 1984; by-laws were amended June 12, 1986 by Resolution No.86-25; by-laws were amended and the name changed to Park and Recreation Advisory Committee on September 2, 1992; by-laws were amended on November 3, 1999; by-laws were amended June 2000.

## **Mission - Duties**

The Park and Recreation Advisory Committee was established by the City Commission to advocate for recreational opportunities in the City of Oregon City and to implement the Oregon City Parks and Recreation Master Plan.

The overall goal of the Advisory Committee is to aid the City of Oregon City in providing ample and diverse recreational opportunities for City residents, through implementation of the Parks and Recreation Master Plan. The Advisory Committee's duties include but are not limited to the following:

- 1. Maintain active communications with the Parks and Recreation Department;
- 2. Provide recommendations to the City Commission relative to parks and recreation;
- 3. Solicit citizen opinions relative to parks and recreation;
- 4. Request information, as needed, from parks and recreation specialists;
- 5. Request information from service organizations and special interest groups;
- 6. Oversee implementation, periodic review and update of the Parks and Recreation Master Plan; and
- 7. Provide public meeting time for citizen input.

## **Composition – Term**

There shall be seven (7) members on the Park and Recreation Advisory Committee. One position is reserved for a representative of the Pioneer Community Center. Members are encouraged to reside within the City limits of Oregon City. A maximum of two members may reside outside the City limits of Oregon City. Each member shall demonstrate expertise, experience, or a positive interest in an area of parks or recreation; the members shall represent a broad range of interests and experience necessary to achieve the goals and objectives of the Advisory Committee.

Appointment to the Advisory Committee will be made by the Mayor. The terms for the Advisory Committee members will be three (3) years. After two (2) consecutive unexcused absences, the Advisory Committee member will be contacted by the Chairperson to see if the member is still interested.

## Officers - Staff

There will be a Chairperson and a Vice-Chairperson for the Advisory Committee. These positions will be filled by two (2) members. Each position will be for a one (1) year term. The Advisory Committee will select a member for the positions of Chair and Vice-Chair each January with a nomination and voice vote process. The Chairperson is responsible for identification of subcommittees and subsequent member selection.

A Parks and Recreation Department staff member will attend every meeting for the purpose of aiding the Committee through information, initiation of projects, perspective, referrals and other customary staff support services.

## **Meetings**

Regular meetings shall be the Fourth (4<sup>th</sup>) Monday of each month. The meetings shall ordinarily begin at 7:00 PM and end no later than 9:00 PM. Special meetings may be called by the Chairperson, the Parks and Recreation Department staff member or the City Commission. A minimum notice of twenty-four (24) hours must be provided for any special meeting. Voting will be by voice vote. There will be no voting by proxy. Formal agenda items must be submitted to the staff representative ten (10) days prior to the meeting date. After the regular agenda has been completed and until the meeting time is over, citizens may introduce additional items for discussion.



In the event there is a disagreement or objection to the procedures pursued by the Chairperson, "Roberts Rules of Order, Newly Revised," shall constitute the authority.



## Introduction

#### Background

In late January, 2008 Kurt Lango of Lango Hansen Architects contacted me concerning the Jon Storm Park site located adjacent to Clackamette Park along the eastern bank of the Clackamas River in Oregon City. Clackamas County is in the process of establishing a paved walking path that will wind throughout approximately 54 trees in the area. Concerns have arisen concerning the potential tree risks associated with locating a walking path in this area.

## Assignment

My assignment is as follows:

- Prepare a tree inventory for the trees identified on the site map you have provided. The inventory will include the following: tree species, common name, diameter (at 4.5 feet above the ground to the nearest whole inch), tree height (to the nearest foot), hazard potential, preservation potential, recommendations to preserve or remove and any applicable comments.
- I am also providing recommendations as to preservation or removal status for each tree.

## Limits of the Assignment

I have performed a limited, visual examination of the trees on the site from ground level. A rudimentary site map (see attachment) with tree locations has been provided to me by Lango Hansen Architects. Trees in this project do not have identification tags. I have marked them with yellow flagging and consecutively numbered them beginning at the north end of the project proceeding to the south. It is these numbers that will be referenced in the inventory.

## **Observations**

## **Field Observations**

Jon Storm Park is a recreational area that is managed by Clackamas County. The Park is joined to Clackamette Park at its northern boundary and sits between Clackamette Drive and the Clackamas River. The Park frequently suffers from flooding of the Clackamas River and was greatly impacted by the flood of 1996 when approximately 4 to 5 feet of river sedimentation was deposited throughout the Park.

The Park contains approximately 50 Black poplar (*Populus.trichocarpa*) and 2 bigleaf maple (*Acer macrophyllum*) trees ranging in diameter from 5 to 59 inches and from 24 to 114 feet in height and one group of 22 smaller Black poplar trees

A number of the trees in this inventory exhibit signs (visible indication of a condition) or symptoms (behavior of a tree in reaction to external influences) that have been used to help determine tree health.



Examination of individual trees revealed the absence of normal root flares (swelling of a trees trunk where the root system connects with the trunk). My examination also revealed the presence of surface roots common throughout the Park. Many of the trees are showing signs of decline such as deadwood in the canopy, trunk decay or missing tops. Many of the trees also have trunk sweep (a bowing of the trunk), multiple or forked tops. There are also several trees that are dead or nearly dead.

## Analysis and Testing

Trees in this project were measured as to diameter at breast height (referred to as dbh) to the nearest whole inch with a diameter tape. Tree heights were recorded to the nearest foot with the use of a clinometer.

All trees have been rated as to potential hazard based upon the following set of criteria:

- Probability of failure- whole tree or component part
- The size of the defective part
- The target area (frequency and duration of use)
- Any other risk factors

#### **FAILURE POTENTIAL**

Each tree in this inventory has been inspected and assigned a numeric value representing the failure potential it represents. Failure Potential identifies the component of the tree most likely to fail and rates the likelihood that the structural defect(s) will result in failure.

- 1. Low: defects are minor (e.g. minor twig dieback, small wounds with good wound-wood development) or normal growth.
- 2. Medium: defects are present and obvious (e.g. cavity encompassing 10-25% of trunk circumference, co-dominant stems without included bark, moderate lean) or trees that show signs of stress from construction activities.
- 3. **High**: numerous and/or significant defects present (e.g. cavity encompassing 30-50% of trunk circumference, co-dominant stems with included bark, severe lean, missing tree tops) or trees in severe decline.
- 4. Severe: defects are very significant (e.g. heart rot decay conks present, cavity encompassing more than 50% of trunk circumference, severe lean with soil heaving, missing tree tops) or the tree is dead.



#### SIZE OF DEFECTIVE PART

Size of defective part rates the size of the part most likely to fail. As the size of the defective part increases, so does the potential for site damage. Therefore the size of the failure affects the hazard potential.

- 1. Most likely failure less than 6 inches in diameter.
- 2. Most likely failure from 6-18 inches in diameter.
- 3. Most likely failure from 18-30 inches in diameter.
- 4. Most likely failure greater than 30 inches in diameter.

#### TARGET RATING

Target Rating quantifies the use and occupancy of the area that would be affected by the failure of the defective part.

- 1. Occasional use: (seldom used area or trail).
- 2. Intermittent use: (seasonal use, less than daily use).
- 3. Frequent use: (daily use for several hours, public areas, residences, trails).
- 4. Constant use: (year-round use for a number of hours daily, residences, parking lots, heavily used public areas and buildings).

#### **RISK RATING**

The overall risk assessment is obtained by assigning a value for each of the three components: failure potential, size of part and target rating. Each component is rated on a 1-4 point scale with 4 as the maximum. Risk Rating equals the sum total of the three rating categories ranging between 3 and 12 points. This Risk Rating can them be utilized to evaluate each trees potential for creating site impact were it to fail.

#### **PRESERVATION POTENTIAL**

Preservation Potential can be defined as the individual trees ability to survive construction activities and remain a desirable member of the post-construction site environment. "Factors to be considered when determining a tree's preservation potential include but are not limited to: tree health, structural integrity, expected longevity, species tolerance to site disturbance and level of future maintenance requirements."(Arboriculture: integrated management of landscape trees, shrubs and vines/ Richard W. Harris, James R. Clark, Nelda P. Matheny , 2004). Preservation ratings range from low to medium to high and were assigned to each tree based upon the factors described above and the trees individual hazard rating. Status (either preserve or remove) was determined by considering the hazard rating and preservation potential of each tree as it relates to its position in the project.



## Discussion

Tree Risk Assessment is the foundation of a hazard/tree failure evaluation. "Tree risk assessment is a systematic process that reviews risk factors and ranks them into risk categories. Not all trees are hazardous at any one point in time. Risk assessment examines the whole tree, or part of it, and is only undertaken when there is a target that might be damaged if the tree or tree part were to fail. If there is nothing of value that would be damaged in the event of a failure, there is no target, and therefore no hazard. However, all trees pose some degree of risk all the time". (Tree Risk Assessment in Urban Areas and the Urban/Rural Interface © PNW Chapter ISA, US Release 1.0, pages 1 and 2).

Trees with high Hazard Ratings and low Preservation Potential could be considered to be undesirable for the site. Like-wise trees with low Hazard Ratings and high Preservation Potential could be considered desirable for preservation. There may be instances when the trees location factors heavier in the preservation decision than does its risk. In these instances the potential impacts to the path itself are of greater concern than the health and vigor of the tree.

Accumulation of river sedimentation at depths observed can greatly alter the rooting environment supporting these trees. Suffocation and surface rooting can occur when soil or other materials are deposited atop an established root system. "Although there are reports of mature trees rooting into deep fill and surviving for long periods (Harris, 1992), placing fill over the trunks of trees is ill advised. Not only is exchange of gases disrupted but also many trees are subject to collar rot, which can occur if the trunk remains moist. A new root system develops in the fill, and the old system dies (Duling, 1969). The new root system may be adequate to keep the tree green and healthy, but as the old root system decays, the stability of the tree is jeopardized" (Harris, Clark, Matheny, 2004).

## **Conclusions**

It is highly likely that past river flooding and sedimentation deposits throughout the Park have greatly impacted the health of the trees. It is also likely that root system suffocation has contributed to the decline of several trees in the Park and can be expected to impact tree health in the future.



## Recommendations

Specific tree recommendations can be found in Appendix II Tree Inventory. Below is a brief summation of my recommendations.

- Twenty six trees in the inventory are either in moderate to severe decline, have missing tops, have trunk decay or are dead or nearly dead. Given the condition of these trees, retention is not recommended.
- One tree is recommended for removal based solely upon its close proximity to the proposed path. It is likely that this tree would cause damage to the path in the form of pavement lifting if it were retained.
- Twenty six trees are recommended for retention and should be monitored on an annual basis for signs of decline.

Recommendations were based upon criteria discussed in the Testing and Analysis portion of this report. Tree removal recommendations were made when the Hazard rating, Preservation Potential and tree location indicated a significant hazard to public safety in the Park existed. The decision to remove any trees will be at the discretion of the Park managers. Retention is recommended for those trees that do not appear to represent a significant hazard to public safety at this time.

Care has been taken to obtain all information from reliable sources. All data has been verified insofar as possible; however, the arborist can neither guarantee nor be responsible for the accuracy of information provided by others. The information contained in this report reflects the condition of those items at the time of inspection. There is no warranty guarantee, expressed or implied that problems or deficiencies of the trees in question may not arise in the future.


