## **Regular Meeting**

- 1. Call to order: Chair McAdoo called the meeting to order at 7:00 P.M.
- 2. Approval of minutes January 26, 2009 regular meeting: approved with two typo corrections.
- 3. Citizen comments on issues and items not on the agenda: none.
- 4. General business:

a. Skate Park art project proposal, Paula Lewis: Artists Paula Lewis and "Dizzy" presented the concept of the spray paint art on the wall of the Clackamette Skate Park bowl. Rocky Smith spoke in support of the project. A graphic depiction of the art was presented. They will be seeking either Metro Enhancement grant funds or O.C. 150 Leave a Legacy funding. They would like to do this in conjunction with both the Pioneer Family Festival and the Oregon Sesquicentennial events. PRAC members asked questions about the O.C. High School student involvement. PRAC unanimously passed a motion supporting the project. Staff indicated the artists would need to work through applicable channels for public art (on city property) approvals.

b. Area Agency on Aging Advisory Group report: Marlene Gleason and Lisa Bentley, Clackamas County Area on Aging Advisory Council, reported on a number of issues including advocacy, long-term care, focal point/nutrition, transportation, and Oregon Project Independence. These are important issues with the budget challenges facing the state, and many programs and agencies stand to lose funding. A handout was provided with detailed information. Kathy Wiseman, Pioneer Center Supervisor, reported on some of the programs and services being provided by the Pioneer Center.

c.OC 150 Sesquicentennial celebration – tree planting event update: Ted Schumaker has not spoken with Shawn Dachtler. Larry Potter provided Shawn with a list of trees previously. Some of the areas may need to wait until fall to be planted for optimum survival rates. Ted will call Shawn to follow up. d. PRAC position vacancies update: Two positions remain vacant. Staff will be doing more noticing/advertising of the vacancies to recruit applicants. PRAC members are encouraged to help put the word out.

e. Proposed Eagle Scout project – tennis court backboard at Rivercrest Park: Larry Potter is working with an Eagle Scout to construct and install a tennis court backboard at the Rivercrest Park courts. A preliminary design was presented. PRAC is supportive of the project. Staff will continue to work on the details of the project with the scout.

As you can see, we have received permission from the permitting agencies to dispose the spoils along the west side of Clackamette Park into the Willamette River. We are waiting for permission from the State since they own the "land". So we don't have the official permit yet, but we may be close.

## **Background**

1

A permit application to dredge the entrance channel to Clackamette Cove was submitted to the Corps and DSL. During the Public Notice period, several comments were received by the Corps and DSL concerning potential impacts on adjoining landowners of deposition of 4,000 cubic yards of dredge material on the island in the Clackamas River. Approximately 5,000 cubic yards was proposed to be stockpiled in an upland location for fish enhancement use in future projects. After further consideration and discussions with the NMFS and ODFW, the location for the deposition of dredge material has been changed from the island to the east shoreline of the Willamette River (Figure 1). The proposal is to deposit all 9,000 cubic yards of material along the shoreline of the Willamette River.

## **Project Description**

The following elements for the project are proposed:

- 1. <u>Isolation Berm</u> As previously proposed (Figure 1), approximately 500 cubic yards of isolation berm will be used for the temporary berm to minimize turbidity and sedimentation in the Clackamas River.
- 2. <u>Access Road</u> The proposed access will remain the same.
- 3. <u>Deposition Area for Dredge Material</u> The new proposal is to place the material along the east shoreline of the Willamette River (Figure 1).
  - a. A total of approximately 9,000 cubic yards of material will be place in two locations, approximately 4,500 cubic yards per location. Cross section of the

existing shoreline is shown with the cross section of the proposed finished grade for each location.

- b. The dimensions of each area is: 400 feet long, 425 feet long for a total of 825 feet. Approximate width is 60 feet. Depth varies according to the cross section in Figure 1.
- c. All material will be placed below the ordinary high water as shown on Figure 1.
- d. The material will consist of native Clackamas River bed load, typically sand, gravel, and cobbles with some fines.
- 4. <u>Haul Road</u> The haul road from the dredge area to the deposition area is shown in Figure 1. The haul road is an existing access road to the shoreline of the Willamette River. No vegetation will be removed for the use of the haul road. The haul road is an existing paved road in most areas. Sediment control BMP's will be used along the route to mobilization of sediment. Route will be cleaned during haul and upon completion of haul activity.
- 5. <u>Grading of Material</u> Once the material is deposited by the haul trucks, the material will be spread to the elevation shown in Figure 1.
- 6. <u>BMP's for Deposition Site</u> BMP's for the site include:
  - a. A sediment curtain will be installed along the shoreline of the Willamette River.
  - b. Material will be placed below OHW, and shaped into the zone between OHW and OLW. The shape will approximate the natural shoreline. Material will not be compacted.
  - c. No heavy equipment will be used inwater.
  - d. Work will occur during the allowed inwater work period for ODFW (see schedule, below).
  - e. Equipment refueling will occur 250 feet from either the Clackamas River or Willamette River.

#### **Schedule**

1

The dredging and deposition will occur during the inwater work period. For the Clackamas River, the inwater work period is July 15 to August 31. For the Willamette River, the summer inwater work period is July 1 to October 31.

1. The City of Oregon City requests that, if feasible, the inwater work period for this project be **July 1** to August 31. This will give the contractor two additional weeks for the limited time that work can occur in the Clackamas River.

#### **Impacts of Placement of Material**

No impacts will occur to the upland area where the existing access will occur for hauling material to the site. Deposition of material on the shoreline of the Willamette River should not result in adverse impacts to water quality or fish resources. Material that will be deposited will be of similar size and will be maintained in the Willamette River system. Fish spawning and rearing likely would be non-existent or minimal along the shoreline in this area of the Willamette River.

## Landowners Adjacent to the Site

 The City of Oregon City owns Tax Lot 600 where the dredge disposal is proposed. This includes Clackamette Park, the haul road through the park, and the shoreline area where deposition would occur. ## **Alternative Sites for Disposal**

Alternative sites for disposal include:

- 1. The island in the Clackamas River, near the mouth of Clackamette Cove. This area was rejected because of the potential of hydraulic changes in the river that could adversely impact the north shore of the Clackamas River, thus worsening erosion of this area.
- 2. Stockpiling all dredged material (9,000 cubic yards) for use in fish enhancement projects was considered. This was not a desirable alternative because the material would be removed from the system and used at some future date on unidentified projects.
- 3. Deposition of dredge material in Clackamette Cove was rejected because of the logistics, costs, and environmental impact involved in transporting and depositing material on the north side of the cove. A large barge and various type of equipment would be needed to level the material to form fish enhancement coves and channels.
- 4. Stockpile and sell the dredge material was considered but rejected because this would remove environmentally valuable material from the river system.

#### Metro protects 24 more acres in Oregon City

#### Canemah Bluff land acquisition protects rare Oregon white oak and madrone habitats

Metro's recent purchase of 24 acres in the Canemah Bluff natural area increases to 158 acres the total amount of land purchased by Metro in the area (see map). The new property includes forests, wetlands, a stream and spring, and rocky outcrops. By expanding the overall size of the protected area, this acquisition improves habitat for wildlife.

"We've been working to secure these important natural and cultural resources for more than a decade," said Metro Council President David Bragdon. "This acquisition meets the Metro Council's goal of making strategic additions at Canemah Bluff."

Located on the bluff in Oregon City overlooking the Willamette River, Canemah Bluff offers scenic views to the neighboring city of West Linn and to travelers on the busy I-5 freeway. The natural area is part of the region's network of parks, natural areas and trails and is managed by Metro. Canemah Bluff is valued for its rich diversity of habitats including conifer forests, ash bottomlands, wildflowers and rare oak woodlands.

The southern half of the new Metro acquisition is dominated by big-leaf maple and alder trees. The northern portion, adjacent to the other Metro properties, has a mixed forest of Douglas fir, white fir, Western hemlock, Pacific yew, Oregon white oak, and Pacific madrone along with more maple and alder trees. The presence of a spring, stream and wetland adds complexity and increases the land's habitat value. Additionally, a series of rocky outcrops on the southern portion of the site include crevices and small caves.

"The diversity of habitats on this property – and its location right next to the land Metro has already protected – makes this a significant acquisition," said Metro Councilor Carlotta Collette who represents the Oregon City area. "We will work with the community to incorporate this area into our ongoing land management activities, including our volunteer Park Watch."

Because they are so rare, maintaining and enhancing the oak woodland and madrone trees found in the Canemah Bluff natural area has been a priority for Metro's science team. Forest management, such as tree thinning, has been necessary to prevent the fast-growing Douglas fir and big-leaf maple from outpacing the slower-growing oaks. Removing invasive plants such as scotch broom and blackberry has allowed the prairie's

wildflowers to thrive. Today Canemah Bluff's native prairies – boasting spring blooms of camas, wild onion and many other unique plants and wildflowers – are flourishing.

The Metro Council's voter-approved 2006 Natural Areas Program funds land acquisition and capital improvements that protect water quality and fish and wildlife habitat, enhance trails and wildlife corridors and provide greater connections to nature in neighborhoods throughout the Portland metropolitan area.
