- 1) Call to order: Chair Steve McAdoo called the meeting to order at 7:00 PM.
- 2) Approval of minutes: April 27, 2009 regular meeting minutes approved as written.
- 3) Citizen comments on issues and items not on the agenda: None.
- 4) General business
  - (1) New business
    - (a) Interview PRAC applicants: Three Committee applicants were interviewed -Rachel Gordon, Patricia Andrews, Richard Andrews. PRAC will follow-up and discuss the applicants at the next meeting.
    - (b) Web streaming of meetings and possible regular meeting day change: Scott Archer discussed the possibility of having the PRAC meetings broadcast via our *Granicus* system. The meetings would be available via broadcast both live and archived for playback any time. This would provide better transparency and information to the public about committee and city business. Additionally, this provides a permanent recorded record of the meeting, versus just the written minutes. If PRAC decided to do this the meetings would need to be held in the City Commission Chambers because of the recording system. Since the meetings conflict with another standing meeting in the Chambers, PRAC would need to move its regular meeting to another standing date, such as the third Monday. PRAC would like to discuss this at the next meeting.
  - (1) Old business/follow-up items
    - (a) Carnegie Center utilization decision process timeline: Scott Archer presented a proposed decision process timeline, which was also discussed with the City Commission at a work session recently. PRAC will be kept apprised on the status of this project.
    - (b) McLoughlin Promenade project update: Project planning continues to proceed.

- (c) Cove dredging project update: The City is still awaiting final permits. We are prepared to do the project upon receipt of required permits.
- (d) Skate Park art project proposal update: The project was not done as part of the Pioneer Days celebration as hoped. Staff will try to receive an update from the artist Paula Lewis.
- (e) OC 150 Sesquicentennial celebration tree planting event update: Still awaiting further coordination of the event. Scott Archer told Mayor Norris that Shawn Dachtler would be unable to chair the event. Mayor Norris indicated she was going to try to find another person or group to take this project on. Steve McAdoo will contact the Mayor to follow up.
- (f) RV Park improvements update: The RV Park renovation concept plan was presented to the City Commission at a recent work session. The Commission was receptive to the plan, and asked staff to further develop the concept and develop a financing plan for further consideration.
- (g) PRAC position vacancies consider applicants: Next meeting.
- 5) PRAC member reports
  - (a) Ted Schumaker checked out Jon Storm Park recently.
  - (b) Bryan Watt:
    - (i) Would like to start thinking about the connections with the R.V. Park, Cove, other pathways. There is lot of potential with these.
    - (ii) Pool starting blocks Metro Enhancement grant did not receive funding. Will continue to pursue how to get this done.
- 6) Director/staff reports
  - (a) Sportcraft boat ramp: Still working on permits. Oregon State Marine Board grant application status pending.
  - (b) Recreation Services update
    - (i) Swimming pool roof & HVAC unit replacements moving forward.
    - (ii) Sprayparks (Carnegie and Rivercrest) planning to open soon after Memorial weekend.
    - (iii) Pioneer Center improvements still waiting for remainder of furnishings to complete; should be in by end of June.
    - (iv) Long-time Pioneer Center program coordinator Julie Miguel has retired. We are recruiting to fill this important position at the Center.
    - (v) 4<sup>th</sup> of July celebration and fireworks for 2010 were not funded in Metro Enhancement grant process recently.
    - (vi) Summer Trail news is out.
  - (c) Parks maintenance update
    - (i) Annual Mt. View Cemetery Memorial Day event begins at 10:00 A.M.
