3. CEREMONIES AND PROCLAMATIONS

3a. Arbor Month Proclamation

Commissioner Mitchell read the proclamation declaring April 2023 as Arbor Month.

3b. Hiroshima Peace Tree Proclamation

Commissioner Marl read the proclamation declaring April 29, 2023 as Hiroshima Peace Tree Planting Day.

3c. Sexual Assault Awareness Month Proclamation

Mayor McGriff read the proclamation declaring April 2023 as Sexual Assault Awareness Month.

Erin Henkelman, Director of Safe Place Family Justice Center, gave a history on Sexual Assault Awareness Month and statistics on assaults per year. She explained the services provided by the center.

Lex Crawford, Training and Outreach Coordinator of Clackamas Women's Services, discussed the services offered by Clackamas Women's Services and encouraged everyone to support this work.

3d. Arab American Heritage Month Proclamation

Commissioner Smith read the proclamation declaring April 2023 as Arab American Heritage Month.

Mayor McGriff thanked Police Sergeant Matt Paschall for his 25 years of service to the city.

4. CITIZEN COMMENTS

Betty Mumm, resident of Oregon City, spoke about youth sports and how increased costs would go to the parents. With obesity, children needed to be active, and she asked that they be easy on the price.

There was consensus not to hold a separate Work Session but incorporate the information into the budget hearing process.

9. GENERAL BUSINESS

9a. OLCC Liquor License Application – Limited On-Premises, Big Chill, LLC, 875 Molalla Ave., Oregon City

Tony Konkol, City Manager, said this item was continued from the last meeting for the applicant to answer questions about the application.

Hardeep Singh Dhounchak of Wilsonville and Mary Monterrosas of Beavercreek said the application was filled out incorrectly. To clarify, they planned to sell sealed alcoholic containers that would be consumed off premises. They were open to discussing the application with the neighborhood association. They would like to put in a food truck in the parking lot and wanted clarification on what was allowed in the Mixed-Use Corridor (MUC) zone.

There was discussion regarding the concerns of the neighborhood in having another business selling alcohol when there were already two others nearby.

Motion made by Commissioner Smith, Seconded by Commissioner Marl, to approve the OLCC Liquor License Application – Limited Off-Premises, Big Chill, LLC, 875 Molalla Ave., Oregon City. The motion carried by the following vote:

9b. City Commission 2023 – 2025 Goals Discussion

Mr. Konkol asked if the minutes reflected the goals and themes the Commission discussed at their retreat.

There was discussion regarding creating a balance between having broad goals and having projects in the budget that were supported by the Commission, timing of the budget process, prioritizing the funds, coming back with more frequency to discuss implementing the goals, and that the minutes reflected what was discussed. This would be an iterative process and driven by both the retreat and budget process.

9c. Street Tree Minor Code Amendments

Pete Walter, Planning Manager, gave a presentation on the code amendments. He discussed the proposed revisions, NRC direction on pollinator gardens, fee in lieu of planting, exceptions, certified arborist definition, decision maker clarification, fee in lieu as last resort, and other clarifications.

There was consensus to adopt the proposed replanting exemption for planter strips three feet wide or less, to adopt the proposed Certified Arborist, Decision-maker, Fee-in-Lieu as Last Resort, and other clarifications, and to remove the covenant option for planting new or designating existing trees in private yards near rights-of-way. There was discussion regarding pollinator gardens, the process for the covenant option and lack of enforcement, changing the amount for fee-in-lieu of replanting, incentivizing planting trees, and discouraging clear cutting. There was consensus to change the fee-in-lieu to \$500 and to clarify that for planter strips three feet wide or less a fee-in-lieu was not required.

These changes would be brought back in an ordinance.

9d. Second Reading of Ordinance No. 23-1003, Revising the City Code to Allow Additional Members to be Appointed to the Youth Advisory Committee (YAC)

Motion made by Commissioner Marl, Seconded by Commissioner Smith, to approve the second reading and final adoption of Ordinance No. 23-1003, revising the City Code to allow additional members to be appointed to the Youth Advisory Committee (YAC). The motion carried by the following vote:

9e. Purchase of New Library Circulation Desk

Greg Williams, Library Director, explained the need for a new circulation desk and how ARPA funds would be used to purchase it.

Motion made by Commissioner Smith, Seconded by Mayor McGriff, to approve the purchase of a new library circulation desk. The motion carried by the following vote:
